#### ABIA-STATE AGENCY FOR COMMUNITY AND SOCIAL DEVELOPMENT PROJECT ABIA-CSDP

#### **KEY PROJECT RESULTS**

Approval and funding of 123 Community Development Plans leading to the completion of 204 micro projects across 7 major sector in 11 Local government Areas of the State. This resulted to the following key results

#### Access to Social And Environmental Service Infrastructure Education

School enrolment in 15 intervened communities increased by an average of 25% as a result of the construction of new classroom blocks which provided conducive teaching and learning environment.

#### Health

The number of persons (male/female) attending health facilities in the 19 intervened communities increased by an average of 500 persons per community due to a reduction of about 2.10km in distances to the facilities across the communities

#### Electricity.

Average of 615 households per community connected to the national grid in the 64 assisted communities and 600 new electricity powered small scale businesses established across the benefiting communities.

#### Water

Distance to Potable water points reduced to an average of .5km for every household in 20 intervened communities resulting to 26% more community members having access to potable water and 57% reduction in cost of water.

#### 2. LGA/Sectoral Ministries Capacity and Partnership

✓ 476 Local Government Review Committee members, 17 Local Government and 5 line ministries Desk Officers trained on CDD process

#### 3. Community-LGA partnership on Human Development and CDD projects

- ➤ 2,500 community members trained on CDD and community Project management leading to more communities now embarking on their projects using the CDD approach even without CSDP assistance
- ≥ 232 communities currently receiving technical/financial support from relevant MDAs and their LGs.

## ABIA-STATE FADAMA III DEVELOPMENT PROJECT (ADDITIONAL FINANCING) ABIA STATE FADAMA III (AF)

#### **KEY PROJECT RESULTS**

- 1. 40 Fadama Clusters and 158 Groups formed across the 3 Senatorial Zones and LGAs.
- 2. Sensitized farmers on scaling up of Rice and Cassava Production across the 3 senatorial zones.
- 3. Mainstreamed 60 youths and women into cassava and rice processing.
- 4. Installed 2 Integrated Rice Processing Mills.
- 5. Flagged off the production of Abia Destoned Rice in collaboration with Abia State Ministry of Agriculture.
- 6. 78.9% of Abia Fadama farmers increased their average income by at least 41.4% (source: Endline survey report 2016).

### KEY CHALLENGES IMPACTING ON IMPLEMENTATION

- Outstanding State Counter part funds.
- High rate of inflation.
- Inability of poor farmers to meet with their matching grant
- Poor Feeder Road Access to some farm locations.

### ABIA STATE EROSION AND WATERSHED MANAGEMENT PROJECT ABIA NEWMAP

#### **KEY PROJECT RESULTS**

#### 1. CIVIL WORKS

- a. Umuezeukwu (100% remediation of gully erosion)
  - 5 families dislocated by gully erosion have returned to their Native compounds
  - Abandoned uncompleted buildings are been completed, farming activities along the corridor have resumed, Communication between Umuezeukwu and Mbawsi has been enhanced and more children now attend school across the gully area
- b. Amuzukwu Ibeku (68% remediation of gully erosion)
  - Farming activities have resumed along this corridor
  - People are returning to deserted shops to restart businesses and
  - ✓ New buildings are springing up in the neighbor hood
  - c. Amuda Achara Isuochi (23% remediation of gully erosion)
    - Farming activities have resumed along this corridor
    - Communication between Amuda and Achara communities has been restored.
    - Travel time between the two communities has reduced by 77.7% (from 45mins-10mins)School enrolment and attendance has also improved

- Payment of compensations for involuntary resettlement of 78 persons
  Disbursement of grant on livelihoods enhancement to 792 persons in 82 community interest groups
- 3. CONSULTANCIES
  - Preparation of approved designs for
    - a. Gully erosion intervention works at Umuogele Umuakwu, Umuagu/Umuda Isingwu
    - b. Additional works at Umuezeukwu Nsulu and Amuzukwu Ibeku
    - c. Emergency response to flood at Ndiegoro, Umuagbai, Uratta and Ifeobara in Aba
  - On-going engagement of consultants for Aba Urban storm water management master plan /GIS mapping of Abia state (On going process)
