

Proportion of LGAs where daily IPDs review mtg chaired by high-level LGA official	2/6 LGAs = 41%


Issues for Hon Minister's Consideration

- ✓ FCT remains at risk for re-emergence of polio due to routine immunization less than 80% and sub-optimal IPD performance particularly in Bwari Area Council
- ✓ Hon Minister could consider maintaining regular meetings of FCT Task Force, quarterly meetings with all Area Councils as well as Traditional leaders to identify and address barriers to higher coverage

Polio Updates

The Presidential Task Force on Polio inaugurated by Mr. President on 1st of February, 2012 has in the last 2 months engaged in a number of activities

1. Meetings with Northern Governors Forum, Northern Traditional Leaders Forum and Religious Leaders
2. High level advocacy visits to 5 of the 8 states with confirmed polio in 2012
3. Advocacy visits to LGA chairmen in 70 high risk LGAs
4. Improving micro-plans (new template, GIS support)
5. Improved team selection, training and supervision
6. Pilot of innovations i.e. team restructuring, GIS/GPS, LQAs with mobile telephones
7. Improving quality/reliability of independent monitoring
8. Support States with poorest Routine Immunization performance (RI) to develop plans to accelerate RI performance

FACTS ABOUT POLIO:

- Polio is NOT the only priority disease in Nigeria and globally.
- Polio is the longest & most expensive public health intervention globally.
- Polio will remain top on the global public health agenda even if only 1 country is left with the disease.
- The Immunization Leadership Challenge Grant Award provides an opportunity for other priority health interventions if states eradicate Polio by December 2012.
- Nigeria is at the brink of eradicating the Polio disease but requires an urgent and dogged approach to ensure every child is reached with 2 drops of Polio vaccine
