# Maternal Health: Zulum distributes N800m worth of drugs to 5 general hospitals

B orno State Governor, Babagana Umara Zulum, has flagged off the distribution of free maternal drugs worth over N800m to five (5) general hospitals for maternal healthcare services.

The distribution was conducted at the Borno State Medical Store located behind flour mills in Maiduguri.

The benefitting Hospitals: State Specialist Hospital, Maiduguri, Mohammed Shuwa Memorial Hospital, Umaru Shehu Ultra Modern Hospital, Mariam Abatcha Children Hospital and Molai General Hospital will, in addition to the drugs, each receive N5m grant. The Specialist Hospital which is the biggest will receive an additional N5m.

"Today we are here to launch the distribution of maternal drugs and other items needed in the maternal section of some of our hospitals to the most vulnerable population in the state. This will reduce maternal mortality and will also increase child care in the state", Zulum said.

The governor also distributed surgical and laboratory equipment to enhance healthcare service delivery to citizens of Borno State.

Zulum charged the Hospital Management Board to be more dedicated to their duties.

"I want to appeal to all of you who are working in the health sector to be more patient and more dedicated so that government will come to your aid. We will address the issues of your offices such as call allowances and other welfare", the governor said.

Zulum however warned that his administration would not tolerate workers' ineptitude.

"We have invested hugely in the health sector within the last four years, but unfortunately we couldn't see the light at the end of the tunnel. This time around we shall not condone laxity on the part of staff from top to bottom. We must sanitize the

system, we cannot afford to play with our healthcare system," Zulum warned.

Speaking earlier, the State Commissioner for Health, Professor Baba Mallam Gana, and the Chief Medical Director, Professor Bukar Kullima, separately expressed gratitude to the governor for his commitment and support to the health sector in Borno State.

# Sustainable Policy Options for Mitigating the Effects of the FUEL SUBSIDY Removal

#### Background

he recent removal of fuel subsidy is aimed at reducing the pressure on government's fiscal position. Available data shows that fuel subsidy in 2022 was estimated at over N4.3 trillion . This is equivalent to about 25% of the 2022 total federal budget, denying the government of resources to fund human and physical infrastructure like education, health, nutrition, roads, etc.

While the removal of the subsidy seems to be a step in the right direction in terms of public finance reform, it is likely to have a significant short-term adverse effect on the population, especially low-income households and individuals. To mitigate the negative effects of the fuel subsidy removal on the people, several palliative options have been proposed with some already being implemented at the federal and state levels, including an increase in the minimum wage, reduction in the number of working days, cash transfers, and provision of mass public transport system.

This brief evaluates each of these palliative options, analyses their merits and demerits, and examines their feasibility and practicability.

#### **Issues in Focus**

Huge government spending on fuel subsidy in Nigeria has become a major economic policy issue in the past few years. According to the 2022 Nigerian Economic Summit Group (NESG) Macroeconomic Outlook, about N3.64 trillion was expended on fuel subsidies between 2015 and 2021, increasing from N307 billion to N1.77 trillion in 2021. It was estimated that about N4.3 trillion was spent on fuel subsidy in 2022. The significant increase in the subsidy payment raised questions about the accuracy of daily fuel consumption, corruption in the subsidy regime, and the sustainability of the fiscal impacts of the subsidy regime.

Generally, fuel subsidy displaces priority government expenditure, encourages excessive consumption, undermines climate action, encourages cross-border smuggling, promotes economic inefficiency and benefits the rich relative to the poor. Evidence shows that the fuel subsidy regime in Nigeria benefits the top income groups relative to the poor .

Previous attempts to remove fuel subsidy have been unsuccessful, partly because of the expected negative effects on the citizens. The opposition to the subsidy removal is hinged on the perceived negative effects of fuel subsidy removal on the poor and mistrust in the redistribution of the surplus to come. It is assumed that removal of the subsidy will lead to substantial increase in the retail price of fuel, which will increase the cost of transportation and other commodities. Labour unions, opposition parties, pressure groups, and the citizens often leverage on these expected negative effects to embark on strikes and protests, leading government to backtrack on previous announcements to remove subsidy.

The latest announcement of the removal of fuel subsidy by President Bola Ahmed Tinubu has been opposed by

pressure groups like the Nigeria Labour Congress (NLC) and the Trade Union Congress (TUC) and the government is engaging with all the relevant stakeholders. Nevertheless, the impacts of the fuel subsidy removal are already being felt, as the pump price of fuel increased from the governmentcontrolled price of about N190 per litre to a market price of N617 per litre (as at July 18th, 2023). The price is expected to change in relation to the international crude oil price and the exchange rate.

The current increase in fuel price has resulted in increase in the cost of transportation, which is subsequently translating to increase in the cost of goods and services, as fuel is a major intermediate and final product in the economy. The ex-post impact of the subsidy removal will evolve over time as

the first month of implementation, inflation numbers, as reported by the National Bureau of Statistics (NBS), have adjusted upward to 22.79% (June 2023) from 22.41% in May 2023, reflecting a persistent rise in consumer prices despite a slowdown recorded globally.

As part of efforts to mitigate the negative welfare impacts of the fuel subsidy removal, various palliative options have been proposed, ranging from increase in the minimum wage to investment in mass public transport infrastructure and systems. Each of these policy options hold potentials for mitigating the effect of the fuel subsidy removal, but their impacts and practicability will vary.

One of the main policies proposed to mitigate the negative effects of the fuel subsidy removal is reducing the existing five (5) working days to three (3). This policy has been proposed and is already being implemented in Edo and Kwara states. The focus of this policy is to reduce the amount expended on transportation. However, this may have negative effect on productivity and economic output, if workers have no viable and economically productive activities out of office. In other words, while the reduction in the number of working days may reduce the costs workers incur on transportation, it may ultimately result in low economic productivity, low standard of living, and high unemployment and poverty. Besides, the reduction in the number of working days only benefits a small segment of the society - civil servants. Private businesses and informal enterprises may not be able to afford the high economic costs associated with this measure.

Another policy option that has also been proposed is raising the minimum wage. This is one of the key positions of the Nigerian Labour Congress (NLC).


This policy proposal is premised on matching the expected increase in prices with increase in the minimum wage. While this seems a good idea, analysis conducted on the economic impacts of the latest increment of the minimum wage from N18,000 to N30,000 shows that it has limited welfare effect. Besides, increasing the minimum wage may pose challenges for state governments and the private sector, some of which are still unable to meet up with the current N30,000 minimum wage. Salaries, allowances, and compensation for

government workers cost states about 30% of their total annual expenditure. They do not have enough fiscal headroom to further increase the minimum wage without putting at risk funding for other sectors. Although an increase in minimum wage is important especially in a country with little or no social protection, this may be at the expense of a smaller, cleaner and more streamlined workforce. More so, increasing the minimum wage may lead to a reduction in the demand for labour (increase the unemployment rate). Furthermore, increasing the minimum wage will only directly benefit workers in waged employment vis-à-vis informal sector workers, which often are low-income and are disproportionately affected. This may have positive spillovers on the economy through increased demand.

A third policy proposition to mitigate the adverse economic effects of fuel subsidy removal is cash transfer. This involves the distribution of a one-time or periodic cash to low-income households/individuals. This policy measure is already at an advanced stage, as the Federal Government has secured an \$800 million World Bank facility for fuel subsidy removal palliative. However, the administration of cash transfers in Nigeria has been undermined by corruption, lack of transparency and accountability, as evidenced by the challenges faced in the distribution of cash transfers during and after the COVID-19 pandemic . Furthermore, the institutional framework, in terms of data and manpower, for effectively implementing cash transfers is inadequate.

These policy options have been tested in different countries with varying degrees of success. For instance, direct money transfer to poor households was





adopted in Chile and was adjudged to be more efficient than subsidizing transport fares or fuel prices . In several developed cities such as Paris, London, Mexico City, Madrid, Vienna, etc., special categories of passengers like the elderly, unemployed, military personnel, students, and civil servants travel free or at relatively lower fares than the standard fares . In some cases, subsidies are channelled to transport suppliers in the form of infrastructure subsidies or subsidies to cover operating costs. A typical example is in the UK under the Bus Service Operators Grants (BSOG) where public transport bus operators receive a tax rebate on fuel cost . Similarly, parts of fuel tax revenue are earmarked for public transport improvements and local road network investments in Germany.

#### Key Conclusions

While these measures have been successfully used in several countries, their adoption in Nigeria may be beset by several challenges, including a shrinking public budget, lack of adequate database as a basis for targeting the subsidy, poor public transport This system, lack of a coordinated policy measure is transportation policy, and moribund transportation already at an infrastructure. anced stage, as the Federal Government Given

the inherent difficulties in implementing transport fare subsidy like in some countries, focus is placed on the development of mass transport systems, particularly buses and, train/metros that

improve access of the poor to public transportation. This policy option, although has huge cost outlay and may take time to implement, uses economies of scale to minimise transportation costs, which also has positive effect on trade and economic activities.

Mass public transport presents a unique opportunity for an efficient and effective transportation system in Nigeria because it is relatively cheaper for users, has larger carrying capacity, utilises economies of scale and has lesser environmental footprint per person. Moreover, it will have larger proportional effect on most of the population unlike the other policy options. Experiences from developing countries such as Brazil, Egypt and Uzbekistan have shown that the railways and metro system are successful in enhancing the poor's access to public transport, and over 50% of the users of Brazil's metro system are low-income people.

Finally, the short-term palliative options being explored by the government would only have limited impact on mitigating the adverse economic effects of the fuel subsidy removal on the poor. To promote long-term sustainable development. efforts should be directed towards investment in mass public transport infrastructure development at the federal and state levels. This will require improving budget allocation to public transport infrastructure. Given the limited fiscal headroom of the government, strategic policy to mobilise both private and Multilateral Development Banks financing into the sector may be initiated.

## Trust Building Strategies and Community Engagement As Panacea To Safe School Project

Introduction

he safe school project requires institutional and structural collaboration for success. Success is achievable when there is trust among institutional leadership coordinating the safe school project through organizational capacity building, responsibilities, and project implementation. The synergy between implementing agencies and school/ host communities in ensuring the success of the safe school project cannot be overemphasized. This paper sets out to justify the need for trust in strategic engagement with school and host communities by security agencies and other implementing partners and institutions in achieving the desired success in the safe school project.

#### **Trust Building Strategies among Security Agencies**

Trust is basically achieved on assurance or firm belief. To trust someone is to have an assured reliance on the character, ability, strength or truth of someone or something. The more trust is accorded to someone or something, the greater the unconditional belief or reliance on the person or thing with perceived benefits, risks, uncertainty, credibility, and vulnerability. This makes us to open ourselves to risk by engaging or collaborating with others to achieve a desired goal (1). Trust glues leaders to their followers and provides the capacity for organizational and leadership success on project collaboration by institutions. Collaboration by security agencies in providing a strong foundation of a great workplace is created by organizational credibility, respect and fairness which form the basis of trust among leaders who trust their followers succeed along with them (2). Therefore, it is important to understand that leaders who trust their followers succeed along with them. Trust is therefore an investment on both parties (leaders and followers).

Trust is built on seven principles of boundaries, reliability, accountability, confidentiality, integrity, non-judgement, and generosity (3). There is another dimension to this by David Horsager, the Chief Executive Officer (CEO) of Trust Edge Leadership Institute, United States. Trust to him is achieved on the '8Cs" of trust, Clarity, Compassion, Character, Competency, Commitment, Connection, Contribution and Consistency. These can be simplified as, to be honest in anything you do, honour your commitment to your leaders and work, and admit your fault when you are wrong. A trustworthy person is one who does these. A trustworthy person is one whose ability, understanding, fairness, openness, integrity, and consistency motivate others is maximize their potential for institutional success and progression.

Trust creates a sense of security and confidence when dealing with others. This makes it possible for you to predict someone's action, inactions, and dependability or otherwise for a sustained credibility. A 74% less stressful situation is attributed to a high trust environment (5). A low trust work



environment is stressful to everyone involved. Flexibility to work on your term is possible with a trusted superior or leader. Sustained credibility accords you the reliable template as a trustworthy person. You can earn yourself a practical trust when you are hardworking, reliable, punctual, competent, and responsible for consistency in work done. This means you provide work and job satisfaction to your colleagues and superior. You can also earn yourself emotional trust when you create a meaningful and productive bond with colleagues. This requires emotional intelligence. This creates mutual respects, creativity, thoughtful intelligence contribution to organizational projects and a balance expertise on issues while accommodating the views of others without bias or sentiments. Trust motivates and builds competence and dependence for institutional success.

Security agencies working on the safe school project can leverage on the ten Maggie Wool's (2022) strategies of trust building. Trust requires long-term thinking. In doing this, you should be considerate of others. Honesty is key in building trust. You should be truthful always. You should try as much as you can to always honor your commitments, make promises that are possible and feasible. Own up to the mistakes and wrongdoing. However, try as much as possible to avoid making mistakes in the first place. Miscommunication damages trust. Misinterpretation distorts the communication process. Communicate effectively and fluently without ambiguity. Clarity of concept, written or spoken; effective listening and comprehension of conceptual clarifications strengthen and sustain the communication process.

Vulnerability is not a crime or weakness. You should be sincere about your emotions and feelings. Our humility is built on emotions. Unexpressed emotions are dangerous in a work environment. When you are unhappy, stressed, ill, weak, tired etc. expressing them will sustain communication and understanding. Personal details can only be shared with trusted friends and relatives. You should share responsibility, be helpful and supportive of others. Schools' safety and security require collective efforts. Being helpful means supporting others within

Process openness and transparency will promote and sustain impact and action through participatory efforts of all parties concerned the framework of the project or goal to be achieved. Try to show care for others. Check on others regularly to know how they are doing. Try and be friendly with others as much as you could. Make it easy for people to trust you. Stand up for what is right. Your honesty and truthfulness should propel you to defend your right and the rights of others especially the most vulnerable in your workplace. Show insightfulness and valuable views and opinions on issues. Always try to be transparent with information and work-related issues. Trust is built on transparency, accountability, and honest responsibility.

#### Community Engagement and Safe School Project

Security agencies need participatory community approach to be able to keep the school community safe and secured. Community engagement is the process of working collaboratively with host and school community to addressing issues of safety and security of schools in Nigeria (6). David Mathews (2008), researching for the Co-Intelligence Institute recognized careful planning process as strategic for community engagement. Incorporating inclusive and demographic diversity through participatory approach of host communities is important in the security and safety of the school environment. Security agencies need the collaboration of host communities through shared purpose, openness and understanding to achieve the security and safety of school infrastructure, learners, and teachers. Process openness and transparency will promote and sustain impact and action





through participatory efforts of all parties concerned. Sustained community engagement of security agencies and school/ host communities can ensure participatory culture based on the objectives of the safe school project.

The safe school project is the concerted effort by the federal government to mobilize sustainable fund and political will to provide a protected and safe learning environment for learners, teachers, and non-teaching staff. The objectives are to strengthen security resilience and integrate host communities in the protection of education, enhance the school community's capacity to protect education, create an effective and efficient national school and emergency response infrastructure, enhance the capacity of security agencies to gather intelligence, prevent and respond to attacks on education and provision of assistance to survivors of attacks on education (7). The costed plan intervention strategy kinetic and non-kinetic includes measures, security resilience in host and school communities, policy advocacy, security assessment, monitoring, and data collection. These required trust and strategic engagement between security agencies and host communities.


To ensure synergy between security agencies and host communities, a multilevel approach to providing responsive security coverage for host communities, schools and other learning places was incorporated. The development of a National School Security Rapid Response and Coordination infrastructure, building resilience in school communities, supporting security resilience in host communities, strengthening the competence and capacity of security and law enforcement officers deployed in host communities, and regular engagements and policy advocacy with the Nigerian Public and key government officials on implementation of the national plan can be achieved through community engagement. The Local Government School Security Response Centre is expected to link up with the State Security Response and Coordination Centre and that of the National Security Response and Coordination Centre here in Abuja. Synergy of purpose through trust is key in achieving this chain of security architecture.

#### **Conclusion and Recommendations**

The Safe School Project in Nigeria is expected to build and integrate security resilience host communities in the protection of education. This will be possible through the strengthening of the detection, deterrence, and response capabilities of the security agencies by building and equipping the School Security Rapid Response and Coordination Centre in Abuja and the 36 states of the federation. There is the need to develop a robust and proactive financing Safe School Monitoring and Evaluation System for transparency and accountability by undertaking a nationwide monitoring and evaluation and data collection survey on schools' attacks periodically. However, community engagement and stakeholders' collaboration are pivotal in achieving these as clearly enumerated in the safe school short term action plan for 2023-2026.

Furthermore, to ensure sustainable safety and security of the learning environment and host communities, trust building strategies should be applied to address persistent challenges of insurgency, terrorism, armed bandits, violent cult groups, bullying, illicit drug abuse, child molestation, sexual assault, ritual killings, militancy, etc.

The ABCD of Trust Model: Able - demonstration of competence, expertise, performance results and skills facilitation; Believable - action based on integrity, honesty, values and fairness; Connected - care for others through interest, communication and recognition of people's rights and competence; Dependable -maintenance of reliability, responsiveness, accountability and organizational inclusivity should define strategic engagement between security agencies and host communities through trust, transparency, impactful collaboration and shared purpose for the success of the safe school project in Nigeria.



...Announces Other Interventions in Health, Security and Infrastructure

he Kaduna State Governor, His Excellency Senator Senator Uba Sani has approved the full implementation of the 2014 Consolidated Medical Salary Scale (CONMESS) for the Association of Resident Doctors working under the Kaduna State Ministry of Health.

The Governor made this announcement during a media chat recently as part of activities marking his first 100 days in office. He used the opportunity to address a wide range of issues across different sectors, notably health, security and infrastructural development issues among other concerns.

Following the recommendations of a committee led by the Kaduna State Head of Service, negotiations were held with striking doctors in August 2023 where it was revealed that resident doctors in Kaduna State Ministry of Health receive 75% of the 2014 CONMESS, while their counterparts working at Barau Dikko Teaching Hospital receive 100% of CONMESS.

Consequently, commencing from September 2023, the approved 100% CONMESS will bring Resident Doctors in the Ministry of Health at parity with their counterparts at Barau Dikko Teaching Hospital. This step, the Governor added, will further boost productivity and attract more doctors to the state.

Similarly, the Governor announced during the live media chat broadcast across major radio stations in Kaduna, that approval had been granted for the continuation of the recruitment of 89 medical doctors to address the staffing gap identified in 2017, as recommended by the committee.

"This initiative amongst others was designed to enhance doctors' morale and improve access to quality healthcare for Kaduna residents. You will recall that we recently flagged-off the distribution of advanced medical equipment to our upgraded primary health care centres. This reflects our administration's commitment to ensuring that every citizen/resident has access to a primary healthcare center within a kilometer of their residence," the Governor added. During the media chat, Governor Sani also

During the media chat, Governor Sani also responded to questions from Kaduna residents, submitted via phone calls. He underscored the positive results of his interactions with development partners, noting that the increase in investors attracted to Kaduna was due to the business-friendly environment created by his administration.

Addressing the issue of uncompleted projects inherited from the immediate past administration, Governor Sani reassured the people of Kaduna State that all projects will be completed, adding that this time around there will be a renewed focus on transforming the rural areas in the coming months.

Speaking on security, Governor Sani expressed his appreciation to the security agencies in Kaduna State for their support in training old and newly-recruited 7000 men and women of the Kaduna State Vigilance Service. He also stressed the urgency of effective policing and recognized the necessity for State Police Force to complement the efforts of national security agencies.

overnor Babagana Umara Zulum has given final approval for immediate recruitment of four thousand (4,000) new teachers already evaluated and shortlisted for deployment to public primary and secondary schools across Borno State.

of science, laboratory technology employed as lab attendants while there are 23 Matrons and 68 cooks to serve students. All the 4,000 shortlisted teachers were meticulously selected after they proved competent teach in primary secondary and schools.

"A total of 19,305 persons applied the t for teachers' recruitment out of which 10,470 the wrote assessment examinations on various subjects taught in

primary and secondary schools. "621 applicants scored distinctions (A's) in various subjects after they were scored while 162 scored merit (B's) in various subjects. "All those who scored distinctions and

merit were shortlisted for recruitment while some of the best amongst those with less scores were shortlisted to teach subjects like French, Literature etc in which they were found competent to teach," Gov Źulum said.

It would be recalled that in February 2021, a committee set up by Governor Zulum to conduct Basic Literacy and Numeracy Competency Assessment of primary school teachers across Borno's 27 Local Government Areas had found that of 17,229 teachers who were assessed, only 5,439 representing 31.6% were found to be competent enough to teach, while 3,815 constituting 22.1% were found to be incompetent to teach and untrainable.

The committee found 7,975 constituting 46.3% to be trainable.

The committee also found that Borno had 1,627 teachers with degrees, 8,153 NCE holders, 2,066 diploma holders, 713 teachers grade II holders, 2,281 SSCE/ GCE holders while 2,389 constituting 13.9% of all the teachers were without any formal qualification.

Governor Zulum directed that competent teachers be paid minimum wage while incompetent teachers be moved to non-teaching government establishments.

He directed a committee to invite and shortlist competent teachers through rigorous assessment examination, from which 4,000 teachers have now emerged.

Meanwhile, names of all shortlisted 4,000 teachers have been released by the committee on teachers recruitment.

The list is to be pasted as notices on public spaces at the Musa Usman secretariat, at the state's Ministry of Education, the Teaching Service Board (TSB) and the State Universal Basic Education Board (SUBEB) all in Maiduguri.

Shortlisted candidates are to cross check their data to ensure accuracy.

The governors later went into a closed-door meeting to deliberate, after which they are expected to issue a communique by the evening of Saturday.

The Governor's Wife made the call during a Town hall meeting to sensitise stakeholders and community leaders of Etinan Federal Constituency on the menace of drug abuse, held at the Council Hall of Nsit Ubium Local Government Area.

Decrying the negative aftermath of addiction to drugs, the First Lady who is the Chairperson, Akwa Ibom State Drug Control Committee (AKSDCC), said that drug abuse is capable of robbing one of their health and sanity, as well as the cause of death of victims in extreme cases.

"Drug abuse is not a singular problem, it is a multifaceted crisis that affects every aspect of our families and our society at large. As leaders and stakeholders, it is our duty to address this pressing issue and work towards a solution that will bring positive change.

"Furthermore, drug abuse has a ripple effect on families, tearing at the fabric of our society. The emotional anguish experienced by family members witnessing their loved ones succumb to addiction is immeasurable. Relationships are strained, trust is eroded, and the well-being of children is endangered," she remarked.

Pastor Patience Eno further noted that drug abuse also increases crime rate in the society as victims "resort to desperate measures to obtain drugs or to finance their addiction."

She urged traditional and community leaders in the different Local Government Areas as well as parents to be vigilant and to report all cases of drug abuse to National Drug Law Enforcement Agency (NDLEA).

In a tone setting, the Secretary of the State Drug Control Committee, Mrs Esther Ukpe giving a brief background of the Committee, said it was inaugurated by the previous administration in February 2023 and was chaired by the former Wife of the Governor who handed over the leadership to the incumbent Wife of Governor, Pastor Patience Umo Eno to lead in the fight against substance abuse.

She described Pastor Eno as a leader with compassion who is determined and committed to furthering the course of the Committee, stating that drug abuse is an issue that plagues communities, breaks families apart, and hinders the progress and well-being of individuals who fall victim to its grip.

Mrs. Bassey encouraged the victim to avail themselves of help mechanism put in place as well as the rehabilitation and reintegration schemes to have them live normal life in the society.

# Uba Sani: Beyond the first 100 days



n 1985, Mario Mathew Cuomo, three term governor of New York, uttered a famous quip which remains a maxim not just in the United States but elsewhere. The governor, in moments of candour, said that politicians campaign in poetry but govern in prose. Largely, this dictum rings true since he verbalized it about 38 years ago.

Indeed, campaign rallies are feisty, boisterous and carnival-like affairs, where sound bites and promises rouse the crowd, amidst praises and fanfare. Politicians, in those moments, promise heaven on earth, pledge a land of milk and honey, using saccharine-coated

language. However, on assuming office, reality usually sets in as they stare at balance sheets, defaced with red ink, suggesting near empty treasuries. Thereafter, the scales fall from their eyes and some walk back their promises, while others impose some contexts.

Sadly, many politicians have eaten their word after victory but luckily, Senator Uba Sani, the Kaduna State governor, has so far kept his own. Last week, he

The goal, according to him, is to bring healthcare nearer home as no individual, throughout Kaduna state, would travel one kilometre to access a health facility commissioned a slew of projects, flagged off others and showcased his scorecard generally, ahead of his 100 days in office. Indeed, for Governor Uba Sani, keeping promises is not a mere flash in the pan and at this point, a brief flashback is necessary.

Kudan, as a local government, boasts of businessmen, retired civil servants and senior government officials as well as two gubernatorial candidates, including Isa Ashiru and Suleiman Hunkuyi, PDP and NNPP flagbearers respectively. However, the area council lacked a modern computer centre, where students can sit for JAMB examinations. Usually, they travelled to Zaria, about 27 kilometres

away, for their Computer Based Tests and the cost, stress and inconvenience took a toll on parents. Somehow, they cried out to Uba Sani and the APC candidate, as he then was, came to their rescue. Right now, a befitting edifice, well furnished and equipped, stands at Hunkuyi, the headquarters of Kudan local government area.

Significantly, the Computer Based Test Centre, as events unfolded, was like a prologue to the main act **THE EXECUTIVE SUMMARY** A Nigeria Governors' Forum Monthly Publication





in the education sector. The governor, on August 21, had reduced school fees in state-owned tertiary institutions. The review, according to him, is in response to public outcry across the state. Truly, students, parents and focal groups, had complained of exorbitant school fees during the last gubernatorial campaign. Point blank, the APC candidate, as Senator Uba Sani was, had promised a downward review. Expectedly, on assuming office, he set machinery in motion and 84 days later, the governor fulfilled this election promise. In fact, students of Kaduna State University(KASU), Nuhu Bamalli Polytechnic and College of Education, Gidan Waya, including those of Shehu Idris College of Health Science and Technology, Makarfi , went wild with jubilation after the announcement.

Accordingly, KASU's school fees has been slashed, in the downward review, from N150,000 to N105,000 per semester. Similarly, the fees of Nuhu Bamalli Polytechnic, a Zaria based institution, has been reduced from N100,000 to N50,000. In addition, College of Education, Gidan Waya, now charges N37,500 instead of N75,000 per semester. Likewise, students of Shehu Idris College of Health Sciences, across all courses, will enjoy new fees regime. Indeed, charges for Higher National Diploma courses, the governor revealed, have been reduced from N100,000 to N70,000, while National Diploma students will now pay N52, 000 instead of N75,000.

Similarly, four days after the fees review, the education sector got another boost, when the Kaduna State Scholarship and Loans Board, on August 25, released N205 million to various tertiary institutions across the country. The sum, according to the Executive Secretary, represents the tuition fees of students on scholarship. In fact, Bayero University Kano received N25 million, in fulfilment of an MoU, for the students' tuition fees till their graduation. Likewise, Ahmadu Bello University, Zaria, got N27 million while KASU received N88.63 million. Besides, the scholarship board will enter other agreements, the Executive Secretary promised, "with Kaduna Polytechnic, University of Jos, ATBU Bauchi, Kaduna State College of Nursing amongst others."

Figuratively, the health sector has gotten a new lease of life, as from August 30, when 290 Primary Healthcare Centres, across all the 255 wards, got state of the art medical equipment. The governor, without mincing words, emphasized his commitment to quality healthcare, expanding access to them and ensuring continuity. More so, he reiterated that quality healthcare, as defined by his administration, is a fundamental human right and not a luxury.

Indeed, the Nasir El Rufai administration, in eight years, has provided 255 PHCs but Governor Uba Sani has promised to increase the number. In fact, there will be an additional health centre in each ward, all equipped and staffed to standard, in the lifetime of his government. The goal, according to him, is to bring healthcare nearer home as no individual, throughout Kaduna state, would travel one kilometre to access a health facility. Remarkably, the promise has started bearing fruits, especially with the launching of five mobile diagnostic trucks, fitted with modern equipment, for integrated health services in remote areas. Similarly, the governor plans to recruit more doctors, has approved the 2014 Consolidated Medical Salary Scale for doctors and plans more incentives for health workers.

However, beyond the commissioning of projects, ground breaking for mass housing and flagging off of rural roads, as well as recruitment of 7,000 vigilantes to tackle insecurity, holding the town hall meeting with a cross section of Kaduna citizens was the most remarkable event. Above all, Governor Uba Sani's commitment to seek the people's buy-in and input in policy formulation and project implementation was the most significant. If sustained, this will secure his administration's populist and people-centric image – a legacy that will endure beyond the 100 days celebrations.

#### Neutralize terrorists that fail to surrender, North East Governors tell military

Forum has urged the military to neutralise insurgents that fail to surrender in the ongoing mass surrender by terrorists in the sub-region.

The Chairman of the North East Governors' Forum, Gov. Babagana Zulum of Borno, made the call Maiduguri at the 8th meeting of the forum.

Zulum, who lauded the military for the relative peace in the sub-region that facilitated the return of normalcy in many areas, said there was need to smoke the remnants that refused to surrender from their hideout.

"Let me use this auspicious occasion to commend our brave military in the fight against the insurgency which remains unquestionable while their determination to succeed is very glaring.

"No doubt, they have considered and acted upon a wide range of options in the fight against terrorism, thereby recording tremendous progress which has clearly indicated that the end to the insurgency in the sub region is fast approaching.

approaching. "I want to call on the Nigerian military to reach in to the enclaves of the insurgents who are not ready to lay down their arms. We must pursue them to their hideouts in the remote nooks and crannies and neutralise those who refuse to surrender," Zulum said.

The governor, who decried the negative effect of insurgency that affected the socioeconomic activities in the sub-region, said until the terrorists were subdued, efforts to improve things would be slowed down.

The governor also spoke on the

erratic rainfall recorded this year, and last year's flood which devastated food and infrastructure in the sub-region and urged for FG's intervention.

He said on their part, the north east governors had taken measures to repair some of the damage done.

"I urge us to collectively strategise and develop new adaptable farming methods to mitigate the impact of the low rainfall on crop cultivation this farming season.

"Therefore, there is the need for us to focus more on irrigation farming this time around more than ever before.

"I urge the North East Development Commission (NEDC) to focus on the support for irrigation farming in the sub-region in addition to its key mandate of providing critical infrastructure for the sustainable development of the sub-region."

The governor who also spoke on illegal mining, sought for partnership with Federal Ministry of Solid Minerals in curbing the activities of such miners.

He also drew the attention of the forum to the recent amendment to the 1999 Constitution which saw the removal of Power Generation and Railway Transportation from exclusive legislative list to the concurrent list.

He said that the development was important for them to exploit towards the provision of independent power supply and rail transportation in the sub-region.

Vice President Kashim Shettima graced the opening of the meeting and presentation of N15 billion palliatives to the governors by NEDC and commended the governors for their unity in facing challenges in spite of party differences.

He urged them to sustain the tempo.

It says: "Leadership retreats provide a break from the daily grind, allowing you to take a step back and reflect on your own personal growth. Through workshops and interactive activities, retreats offer a safe space to explore your strengths, weaknesses, and areas for improvement. This self-reflection will foster personal growth, develop new skills, refine your leadership style, and gain a fresh perspective on your roles."

Now tell me why anyone will have a problem with Nigerian Governors attending leadership retreat in Rwanda. It is an indisputable fact that Rwanda is recognised by the international <u>community as a model of good</u> governance. Kigali

has become a reference point for good governance. China was able to lift 500 million to 800 million out of poverty. This is a feat by any standard, especially in a country with the largest population in the world. Are these human owls who see more in darkness than light saying that there nothing to learn and gain from China by sharing ideas on their experiences? Leadership is a daily learning experience and this experience gets better through interaction with others who are ahead of others in the areas of the development.

Our obsession to kill every good idea by dismissing its significance without offering better ideas is the most destructive element of cynicism. Whether you are willing to admit it or not, it's impossible to dismiss the record achieved by Rwanda in the area of good governance. Instead of being condemned, our Governors should be encouraged to be part of the every effort aimed at improving the standard of good governance. Nigeria has record of ethnic strifes and these strifes are reinforced by poverty. With good governance is in place, people won't be fighting one another. People won't care about their ethnic differences if good governance is effectively implemented. Why do some people succeed and others fail in good governance? If leaders don't interact with others to share their own experiences, how can we improve? Condemning every noble effort for its own sake of is unhelpful.

# *Food security* Governor Abba Yusuf launches multiple ISDB/LLF funded interventions for ten thousand Kano farmers

overnor Abba Kabir Yusuf of Kano state, recently launched agricultural interventions consisting agro processing facilities and farm inputs, for 6, 200 smallholder farmers, through agricultural associations, under the Kano State Agro Pastoral Development Project/ Sasakawa Africa Association Crop Value chain intervention.

Funded by the Islamic Development Bank, IsDB, the Lives and Livelihood Funds, LLF, and the government of Kano state, the support, which aims to strengthen agricultural productivity comprises units of Power tillers, Hammer mills, Rice mills Rice hullers, Rice threshers, Maize threshers, Traddle pumps and Multi crop threshers, among other things.

Equally, the governor flagged off the second phase of Kano State Agro Pastoral Development Project's Ram Fattening and Small Ruminants Reproduction schemes, for 2, 357 women and youths.

Small ruminants play a vital role in the food and nutrition security of millions of poor rural dwellers in Kano, Nigeria's most populous state, serving as sources of meat, milk and skin.

Also launched by the governor during the occasion was the distribution of free Aflasafe, a bioprotectant for use on groundnut farms to reduce aflatoxin contamination, to 1, 200 farmers, under the Kano State Agro Pastoral Development Project/ KNARDA Legumes Value chain intervention. Aflatoxins can cause liver cancer and other health challenges in human beings.

Speaking during the well attended ceremony in Kano, Governor Abba Kabir Yusuf said the interventions are in tandem with his government's resolve to improve lives and livelihoods.

"Our target is to achieve food sufficiency and sustained employment generation to our teeming youth through agricultural activities, development of additional cultivable land and increase in livestock production, to make our economy very resilient", Gov. Abba maintained. The governor restated his administration's

resolve to revamp agriculture in view of its importance to the economy, the governor expressed appreciation to the Islamic Development Bank and the Lives and Livelihood Funds for their support towards making life better for citizens of the state.



The Managing Director of KNARDA, Dr. Faruk Kurawa told the governor that target beneficiaries of the interventions are mainly peasants from the 44 local government areas of the state, poiting out the support is a tip of the iceberg, as the state government is committed to improving the wellbeing of the citizenry.

KSADP's State Project Coordinator, Ibrahim Garba Muhammad stressed that since inception, the Kano Agro -Pastoral Development Project invested heavily in sustainable development of livestock and selected crop value chains, pointing out that the objective is to contribute to poverty alleviation and strengthening of food security of low income earners.

# Zulum unveils 70 buses for metro transport, civil servants



orno State Governor, Babagana Umara Zulum has unveil a new fleet of 70 buses for metro transport and to ease the movement of civil servants to their various places of work.

The initiative aims to alleviate the burden of commuting for both government employees and the general public.

The unveiling ceremony was held at the premises of Borno Express terminus along Kano-Maiduguri road.

The new fleet of buses, specially acquired for this purpose comprised of standard-sized buses and larger buses to accommodate a greater number of passengers.

Each vehicle is equipped with modern amenities, including air-conditioning facilities and comfortable seating arrangements to ensure a pleasant commuting experience.

Making his remarks, Governor Zulum noted that this second phase of the intervention in the transport sector is to alleviate suffering due to the removal of fuel subsidy.

The governor further said that 30 out of the total 70 buses will be dedicated to conveying civil servants to their places of work from 7:00 am to 9:00 am pick ups and return 3:00 pm to 5:00 from Mondays to Fridays.

"I want you to ensure that these buses start operations tomorrow morning (Tuesday) unfailingly. You should however be mindful of our situation and ensure that you bring down the cost of transportation. Let us consider it as a social service and not as a revenue generation drive," Zulum said to Borno express management.

The governor commended the management for transforming the face of Maiduguri terminus and improving the welfare of both the serving and retired staff.

"Since he assumed office, the General Manager has been paying entitlements of his staff at due time. This is very commendable," Zulum said.

Meanwhile, Governor Babagana Umara Zulum also unveiled newly constructed structures and remodeled buildings at the terminus.

The structures are to serve accommodation for travelers, and for operations of businesses such as restaurants and offices.

Conducting the Governor round, the General Manager, Mohammed Grema noted that all the construction projects were funded with internal revenue generated by Borno Express company.

#### Gov Sule approves payment of palliative to Nasarawa workers, pensioners

Abdullahi Sule, has approved the immediate payment of N10,000 and N5,000to civil servants and pensioners in the state respectively, as palliative for six months.

The directive also include paying the same amount for workers and pensioners at the local government level.

Governor Sule, who gave the directive after meeting with labour leaders, at the Government House Lafia, said the measure was aimed at cushioning the effect of the removal of fuel subsidy.

He directed the state Accountant General, Head of Civil Service, Commissioner, Ministry for Local Government, Community Development and Chieftaincy Affairs, Director General, Nasarawa State Pension Bureau, as well as the Association of Local Government of Nigeria (ALGON), to liaise together with a view to commencing the payment of the palliative with immediately effect.

The meeting was convened at the instance of the Governor to harmonize views on the worker's palliative following feelers that the unions may have different views on what they want for the palliative.

The governor, took time to explain in detail the idea behind the palliative, especially the N5bn given to each state by the Federal Government.

"The arrangement for the palliative is very simple. The Federal Government will give us N4bn in cash, as well as N1bn in cash in order to cushion the hardship created by the removal of fuel subsidy.

"The one billion is going to be in form of a loan which the state is going to pay back. The N4bn is going to be divided into two, N2.08bn would be borne by the Federal Government, N1.02bn is by the state. It's a grant and loan combined together. Every state has taken N2bn so far," he disclosed.

He further explained that even at that, there are conditions tied to the money given by the Federal Government, on how the money is to be expended.





# flags off palliative distribution in Enugu

overnor of Enugu State, Dr. Peter Mbah, has flagged off the distribution of palliatives in Enugu State, ordering the immediate delivery of 52,000 bags of rice and 52,000 bags of maize to the urban and rural poor in the state.

The palliatives include 200 bags of rice and 200 bags of maize to each of the 260 wards in the state.

Mbah, however, said the palliatives were part of the short-term strategies to fighting poverty, saying the medium and long-term plans of his administration remained to eradicate poverty in the state in line with his manifesto.

He said: "Part of our vision is to eradicate poverty in Enugu State. And we knew that at the time we were saying that, there was a high rate of poverty in the state.

"But, a few days into our administration, we have had to contend with a number of policies initiated by the Federal Government such as the removal of the petrol subsidy, and also the unification of the foreign exchange rates.

"What that meant was that the people we have in our poverty bracket suddenly expanded because their purchasing power declined drastically.

"As a government that is pro-people, we have the quick fix or short-term strategy to reduce the pressure on our people, while still bearing in mind the long-term goal of eradicating poverty, making sure

that we introduce strategic programmes that would in the long run get our people constructively engaged, and make a living from such engagements.

"So, what we have simply come to do here today is to present palliatives to the people of Enugu State, particularly our rural poor, urban poor and our downtrodden.

"We have also put a structure in place to make that happen by decentralising the distribution, involving local council leaderships, the town unions, the religious institutions, among others Let me also say that in the exercise so far, the state governor has played his own role and we hope that the directives he has given will be followed so that these items will get to the most vulnerable population



such that once we leave here, these items will begin to get distributed across the 17 local governments from today."

The governor also announced the procurement of busses to subsidise transportation and enable the people to go about their socio-economic activities with ease, recalling that his administration had earlier set up committees to verify and clear all arrears of pensions and gratuities owed public servants in the state. This he said would ensure that the elderly and most vulnerable were able to live a meaningful life in the midst of the economic hardship.

Also speaking at the event, the Chairman of the Enugu State Chapter of the Association of Local Governments of Nigeria, Hon. Okechukwu Edeh, who is also a member of the state palliatives committee, assured that the items would trickle down to the poor immediately.

"As the ALGON Chairman, I promise you that I will work with my colleagues to make sure that these get to the downtrodden. It is <u>not for everybody;</u>

it is for the poor, and it must get to them based on the expanded social register that has been compiled", he said.

Meanwhile, different sections of the beneficiaries have commended the Enugu State Government for transparency and inclusiveness in the management of the palliatives.

Speaking, the Chairman of the Joint National Association of Persons with Disabilities, Enugu State chapter, Onyebuchi Mbah, said: "I wish to say kudos to the current administration in Enugu State because they deemed it fit to practice inclusiveness, involving the most vulnerable groups, persons with disabilities in this exercise. I want them to continue in that direction.

"Let me also say that in the exercise so far, the state governor has played his own role and we hope that the directives he has given will be followed so that these items will get to the most vulnerable population"

Also speaking, Mrs Chika Nwankwo, Councillor representing Awgu Ward I in Awgu LGA described the palliatives as "sweet news to the poor in the rural areas where I come from".

"The poor, the sick, and many who cannot afford one square meal in a day are eargerly waiting for us to return with the goodies", she stated.

#### Insecurity: Kaduna govt trains 7,000 vigilantes

aduna state government has flagged-off the training of 7,000 additional vigilante members as part of efforts to enhance community policing.

The 7,000 personnel drawn from all the local government areas of the state, are being trained at the Police College, Kaduna.

The state governor, Uba Sani said that the training was a major step towards fulfilling his promise to strengthen the manpower and overall operational capacity of Kaduna Vigilance Service (KADVS).

He said that since its establishment, KADVS had been working with security agencies to degrade criminal elements across the state.

"But we face the challenge of inadequate personnel to successfully wage the battle against bandits and other criminal elements.

"It is for this reason that our administration decided to recruit 7,000 personnel into the Kaduna Vigilance Service," he said.

Sanisaid that those recruited were thoroughly screened by local government chairmen, traditional and religious leaders, key stakeholders and security agencies in their local government areas.

"The screening was very thorough. We have here energetic young men and women of transparent honesty who are committed to securing our local communities," he said.


