The Accountant – General may, when authorized so to do by warrant under the hand of the Commissioner responsible for Finance, transfer from the Consolidated Revenue Fund of Bayelsa State during the year ending on the 31st day of December, 2021 any sums not exceeding in the aggregate the sum of ₦329,029,043,669.00 (Three Hundred and Twenty-nine Billion, Twenty-nine Million, Forty-three Thousand, Six Hundred and Sixty-nine Naira) only being the total amounts set forth opposite the Administrative Codes
