Date of Commencement

ENACTED by the House of Assembly of Benue State of Nigeria as follows;

- This law may be cited as the Recurrent Expenditure LAW, 2023 and shall be deemed to have come into force on 1st January, 2023.
- 2. (1) The Accountant-General may, when authorized by a warrant under the hand of the Governor, issue from the Consolidated Revenue Fund of the State, during the year ending the 31st December, 2023 any sum not exceeding in the aggregate [One Hundred and Six Billion, One Hundred and Ninety-One Million, Eight Hundred and Ninety three Thousand, Eight Hundred and Sixty-Eight Naira Fifty-Eight Kobo] (106,191,893,868.58) only as Recurrent Expenditure.
 - (2). The sum specified above shall be appropriated to the Heads of Expenditure as set out in the SCHEDULE to this law.
 - (3). The sum of specified in sub-section (1) above shall be appropriated for the services set forth in PART-B of the SCHEDULE to this law.

Title and Commencement

- 3. All Allowances Approved in the Estimates, except travelling allowances, shall be paid to the beneficiary through salary on monthly basis.
- 4. No amount set out in the schedule to this Law or part thereof shall be withdrawn from the Consolidated Revenue Fund after the 31st December, 2023.
