AN AGREEMENT made this ----- day of -----2017

BETWEEN

ASSOCIATION OF LOCAL GOVERNMENTS OF NIGERIA (ALGON) (for and on behalf of all the 774 Local Governments and Area Councils of Nigeria and Partners) with its registered office at No. 20 Yedseram Street, Maitama, Abuja FCT (Hereinafter to be referred to as the **"PROMOTER,"** which expression shall where the context so admits, includes its assigns and successors-in-title) on the one part;

AND

AISHA MUHAMMADU BUHARI FOUNDATION (represented by Future Assured, an initiative of the Foundation), duly registered under the Laws of the Federal Republic of Nigeria and having its office at No. 2 Nilakka Lake Close, Off Gurara Street, Maitama, Abuja FCT (Thereafter called the **"FOUNDATION"**) on the other part.

WHEREAS:

1. The Promoter (ALGON representing the Third Tier of Government comprising 774 Local Government Councils in Nigeria) in furtherance of delivering its constitutional role of improving the health conditions of Nigerians at the Primary Healthcare level, has entered into a partnership with the Federal Ministry of Health, which is desirous to warehouse the screening of common cancers in Nigeria, namely breast, cervical and prostate cancer, in primary healthcare facilities at the Local Government Areas (LGAs) in order to achieve early detection and survivorship;
2. The Promoter and its partners have designed and planned, and are willing to implement a **"Nationwide Improved**

HealthCare Delivery For All” Campaign as a means of reversal of the current alarming trends in cancer incidence and mortality, having identified this interventional strategy to be an effective tool of cancer control;

3. The Promoter and its partners are desirous to provide Healthcare equipment and materials (breast, prostate, cervical cancer and HIV screening kits, screening equipment, ultrasound machines, ambulance vehicles etc.) to improve healthcare delivery in the 774 Local Governments;
4. The Promoter and its partners have requested the collaboration and support of the Foundation to facilitate the acceptance of the nomination of the ***First Lady, Her Excellency Hajia Aisha Muhammadu Buhari, as the National Ambassador of the “Nationwide Improved HealthCare Delivery For All” Campaign*** for effective impact;
5. The Foundation has agreed to collaborate with ALGON and its partners to secure the endorsement of **Her Excellency, Hajia Aisha Muhammadu Buhari** and her participation as the National Ambassador for the Nationwide campaign on Improved Healthcare Delivery, which complements the healthcare delivery component of the **Future Assured Programme**; and
6. The Foundation has agreed to deploy its structures and also to liaise with and secure support of the wives of the 36 State Governors in the nationwide campaign designed to actualize the **National Strategic Plan on Common Cancer Control (2016 – 2020)**.

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. The Promoter and its partners shall ensure that funds for the programme be domiciled and maintained in a special account (Project Account) to be determined by the Promoter and the Foundation for the sole purpose of executing the said nationwide healthcare campaign;
2. The purchase and supply of equipment and materials (breast/prostate/cervical cancer and HIV screening kits, screening equipment/ultrasound machines, ambulance vehicles etc.) to improve healthcare delivery in the 774 Local Governments shall be executed in accordance with a procedure that parties have approved, while ensuring that the process must be consistent with best practices of due process and accountability;
3. Parties will be part of implementation arrangement including further project design/planning adjustments, monitoring and evaluation;
4. The Promoter shall authorize the use of its funds to finance the implementation of the programme;
5. The Foundation shall facilitate the approval and release of the fund from relevant agencies for the programme as proposed by the Promoter;
6. Notwithstanding the expenses for the programme that may have been approved and incurred in the implementation of the campaign, the Promoter and its partners shall settle all its preexisting agreements from the funds;
7. In case of any dispute or difference between the parties hereto relating either to the programmes/projects or to any other matter or thing arising under this contract, the dispute or


