

# BRIEF ON MATTERS LEADING TO THE DISSOLUTION OF ADAMAWA STATE PDP EXECUTIVE COMMITTEE BY THE PDP NWC ON 17<sup>TH</sup> OCTOBER, 2012, by GOV. MURTALA H. NYAKO.

Enclosed herewith is the Guidelines issued by the National Secretariat in 2008 on the conduct of LG Elections by PDP controlled States. To the best of my knowledge virtually all such States that have conducted these Elections ever since the issuance of these Guidelines have done so in line with the Guidelines without further reference to the National Secretariat.

The process for the Local Government Councils Elections in Adamawa State commenced on 4<sup>th</sup> August, 2011 when the EXCO of Adamawa State Chapter wrote to the then Ag. National Chairman requesting for 100 and 500 Nomination/Expression Forms for the Chairmanship and Councillorship nominations respectively (photocopy of our letter dated 4/8/11 attached and marked as Appendix 1). The Forms for the nomination were supplied to the State Chapter by the National Secretariat.

Initially, the fee for the Chairmanship Forms was N750,000 each while the Councillorship Forms were each sold for N250,000; female contestants were supplied nomination Forms free of charge to encourage their participation. As the Executive Governor and Leader of the Party in the State, I intervened and directed that the Chairmanship forms be sold for N350,000 each while Councillorship Forms were sold at N100,000 each. Accordingly refunds were effected by the Party through its bankers since all payments for Forms were earlier on paid for through the same method.

On 30<sup>th</sup> September, 2011 the State Chapter was directed by the National Secretariat to remit all the proceeds from the sales of Nomination Forms to the National Secretariat vide a letter signed by the Ag. National Secretary, Dr. Musa Babayo. (letter attached and marked Appendix 2).

The Chapter complied and directed its Bankers on 7<sup>th</sup> October, 2011 to transfer the proceeds N53,307,750 (Fifty Three Million Three Hundred and Seven Thousand Seven Hundred and Fifty Naira only) to the Oceanic Bank Plc Account of PDP National Secretariat (photocopy attached and marked appendix 3)

On 31<sup>st</sup> May, 2012 the National Secretariat wrote a letter drawing the attention of the State Chapter to Section 50(1) of our Party's Constitution that relates to Councils' elections. The State Chapter acknowledged the letter and assured them of compliance vide letter dated 18<sup>th</sup> June, 2012. (Appendix 4 & 5)

Adamawa State Independent Electoral Commission (ADSIEC) finally issued a press release on  $27^{th}$  August, 2012 giving Political Parties in the State the  $8^{th}$  of October, 2012 as the dateline to submit to the Commission names of their Candidates for the Elections vide Appendix 6.

The State Party then summoned an all inclusive stakeholders' meeting on 31<sup>st</sup> August, 2012 where it was unanimously agreed that Party Primaries be conducted on 3<sup>rd</sup> October and 6<sup>th</sup> October, 2012 for Councillorship and Chairmanship Candidates respectively. The State Chapter wrote to the National Secretariat through its newly directed channel of communication, the office of the Zonal Chairman North-East (vide Appendix 7), conveying the decision of Adamawa State Stakeholders vide letter dated 10<sup>th</sup> September, 2012 (Appendix 8).

On 3<sup>rd</sup> October, 2012, namely 5 days before ADSIEC dateline for submission of names of Candidates for the Elections, the Adamawa State Chapter learnt, through a televised Press Briefing over NTA by the National Publicity Secretary, that the NWC had suspended our completed Primaries in Adamawa

State and would handle the conduct of fresh Primaries from its Secretariat. The State Chapter replied promptly same date 3<sup>rd</sup> October, 2012 (Appendix 9), pointing out to the National Secretariat that the primaries had been conducted in accordance with their previous Guidelines. The Chapter was glad to step aside for NWC to now directly deal with ADSIEC and meet the dateline for the submission of list of party's candidates on time.

Fortunately, ADSIEC issued a circular on  $5^{th}$  October, 2012 that extended the dateline for submission of Candidates by one week (to the  $15^{th}$  October, 2012) citing the flood disaster for its action.

Nothing further was heard from the National Secretariat until the  $8^{th}$  October, 2012 when the State Working Committee was invited to appear before the NWC for a meeting on the  $9^{th}$  October, 2012. The only item for discussion at the meeting was that the State Chairman, Alh. Mijinyawa U. Kugama who was duly elected in accordance with Party Constitution should step down.

There was another announcement by ADSIEC followed by a letter and a Press Release to all Political Parties in the State that its dateline remained 1600 hrs 15<sup>th</sup> October, 2012 vide their letter dated 12<sup>th</sup> October, 2012. (Appendix 9 & 10). It was observed that the other political parties had already submitted the names of their candidates.

There was no further correspondence or action by NWC and it was definitely getting too late for the National Secretariat to directly conduct the Party's Aspirants' screening, elections of Delegates, Councilors and LG Council Chairmen and submit the results to the ADSIEC within the 3 days left before the dateline.

might be a genesis for the State's insecurity and unacceptability of our Party by the populace.

For us in the State the Year 2015 is just around the corner! We intend to handsomely deliver to our great Party dividends of our loyalty in that year and as always. The State EXCO that has done magnificently well and behaved most loyally over the years and has committed no wrong should live - It deserves commendation for averting disaster to the Party!

I submit that if this unjust dissolution of State's EXCO is left unchecked, every other State EXCO would soon find itself facing similar unjust treatment with repercussion for us all. Let us collectively save our Party.

Our prayer in Adamawa is that the decision of the NWC to dissolve the State EXCO that is yet to be ratified by NEC, be rescinded in the spirit of justice and fairness.

# WARD CONGRESS FOR THE ELECTION OF 3 DELEGATES & COUNCILLORSHIP CANDIDATES

For the purpose of nominating the Party's candidates for the offices of Local Government Council Chairmen, each of the 8,812 Ward Chapters of the Party shall elect **3 Ward Delegates at least one of whom shall be a woman and Councillorship Candidates** at a Special Ward Congress. The same delegates shall participate in the Special Congresses for the nomination of the Candidates mentioned in this paragraph.

### Mode of Election of 3 Delegates and Councillorship Candidate

- The mode of election of the 3 ad hoc delegates and Councillorship Candidates at the Special Ward Congresses shall be by open ballot. All card-carrying party members whose names appear in the Ward register shall queue up behind aspirants of their choice to:
  - a) elect Councillorship Candidate
  - b) elect 3 delegates
- 2) The mode of election for LG Chairmanship candidate is by open secret ballot.
- 3) Party members wishing to become ward delegates shall present themselves to the Ward Electoral Panel as aspirants.
- There should be no predetermined delegates.
- There should be a level playing field in the election of the Ward Delegates.
- 6) The 3 Ward delegates must be elected, otherwise the Congress will be cancelled.

Any member of the Executive Committee of the Party at any Level wishing to contest the delegate's election must resign his membership of the Executive Committee before participating in the election.

#### Ward Electoral Panel

 The State Executive Committee (State Exco) shall constitute an Electoral Panel for each Ward to be known as the Ward Electoral Panel.

The Ward Electoral Panel shall be composed of three (3) **credible persons** from each Ward. The three Ward Electoral Panel members shall be posted to wards other than their own for the purpose of conducting the **Special Ward Congress**.

#### Results

- The result of the election shall be immediately transferred to the Ward Congress Result Sheet in the order of the scores by all aspirants.
- 2) The Councillorship aspirant with the highest votes will be declared winner.
- The first 3 aspirants with the highest scores shall be returned elected as delegates.
- 4) No result sheet shall be accepted unless authenticated by the Ward Electoral Panel members.

**Local Government Area Special Congress** 

For the purpose of nominating the Party's candidates for office of Local Government Council Chairmen, each of the 774 Local Government Council Chapters of the Party shall elect Local Government Chairmen at a Local Government Area Special Congress.

## Composition of Local Government Area Special Congress:

There shall be a Local Government Area Congress which shall consist of:

a) The Local Government Chairman of the Party and other members of the Local Government Area Executive Committee.

- PDP
- b) All National, Zonal and State Executive Committee members of the Party from the Local Government Area.
- c) The elected Local Government Council Chairman, Deputy Chairman, Supervisors and Councillors, who are members of the Party.
- d) All members of the National and State House of Assembly from the Local Government Area, who are members of the Party.
- e) Members of the Board of Trustees from the Local Government Area.
- f) All members of the Ward Executive Committee from the Local Government Area.
- Three delegates from each Ward of the Local Government Area elected at the Special Ward Congress, at least one of whom shall be a woman and shall cease to function at the conclusion of the Congress for which they were elected.
- h) All other political office holders from the Local Government Area, who are members of the Party, that is:
  - i) The President of the Federal Republic of Nigeria;
  - ii) the Vice President of the Federal Republic of Nigeria;
  - iii) the Ministers, Ambassadors and Chairmen of Federal Boards of Parastatals who are members of the Party;
  - iv) the Secretary to the Government of the Federation;
  - v) the Special Advisers and Special Assistants to the President and Vice President of the Federal Republic of Nigeria.
  - vi) the State Governor and Deputy Governot
  - vii) the State Commissioners;
  - viii) the Special Advisers to the Governor;
  - ix) the Secretary to the State Government.

#### Functions of the Local Government Area Special Congress

- To elect Local Government Council Chairmanship Candidate of the Party. 1)
- 2) To elect the National Delegate to the Special National Convention

#### Meeting of the Local Government Area Special Congress

The Local Government Party Chairman shall summon the Local Government Area Special Congress.

- 1) The quorum of the Local Government Area Special Congress shall be one-third of the delegates to the Congress.
  - 2) Provided that not less than two-thirds of all the Wards in the Local Government Area are represented and a simple majority shall pass a motion of the Local Government Area Special Congress.

#### Local Government Electoral Panel

1) The State Executive Committee (State Exco) shall constitute an Electoral Panel for each LG to be known as the LG Electoral Panel.

The LG Electoral Panel shall be composed of three (3) credible persons from each LG. The three LG Electoral Panel members shall be posted to LGs other than their own for the purpose of conducting the Local Government Area Special Congress.

#### Results

- The results of the election shall be immediately transferred to the LG 1) Congress Result Sheet in the order of the scores by all aspirants.
- 2) The Chairmanship aspirant with the highest votes will be declared winner.
- 3) The first 3 delegates with the highest scores shall be returned elected. provided that at least one of them shall be a woman.
- No result sheets shall be accepted unless authenticated by the LG 4) Electoral Panel members.

# MINISTRY OF COMMERCE AND ENTREPRENEURIAL DEVELOPMENT THE JIMETA MODERN MARKET

#### 1. INTRODUCTION

The contract for the construction of the Jimeta Ultra – Modern Market was awarded by the previous Administration in 2004 to Messrs U.L.O Consultants at an initial cost of N3,593,900,333.55k. Unfortunately, the contractor abandoned this project along the way due to some contractual disagreement with the previous Administration. This multibillion Naira project remained stalled until this Administration assumed office in 2007 and renegotiated with the contractor to resume work at site. The long period of abandonment necessitated the upward review of the contract cost to N4.5 billion and N5 billion respectively.

#### 2. THE ULTRA MODERN MARKET

The Jimeta Modern Market which was officially commissioned by the former President, Chief Olusegun Obasanjo GCFR on 20th March, 2009, has the following facilities

- i) 1,840No Lock up shops
- ii) 1,940N0 Open stalls
- iii) 54No Ware houses
- iv) 90No Toilets

Other facilities at the market include: -

- a) 15No Restaurants;
- b) 1No Administrative block;
- c) 2No Police posts;
- d) 1No Fire station;
- e) 4No Bank Halls
- f) 1No Clinic

- g) 3No Gate houses
- h) 1No Security Control Tower
- i) 3No Boreholes

#### 3. ALLOCATION OF SHOPS/FACILITIES

The shops and other facilities at the market have been reasonably and fairly allocated to all deserving traders and interest groups including the 21 Local Government Areas in the State. The neighbouring States of Taraba and Gombe State Governments have also been allocated 100No shops each.

#### 4. REVENUE PROJECTION

Lock up shops and open stalls have been leased out to beneficiaries at the rates of N1.2m and N0.8m respectively. Other facilities at the market have also been leased /rented out. It is envisaged that the State Government would recoup its investment in the market in the next two years.

#### 5. CONCLUSION

The Jimeta Ultra Modern Market project is the only project undertaken by this Ministry in the last two years. Other projects that are in the pipeline and would take – off before the end of the year 2010 include the Guyuk Cement project and the resuscitation of the Mubi Burnt Bricks Industry.





While commiserating with the victims, their families and triends on the unfortunate incident, the Council called for increased vigilance by all and sundry to checkmate the

culprits and forestatt future occurrence.

It called for thorough investigation into the killings by all the relevant security agencies and government institutions to bring to book the perpetrators and ensure that the rule of law prevails to serve as deterrent to future incidences.

The Council also appealed for restraint from the citizens, especially those whose sensibilities have been offended by the unfortunate incident. promising to expand its efforts to work with inemployed youth and initiate a peace curriculum.

Aged 24, late Ahmed attended Wuro Bokki Primary School, Hong and had his post primary school at the prestigous Bartimawu Collage, Kaduna in 2010 before he gained admission into the Federal Polytechni, Mubi.

He said for this reason every responsible citizen of the land must rise to defend, preserve and protect the good name of the area and its people by being "our brothers' keeper" and watch movement of people with questionable characters for peace and progress to prevail.

Gella, who was speaking against the backdrop of the recent attack on students and the unending security situation in the area, explained that the nam-3pm curfew imposed by the government on Mubi created untold hardships on the people as business activities have

virtually grounded to a balt as people were forced to remain indoors while those running petty businesses now rush at musual hours to avoid security operatives.

Today, it is a commun. leafure to see major streets in Mubi virtually empty with few or no vehicles plying the roads and that you could speed at 200km without any obstruction f the hustle and bustle that was synonymous with Mubi. This is really disheartening he declared.

While sympathrong with students and families of those who lost their loss in the October 11 killing, Hon. Sajo Gella appealed to those fleeing the area for safety to stay; assuring that government—has—already taken measures to forestall the re-accurrence of the agly incident by safeguarding lives and properties of the citizens in the area.

He advised parents to caution their wards against indulging in vices capable of ruining their future.

COMMUNIQUÉ ISSUED BY THE NETWORK OF CIVIL SOCIETY ORGANIZATIONS IN NIGERIA ON THE NOVEMBER, 24<sup>TH</sup> 2012 LOCAL GOVERNMENT ELECTIONS IN ADAMAWA STATE, TODAY 25<sup>th</sup> NOVEMBER, 2012.

#### Preambles:

In view of the fact that the State Independent Electoral Commission are saddled with the responsibility of organizing and conducting elections in their various states, Adamawa State Independent Electoral Commission (ADSIEC) organized Local Government elections in all the 21 Local Govt. Areas of the State on the 24<sup>th</sup> November, 2012 in Adamawa State.

Our organization; Network of Civil Society Organization in Nigeria an umbrella body of over 120 registered Pan-African Civil Society Organizations in Nigeria committed to strengthening democratic values within the African Continent sent Fifteen Heads of member Organizations to ADSIEC for accreditation to observe the Adamawa State Local Government Elections of 24<sup>th</sup> November, 2012 which ADSIEC complied with and accredited them to observe the election.

#### Pre-Election Observation:

The fifteen Heads of our member Organizations accredited by (ADSIEC) to observe the election arrived Yola the Adamawa State Capital on Monday 19<sup>th</sup> November, 2012 to carry out a pre-election observation ahead of the election. This is aimed at determining the level of preparedness of both the State Government, ADSIEC, Political Parties, the electorates and of course all stakeholders towards the Local Government election. In our pre-election observation, we noted the following:

 The election had been postponed four times with resources and energy wasted at each time. Hence the electorates were calling the Government and the electoral body to conduct the election without further postponement.

- We observed that the State Government provided the necessary logistic supports
  to ADSIEC to ensure a transparent violent free and fair Local Government
  election in the State without any form of interference on the operations of the
  electoral body.
- 3. We noted that ADSIEC was resolute, transparent and committed to conducting a credible free and fair Local Government election in the state, hence provided a level playing ground for all the political parties in the state to participate in the election.
- 4. Our team was also pleased to witness the arrival and receipt of election materials by the ADSIEC Chairman in the ADSIEC Headquarters Yola, under the watchful eyes of various party Agents, Security Agents etc before their distribution to the twenty (21) Local Government Areas amidst tight security and in the company of the party agents and our members.
- 5. We gathered that after due consultations and considerations, 24<sup>th</sup> November, 2012 was announced and set aside for the election to be held. This date was unanimously accepted by all political parties in the State, the State Government and all other stakeholders in the state.
- 6. Our observation showed that the Public Holiday pronounced by the State Government 24 hours to the election was actually a right decision as it helped the people especially the civil servants to go back to their various communities and participate in the election.

#### The Election - General Observation:

Our team of fifteen persons divided themselves into three groups of five persons each, i.e. each group of five persons for each of the three Senatorial Districts in the State. We therefore observed the election as thus:

- ➤ The Adamawa State Local Government Elections actually took place as scheduled on the 24<sup>th</sup> November, 2012 in all the 21 Local Government Areas of the State.
- ➤ The Election was relatively calm, peaceful and of course transparent enough without any interference or complain by/from any quarter.

- We observed that for the first time in the history of elections in Nigeria, including Federal Elections, ADSIEC was very careful to make available all the election materials both sensitive and non-sensitive to their polling units including the commonly forgotten ink-pad, EC-8 form etc.
- ➤ That ADSIEC was not only impartial in their conduct of the election but seen to be so.
- ➤ We observed that the turn out voters was relatively low in some Local Areas especially in the rural areas; this was due to inadequate voter sensitization and mobilization for the election.
- ➤ Due to the very difficult terrain of some communities like Mbula in Demsa LGA, Mapeo in Jada LGA, Gorrobi in Mayo-Belwa LGA etc, elections could not commence as scheduled due to late arrival of election materials and personnel.

#### Recommendation:

Following the above observation and to improve on our electoral process, we wish to recommend the following;

- a) The policy of no movement during the elections should be well enforced next time as the team saw majority of the people not complying with the order.
- b) The Government and the Electoral body should engage committed Civil Society groups like ours on an intensive civic voter sensitization, mobilization and education ahead of every election.
- c) The political parties should also engage in civic voter mobilization as a proactive way of campaign rather than singing songs and partying along the streets.
- d) The difficult terrains in the State should be given consideration first in terms of distribution of election materials to ensure quick and timely commencement of the election in such areas.

#### **Commendation:**

 The team wishes to commend the electoral empire of the state for its wonderful preparation in providing all the needed logistics and materials on time which actually encouraged the success of the election. The Security Agents and arrangements is equally worthy of note as all the places visited by our team, there was no case of violence, molestation or any other form of disorder.

3. Most importantly, the people's attitude toward the conduct of the election, our team rated their orderly conduct to be highly satisfactory and excellent, especially their maturity in putting behind them the string of violence. Indeed they demonstrated high degree of hospitality and welcoming attitude to visitors.

4. Finally, we must not fail to appreciate the effort of the State Government for providing all the necessary logistic supports for the conduct of the election.

#### **Conclusion:**

We conclude by saying that The November 24<sup>th</sup> 2012 Adamawa State Local Government Elections actually took place as scheduled under a conducive and peaceful atmosphere. The election was free, fair, transparent and credible.

We therefore adjudge it to have met the internationally accepted standards of election; hence the result should be accepted by all the candidates and political parties as reflecting the wishes and decisions of the electorates.

We urge the winners to see themselves as Servant Leaders only to serve and represent their people effectively while extending true hands of fellowship to other candidates for peaceful co-existence and rapid development of their various localities as we also advice the losers to show the spirit of sportsmanship for there is always another time.
