	PRESENTATION BY THE WORLD BANK COUNTRY

	The World Bank Country Director, Rachid Benmessaoud, briefed the	
Forum on the progress of the implementation of the Bank's po		

partnerships with States, members pledged to strengthen coordination mechanism and consensus on replicating and exchanging reviews across the States, to resolve implementation challenges and achieve project development objectives. The Forum also resolved to hold portfolio reviews with the Bank to streamline project development objectives with the needs of States. This will assist the resolution of challenges affecting the disbursement of funds and implementation targets.

PRESENTATION BY THE CHAIRMAN, NATIONAL HAJJ COMMISSION

The Forum also received a presentation from Abdullahi Mukhtar Muhammad, Executive Chairman of the National Hajj Commission of Nigeria (NAHCON), on the Challenges and Prospects of the Hajj pilgrimage. Members pledged to collaborate with the Commission and the Ministry of Foreign Affairs to ensure that existing agreements of air carriers are renegotiated with the involvement of States as key stakeholders.

The Forum resolved that a committee comprising of the lawyers in its midst would review the Hajj Agreement. The Committee included:

- i. Governor, Bauchi State
- ii. Governor, Sokoto State
- iii. Governor, Ondo State
- iv. Governor, Kaduna State (Chairman)

The Committee was mandated to present its report at the next meeting of the Forum.
