|      | The Chairman welcomed the Governors to the meeting and briefed them on the deliberations at the last meeting held for constitutional amendments.  He informed the Forum that one of the resolutions at the last meeting was to invite the Speaker to make a presentation.  |  |
|      | The Chairman called on the Governor of Bauchi state to brief the Forum on the meeting with the President to discuss budget support, non-remittance to the federation account of revenues collected by some federal government agencies and to make a case for the approval of the payment of the London-Paris club refunds after reconciliation. |  |
|      | The Governor of Bauchi State in his brief informed the Forum that the Chairman had conveyed the appreciation of the Forum to Mr President for all the support given to the states and congratulated him for bringing Nigeria out of recession.   |  |
|      | At the meeting with Mr. President, the NGF Chairman stressed the importance of the bailout fund considering the monolithic nature of the Nigerian economy.   |  |
|      | The President noted the comments of the governors but observed that he could not make any meaningful contributions as he was not armed with the necessary facts. The meeting was thus adjourned pending the return of the Vice President and Honourable Minister of Finance who would update him on the relevant facts.                          |  |

organised for the governors and captains of industries.

At the event, discussions focused on steps taken by the Federal Government to enhance the ease of doing business in Nigeria and the need for the governors' support and buy-in.

The Chairman informed the meeting that it had become necessary to establish the Nigeria Governors' Wives Forum (NGWF), a platform for governors' wives to come together under a common umbrella.

He explained the purpose of the body, which was to enable the governors' wives to speak with one voice and provide a platform for funding projects. The proposal was approved by the Forum and the chairman suggested that a committee of six be constituted to see to the setting up of the machinery for running the NGWF, with the chairman's wife as the chairperson. This Forum would be oversighted by the NGF and the Secretariat would handle the logistics.

## **UPDATE ON POLIO**

The NGF Senior Health Adviser, Dr Ahmad Abdulwahab gave an update on polio. He stated that Nigeria was polio free based on the last exercise conducted in 18 states.

On the upcoming measles campaign, he commended the states that had released the required funds. He stated that only Katsina State had not released funds out of all the states in the North West. In the North-East, Adamawa and Borno States were the only states that had complied. He urged the States to comply before November 26th, 2017.

With regards to the Monkey pox scare, he assured the meeting that as dangerous as it was, it was not fatal. There were reports that Bayelsa and Nassarawa States had recorded cases of Monkey pox.

Finally, he announced that Bill and Melinda Gates had appointed a new Country Director. The Gates Foundation had commenced pilot programmes in Niger and Kaduna States.

In response to the presentation, the Governor of Katsina State informed the meeting that the bailout fund for the measles campaign was now ready.

The Deputy Governor of Nassarawa State reported the challenge of people rejecting immunization and disputed the report that his
