The meeting started at 1.10 pm with opening prayers by the Governors of Katsina and Kaduna States.

CHAIRMAN'S OPENING REMARKS

The Chairman welcomed members and thanked them for their attendance. He reminded them of assignment which they had given to the Body of Attorneys General (AGs) of the States to review Constitution and informed them that the Report of the Body of AGs was now before the Forum for consideration.

CONSTITUTIONAL AMENDMENT - REVIEW OF BODY OF AGS REPORT

The Forum reviewed the Report as presented by the Body of Attorneys General (AGs). Details of eview attached to this minutes.

ARREST OF FORMER GOVERNORS:

Members expressed displeasure at the arrest of some former Governors by the Economic and Finan Crimes Commission (EFCC) over allegations of financial impropriety. The Forum also condemned tigmatization of Governors and called for a proactive information management mechanism to counter pad press.

The Forum resolved to issue a press statement condemning the indiscriminate arrests and also urge President to prevail on EFCC to release those arrested.

JPDATE ON POLIO ERADICATION:

The Chairman briefed members on the recent visit of Mr. Gates to Nigeria in respect of the polio campaide also updated the meeting on the progress being made in the fight against polio. He read out a listolooprone Local Government Areas and urged Governors to keep up the tempo.

SECRETARIAT FINANCIAL UPDATE:

he Chairman called on members still indebted to the Secretariat to pay up as the present finantituation of the Secretariat was bleak.

ADJOURNMENT:

Following a motion for adjournment by the Governor of Ondo State and seconded by the Benue St Bovernor, the meeting adjourned for the next two weeks. As the meeting was still reviewing Constitutional amendments, it was agreed that no statements would be made to the press until all ssues were concluded.

The meeting ended at 4.30pm with closing prayers by the Governors of Katsina and Benue States.
