LAW NO. 12 OF 2022

A Law to appropriate the sum of N458,731,029,167 (Four Hundred and Fifty Eight Billion, Seven Hundred and Thirty One Million, Twenty Nine Thousand, One Hundred and Sixty Seven Naira) only to the services of the Government of Imo State of Nigeria for the year ending on 31st day of December, 2023 and for other related purposes. This excludes the Consolidated Revenue Fund Charge of **N15,735,247,101.95** (Fifteen Billion, Seven Hundred and Thirty-Five Million, Two Hundred and Forty Seven Thousand, One Hundred and One Naira, Ninety-Five Kobo) only, hence a total Budget of **N474,466,276,267.00** (Four Hundred and Seventy Four Billion, Four Hundred and Sixty Six Million, Two Hundred and Seventy Six Thousand, Two Hundred and Sixty Seven Naira) only.

Long Title

BE IT ENACTED by the House of Assembly of Imo State of Nigeria as follows –

Enactment

1. This Law may be cited as the 2023 Imo State of Nigeria Appropriation Law and shall come into force on 1st January, 2023.
2. The Accountant-General may, when authorized to do so by Warrants signed by the Governor of Imo State of Nigeria, pay out of the Consolidated Revenue Fund of Imo State of Nigeria during the year ending 31st December, 2023 the sums specified by the Warrants not exceeding in the aggregate, **N85,168,838,328** (Eighty Five Billion, One Hundred and Sixty Eight Million, Eight Hundred and Thirty Eight Thousand, Three Hundred and Twenty Eight Naira) only.
3. The sums mentioned in Sections 2 and 3 shall be appropriated to the Heads of Expenditure as indicated in the First Schedule to this Law.

The Accountant-General may, when authorized to do so by Warrants signed by the Governor of Imo State of Nigeria, pay out of the Consolidated Revenue Fund of Imo State of Nigeria during the year ending on 31st December, 2021, the sums specified by the Warrants not exceeding in the aggregate **₦49,546,104,000.00** (Forty Nine Billion, Five Hundred and Forty Six Million, One Hundred and four Thousand Naira) only.

The Accountant-General may, when authorized to do so by Warrants signed by the Governor of Imo State of Nigeria, pay out of the Consolidated Revenue Fund of Imo State of Nigeria, during the year ending on 31st of December, 2023 the sums specified by the Warrants not exceeding in the aggregate **₦373,562,190,837.00** (Three Hundred and Seventy Three Billion, Five Hundred and Sixty Two Million, One Hundred and Ninety Thousand, Eight Hundred and Thirty Seven Naira) only.

6. The sums mentioned in Sections 5 & 6 shall be appropriated to the Heads of Expenditure as indicated in the Second Schedule to this Law.
