BE IT ENACTED by the House of Assembly of Kaduna State as follows:

- 1. This Law is cited as the Appropriation Law, 2022.
- 2. This Law shall come into operation on the

The Accountant General of Kaduna State of Nigeria, may on the warrant of the Commissioner of Finance, Kaduna State issue from the Consolidated Revenue Fund of Kaduna State during the year ending the Thirty First day of December, 2022 any sums not exceeding in whole the sum of Two Hundred and Seventy Eight Billion, Five Hundred and Eighty One Million, Eight Hundred and Fifty Eight Thousand, Two Hundred and Forty Five Naira, One Kobo Only (#278,581,858,245.01) as specified in the schedule herein.
- 4. The sum mentioned in Section 3 of this Law shall be appropriated for the purpose of and in the manner expressed in the Schedule.
