Be it enacted by the Kogi State House of Assembly and by
Authority if the same as follow:

Enactment

1. This Law may be cited as the Kogi State Appropriation
Law 2021.

2. The Sum Not Exceeding:

(a) Seventy-Four Billion, Forty-Seven Million, One
Hundred and Sixty Thousand, Four Hundred and
Eighty-Two Naira (₦74,047,160,482) only shall be
Appropriated from the consolidated Revenue Fund of
the Kogi State for the Recurrent Expenditure of the
State Government during the year ending 31st
December, 2021 as set out in the first schedule to the
Law.

First Schedule

(b) Fifty-Six Billion, Four Hundred and Ninety-Eight
Million, Nine Hundred and Seven Thousand, Five
Hundred and Forty-Four Naira (₦56,498,907,544)
only shall be appropriated from the Consolidated
Revenue Fund of Kogi State Government during the
year ending 31st December, 2021 for Capital
Expenditure in the Second Schedule to this Law.
