Kwara State of Nigeria Law No. 1 of 2019

A LAW TO MAKE APPROPRIATION FOR THE YEAR ENDING 31ST DAY OF DECEMBER 2019

(1st January 2019)

Date of Commencement.

The Kwara State House of Assembly enacts:

1. The sum of seventy-one billion, one hundred and forty-five million, two hundred and thirteen thousand, three hundred and fifty-five naira only shall be appropriated from the Consolidated Revenue Fund for Recurrent Expenditure during the year ending 31st day of December 2019 for the services set out in the First Schedule.

Recurrent Expenditure.

2. The sum of seven billion, sixty-two million, seven hundred and seventy-three thousand, one hundred and ninety-five naira only shall be appropriated from the Consolidated Revenue Fund for Public Debt Charges during the year ending 31st day of December 2019 as set out in the Second Schedule.

Public Debt Charges

3. The sum of forty-three billion, six hundred and thirty-eight million, five hundred and thirty-seven thousand, three hundred and sixty-two naira only (referred to as Recurrent Consolidated Revenue Surplus) shall be transferred from the Consolidated Revenue Fund to Capital Development Fund.

N43,638,537,362 Consolidated Revenue Fund to Capital Development Fund.

4. The sum of seventy-nine billion, five hundred and ninety-four million, forty-six thousand and eleven naira only shall be appropriated from the Consolidated Revenue Fund for Capital Expenditure during the year ending 31st day of December 2019 for the services set out in the Third Schedule.

N79,594,046,011 Capital Expenditure.

5. This Law may be cited as the Appropriation Law, 2019.
