Appropriation of N90,112,909,112.86 Capital Expenditure

4. The sum of Ninety Billion, One Hundred and Twelve Million, Nine Hundred and Nine Thousand, One Hundred and Twelve Naira, Eighty-Six Kobo only, shall be appropriated from the Consolidated Revenue Fund during the year ending on the Thirty-First Day of December Two Thousand and Nineteen for the projects as set out in the Fourth Schedule to this Law.

Citation and Commencement

5. This Law may be cited as the year Two Thousand and Nineteen Appropriation Law and shall come into force on the First Day of January, Two Thousand and Nineteen.
