General Statement of purpose

EXPLANATORY NOTE (EN) FOR THE REVISED 2020 BUDGET ASSUMPTION/PROJECTION AND EXPENDITURE

- **EN 1:1** 2020, Although, there is an expected improvement in the price of crude oil from about US \$27 per barrel in the first quarter to US \$33 per barrel in the fourth quarters, the Rivers State government has pegged her assumption at \$20 per barrel in the 2020 Revised Budget in agreement with NGF as against FGN's pegged assumption of \$25 Per barrel. This is necessary to absorb any shock in the international oil market and to effectively weather the possible impacts of Saudi/Russia Oil War and clumsy demand as a result of COVID-19 pandemic.
- **EN 1.2** The downward review of 1.7 mbpd in the Revised 2020 Budget of the oil production in Rivers State was necessary to respond to the current OPEC palliative trade agreement to reduce supply to enhance price in the face of sluggish trade arrangement in the international crude oil market and very minimal economic and industrial activities as a result of the COVID-19 pandemic across the continents.
- EN 1.3 Despite the CBN's recent upward adjustment to N 360/US \$1 at the Importers and Exporters Foreign Exchange (IEFX), the naira exchange rate to the dollar further depreciated from about N362/US \$1 in January 2020 to about N382/US \$1 in the early second quarter. While the CBN is not relenting on its compensatory and palliative measures, it is expected that the naira will suffer more devaluation with the projected loss of about \$26 Billion in oil revenue as a result of low demand of crude oil due to COVID-19 pandemic. Hence, Rivers State benchmarked her exchange rate at N360/US \$1 in the revised 2020 estimates in agreement with the FGN to weather possible external shock
- **EN 1.4** The National GDP was revised from about 2.93% to -4.42% in the National 2020 Budget Estimates as a result of Nigeria's Economy being threatened by twin shocks of both COVID-19 pandemic and the sharp decline in the crude oil price in the international oil market suggesting a more serious recession than that witnessed in 2016/2019. Rivers State in her revised estimates assumed -4.42% adopted by FGN and NGF in the current year.
- **EN. 1.5** Part of the obvious consequences of the Lockdown and restricted economic and commercial activities was a severe pressure on the general price of goods and services, especially food stuff with Rivers State seriously affected. This prompted the IMF projected inflation rate for Nigeria at 13.4% by the end of 2020. However, Rivers State adopted an inflation rate per annual average of 14.13% adopted by FGN.

- **EN 1.6** The Opening Balance of N31,989,343,188.54 billion was an estimated closing balance in 2019. Whereas N9,266,279,131.06 indicated in the 2020 amended budget represents the actual closing balance in 2019 which is now the actual opening balance for 2020 amended budget.
- **EN. 1.7** The Revenue and Capital Receipts in the Rivers State Revised 2020 Budget is put at N266,397,242,711.76 as against N428,824,014,430.46 of the initial estimates representing about 33.21% reduction. This is in appreciation of the current economic realities of possible low revenue resulting from minimal economic activities due to the COVID-19 pandemic.
- **EN 1.8** The Gross Statutory Allocations reduced from N54,037,294,916 of the initial estimates to N28,491,364,062.00in the revised 2020 estimates due mainly to:
 - i. Gross Statutory Allocation reduction resulting from sudden fall in the crude oil price in the international oil market
 - ii. Reduced oil production resulting from the OPEC trade and price palliative agreement
- iii. Reduced demand for crude oil and other export goods due to COVID-19 pandemic.
- iv. The revised estimate is based on the macroeconomic and mineral assumptions provided in EN1.1 EN1.5 above.
- **EN 1.9** The revenue allocation for Derivation decreased from N120,355,800,000 in the original 2020 estimate to N66,089,494,318.35 in the revised 2020 budget and maintained the same for COVID-19 response based on the need to pursue budget realism.

The actual receipt from Derivation up to June 2020 stood at 70% of the total estimate in the revised 2020 budget. It is therefore expected that appropriated estimates in the revised 2020 budget will be achieved using the assumption provided in EN 1.1 - EN 1.3 above.

EN 1.10A Estimates for Other FAAC **Transfers** reduced from State N10,898,236,033.46 in the Rivers initial budget estimates N7,462,994,922.17 in the revised which was mainly due to the reduction in general economic activities including the variables of the FAAC such as Exchange Rate Gain, Forex Equalization and Refund from ESCROW/Paris/Bank Charges.

EN 1.10B - Capital Receipt in the 2020 Revised Budget Estimates of N49,313,973,147.48 which is 62.45% of the sum of N78,953,067,518.29 approved as FGN refund for Rivers State.

EN 1.11 VAT estimates for the initial 2020 budget estimates was given as N21,650,119,130, as against 2019 approved estimates of N26,377,628,543. The revised figure of N14,017,446,058 is provided in the 2020 amended budget. Notwithstanding reduced commercial and economic activities as a result of the COVID-19 pandemic and lockdown it is anticipated that actual VAT receipts for 2019 of N17,629,628,292.93 will be surpassed in 2020 because of the increase in VAT rate from 5% to 7.5%.

EN 1.12 IGR Performance in Rivers State between 2015-2019 Had been commendable. The feat was gained as a result of major reforms in the Internal Revenue Service of the State with deliberate attempt to block all revenue leakages. There was a significant reduction in the IGR estimates of N141,882,504,351, in the initial estimates to N92,986,084,316.65 in the 2020 amended budget.

The reasons are

- i. Lockdown caused by COVID-19 pandemic
- ii. Restricted Commercial and Business activities

EN 1.13 Rivers State is optimistic to leverage on **Internal Grants** of N1,519,884,078.86 UBEC Counterpart Fund arrangement for Educational Endowment to further increase the capacity of Government to address the infrastructural needs of UBE schools as part of the COVID-19 response.

EN 1.14 – **External Grant** was estimated at N6,516,001,080.25 which is made of:

- N521,364,861.00 UNICEF intervention for COVID-19 Emergency Response and Social Protection, Sustained Immunization under the State Primary Health Care, Neglected Tropical Disease, TBA Training and HIV
- N1,933,749,950.00 World Bank BESDA (Advance) and (Prior) Programme.
- N2,260,886,997.25 EU grant under the SEEFOR Programme for CDDS and Public works.
- N1,800,000,000.00 SFTAS AF grant which the State hopes to have access to.

EN 2.1 – The total Expenditures estimates for the year 2020 was reduced from the original estimates of N530.8 billion to N300.3 billion in the revised 2020 budget estimates. The reduction was orchestrated by the effects of COVID-19 on the general revenue profile of the State which made it imperative to prioritize government expenditure in response to the COVID-19 pandemic. Consequently, emphasis on expenditure allocations gave more attention to the MDAs and activities that direct bearing on mitigating the effects of COVID-19 on the well-being of the citizens.

EN 2.2 – The Personnel Cost maintained only a slight reduction from N111,404,477,403.55 in the initial estimates to N93,589,235,422.32 in the 2020 amended response. This was imperative to capture;

- a. Selective employment relevant to COVID-19 response programme
- b. Maintain the Salaries of Civil Servants on Grate Level 1-10 absent from work as a result of the State executive orders to "stay at home" to minimize the interpersonal infection of COVID-19.
- c. To Capture the impact of the reviewed minimum wage implementations.

EN 2.3 – While we maintained the total Overhead appropriations for each of the selected COVID-19 response MDAs, there were redistributions of individual activities appropriation within the MDAs from Non COVID-19 response activities to COVID-19 response activities. This was necessary to increase appropriations to individual activities of COVID-19 response items of the individual MDAs in order to respond to the imperatives of increased expenditures as a result of the COVID-19 Pandemic in the State. But note that, the total amount of N224,166,552.46 of the COVID-19 response is only a part of the N18,429,395,834.45 total overhead cost of the MDAs.

Note: The Overhead activities vary according to the nature and mandate to the MDAs and as appropriated for in the revised 2020 budget. Most of the obvious COVID-19 activities are peculiar to the Ministry of Health and as represented in its 2020 revised appropriation Overhead activities which have also been captured.

However, the choice of other MDAs overhead activities and appropriation was predicated on their relevance to issues associated with the COVID-19 such as publicity and advertisement, local training environmental cleaning and fumigation, court arbitration, prosecution and seating in addition fouling, maintenance of vehicle and procurement of office consumables all to aid

COVID-19 control and administration and hence were selected as COVID-19 responsive activities.

EN 2.4A – Interest payment on debt including FAAC deductions was projected at N12,097,365,25 in the revised budget for 2020 because of anticipated waiver and State Action on debt services by the Federal Government.

EN 2.4B – Consolidated Revenue Fund Charges experienced reduction from N11,800,583,368 which was estimated in the 2020 original Budget to N7,293,050,772 in the Revised 2020 Budget Estimate. The reduction is due to drop in revenue of the State as economic activities have been affected by the COVID-19 Pandemic. Items covered in the CRF estimate include; Anticipated New Recruitments for COVID-19 Responsive activities, Counterpart Fund for Pension Scheme, Death Benefits, Pension Harmonization and Re-imbursement and other charges on General Administration.

EN 2.5 The sum of N168,961,043,904.55 was appropriated for Capital Expenditure in the revised 2020 budget which recorded a reduction from N362,204,165,743.00. The reduction was necessary to focus on on-going Capital projects in the absence of extra funding activities.

• Economic Sector

Captures most of capital projects, such as infrastructure and other capital goods. Expenditures were limited to on-going projects which have direct bearing on the growth on and development of the state and people in order to reduce accumulation and arrears in the absence of extra funding sources. More so, the projects were also intended to regenerate post COVID-19 growth and development.

Social Sector

This consist of mainly the provisions of Social goods and services in addition to economic empowerment. Hence, Capital Expenditure focused on the provision, rehabilitation, renovation, rebuilding and equipping of schools, hospitals for effective teaching and learning and easy access to health services. Expenditures on ICT infrastructures in both schools and health facilities also took major chunk of the expenditure in this regard.

Law and Justice

Visual Court Seating was necessary within the period of COVID-19. Hence, expenditure focused on internet facilities and access for the various court proceedings for Justice Dispensation.

Administrative Sector

Capital Expenditures for this sector emphasised good governance through citizenship participation in governance and the provision of ICT infrastructure for adequate networking of government businesses and activities.

EN 3.1 – Local Credit, amounting to N20 billion was appropriated in the revised 2020 budget. The Rivers State Government has committed itself to undertake very critical infrastructural development to help expand the State's economy before and through the advent of COVID-19 Pandemic. Besides this, Government views any development initiative that will help to address the perennial traffic congestion in the State as very critical and would further help to mitigate the challenges occasioned by the COVID-19 pandemic as the infrastructure development programme would help create additional jobs and take particularly, a lot of the youths off the unemployment market. Accordingly, Rivers State Government has committed its scarce resources and arrangement have been concluded with two (2) Banks (Access Bank and Zenith Bank Plc) to secure about N18 billion to enable her commence the construction of a flyover project and associated road networks to deliver on its promise to the citizens of the State. Another sum of about N2 billion has been secured as loan from commercial banks (Access Bank and Zenith Bank Plc) to enable the State meet the requirement of Counterpart Funding for UBEC, the first tranche would be released in August 2020. Projects covered by this appropriated sum of N20 billion under the Local Credit are considered time bound in line with Government Development Agenda for the Fiscal Year 2020.

EN 3.2 Credit from World Bank was estimated at N4,706,549,340.50. Forty-one percent (41%) of this has already been accessed under the State World bank SEEFOR Project, while the rest are to be accessed in course of project implementation and approvals.

General Explanatory note for the Revised 2020 Budget

Rivers State government in the 2020 Budget review perceived all Construction, Civil Works, rehabilitation, procurement, ICT and Other basic health facilities as COVID-19 response activities.

All ICT programmes and activities are also described as COVID-19 as they are oriented towards ensuring social distancing, and E-governance.

Provision of health care facilitation and services are also tagged COVID-19 responsive in the revised 2020 budget as they are frontline interventions necessary to manage and mitigate the impact of the pandemic.
