**ENACTED** by the Sokoto State House of Assembly as follows:-

Citation & commencement

1. This Law may be cited as the Appropriation Law, 2022 and shall come into operation on the 1<sup>st</sup> day of January, 2022.

Issue and Appropriation of N188,429,495,847.63

2. The Accountant General may when authorized so to do by warrants issued by the Commissioner of Finance, pay out of Consolidated Revenue Fund during the year ending on the 31<sup>st</sup> December, 2022 the sums approved by the warrants not exceeding in the whole the sum of One Hundred and Eighty Eight Billion, Four Hundred and Twenty Nine Million, Four Hundred and Ninety Five Thousand, Eight Hundred and Fourty Seven Naira, Sixty Three Kobo (N188,429,495,847.63) being the total of the amount specified in the Schedule.

Schedule

3. The said sum shall be deemed to have been appropriated for the purpose and in the manner specified in the Schedule to this Law.
