# **State Summaries**

# 1. Abia State

# **Findings**

Abia state scores 18 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- Public access to budget documents: Abia state scores 16 out of 100 on the State Budget Document Availability Index. While most documents are produced in the state, only the Accountant General's Report and Auditor-General's Report are publicly available on request.
- Public participation in the budget process: Citizens and CSOs in Abia state have limited spaces for the public to be involved in the budget process with a score of 14 out of 100. During the budget formulation stage, the Ministry of Youth Development and Ministry of Women & Social Development invite some constituencies with disabilities to provide inputs on the State Draft Estimates. However, the government doesn't clearly articulate how these inputs are used. The budget approval process is closed to the public. Both the budget execution and auditing process have no open spaces for public scrutiny.
- **Public access to procurement information:** With a score of 30 out of 100, citizens have minimal access to procurement information in Abia state. Tenders in Abia state are publicly opened after the bidding process is closed. The procurement decisions with justification of each award are published in the official gazette.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

# **Budget Transparency**

The government can easily improve budget transparency in Abia state by publishing online and in a timely manner the following documents that it already produces:

- Request for submission of Budget Circulars from Ministries, Departments, Agencies and Parastatals
- Abia State Budget along with Abia State Medium Term Expenditure Framework and the Abia State Draft Budget votes

- Abia State Budget Appropriation Law
- Abia State Quarterly Reports
- Abia State Mid-Year Review

In addition to publishing these documents, the Budget Office in the Abia State Planning Commission should partner with CSOs in the state to develop a Citizen's Budget.

# **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the government in Abia state should do the following:

- Open the budget formulation process to all constituencies; establish effective mechanisms to solicit the public's inputs on what should be included in the State Draft Estimates; and clearly articulate what the government expects to do with these inputs.
- Publish a list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs.
- Establish practical mechanisms for the public to provide inputs on how the budget is being implemented and publish reports on how these inputs are used.

Similarly, the Abia State House of Assembly should do the following:

- Open committee hearings on the budget to public where citizens and CSOs can testify.
- Open the hearings on the Auditor-General's Report to the public.

Lastly, the Auditor-General should do the following:

• Establish practical mechanisms for the public to submit inputs on what should be audited.

#### **Procurement Process**

To improve the entire procurement process, the following should be done:

- The government should introduce a law in the SHoA establishing a Tenders Board that would oversee the whole procurement process along with a procurement complaint board that manages an alternative dispute resolution mechanism.
- The official gazette, including procurement awards and justification of awards for all community projects, should be publicly available at no charge.
- Enact State Fiscal Responsibility Law.
- Establish state procurement body.

#### **Access to Information**

To improve access to information in the state, the government should do the following:

- Domesticate the Freedom of Information (FOI) Act, 2011.
- Establish Freedom of Information (FOI) Agency in the state.

# 2. Adamawa State

# **Findings**

Adamawa state scores 39 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- Public access to budget documents: Adamawa state scores 56 out of 100 on the State Budget Document Availability Index. The State Budget Call Circular, State Draft Budget Estimates, and State Budget Appropriation Law are publicly available on request. Citizens have access to all documents in both the budget formulation and approval stages that can serve as a basis to monitor how the government is executing the budget; however, none of the budget execution documents are publicly available. Quarterly Reports are produced for internal use only while the Mid-Year Review, Accountant General's Report, and Auditor-General's Report are not produced at all.
- Public participation in the budget process: Citizens and CSOs in Adamawa state have limited spaces for to be involved in the budget process with a score of 14 out of 100. During the budget formulation stage, the government provides no spaces for the public to provide inputs on the State Draft Estimates. Few committee hearings on the budget are opened to the public, with only some committees publishing reports during the budget approval process. In the auditing process, citizens have no open spaces for public scrutiny.
- Public access to procurement information: With a score of 27 out of 100, citizens have limited access to procurement information in Adamawa state. The Public Procurement Law 2013 regulates the entire procurement process and established the State Tenders Board. Tenders in Adamawa state are publicly opened, with some delay, after the bidding process is closed. Few procurement decisions are available to citizens.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

#### **Budget Transparency**

The government can increase budget transparency in Adamawa state by publishing online and in a timely manner the following documents that are already produced:

• Adamawa State Quarterly Reports

The Permanent Secretary Budget Office of Adamawa state should do the following:

• Partner with CSOs in the state to develop a Citizen's Budget.

• Produce and publish the Mid-Year Review, Accountant General's Report, and Auditor-General's Report.

# **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the government in Adamawa state should do the following:

- Open the budget formulation process to all constituencies; establish effective mechanisms to solicit the public's inputs on what should be included in the State Draft Estimates; and clearly articulate what the government expects to do with these inputs.
- Publish a list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs.
- Establish practical mechanisms for the public to provide inputs on how the budget is being implemented and publish reports on how these inputs are used.

Similarly, the Adamawa State House of Assembly should do the following:

- Open all committee hearings on the budget to the public where citizens and CSOs can testify.
- Open hearings on the Auditor-General's Report to the public.

Lastly, the Auditor-General should do the following:

• Establish practical mechanisms for the public to submit inputs on what should be audited.

#### **Procurement Process**

To improve the entire procurement process, the following should be done:

- The State Tenders Board should establish a procurement complaint board that manages an alternative dispute resolution mechanism.
- The State Tenders Board should publish all procurement decisions along with their justifications for all community projects.

#### **Access to Information**

To improve access to information in the state, the government should do the following:

- Domesticate the Freedom of Information (FOI) Act, 2011.
- Establish Freedom of Information (FOI) Agency in the state.

# 3. Akwa Ibom State

#### **Findings**

Akwa Ibom state scores 22 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- **Public access to budget documents:** Akwa Ibom state scores 7 out of 100 on the State Budget Document Availability Index. While most documents are produced in the state, not a single document is publicly available.
- Public participation in the budget process: Citizens and CSOs in Akwa Ibom state have moderate spaces to be involved in the budget process with a score of 50 out of 100. During the budget formulation stage, the Akwa Ibom government invites citizens through state radio and television to attend town halls to provide inputs on the State Draft Estimates. The budget approval process is open to the public but no committees publish reports. The Akwa Ibom government publishes a list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs. Town hall meetings are also implemented throughout the budget execution process to solicit inputs on how to improve the way the government executes the budget. In the auditing processes, citizens have no open spaces for public scrutiny.
- **Public access to procurement information:** With a score of 30 out of 100, citizens have limited access to procurement information in Akwa Ibom. Tenders in Akwa Ibom state are publicly opened after the bidding process is closed. The procurement decisions with a justification of each award are published in the official gazette.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

#### **Budget Transparency**

The government can easily improve budget transparency in Akwa Ibom state by publishing online and in a timely manner the following documents that are already produced:

- Akwa Ibom State of Nigeria Budget Preparation and Submission of Call Circular
- Akwa Ibom State Chart of Account along with Government of Akwa Ibom State of Nigeria Medium Term Expenditure Framework
- Akwa Ibom State Budget Appropriation Law
- Quarterly Budget Performance Report
- Review of Performance Recurrent/Capital Expenditure
- Report of the Accountant General on the Accounts of Akwa Ibom State
- Report of the Auditor-General on the Accounts of Akwa Ibom State

In addition to publishing these documents, the Akwa Ibom State Budget Office should partner with CSOs in the state to develop a Citizen's Budget.

# **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the government of Akwa Ibom state should do the following:

- Specifically invite vulnerable groups to town hall meetings and clearly articulate what the government intends to do with their inputs for the budget.
- Ensure that the mechanisms for the public to provide inputs on how the budget is being implemented are more accessible, and publish reports on how these inputs are used.

Similarly, the Akwa Ibom State House of Assembly should do the following:

- Facilitate open committee hearings on the specific sectors where citizens and CSOs can testify, and publish committee reports.
- Open the hearings on the Auditor-General's Report to the public.

Lastly, the Auditor-General should do the following:

• Establish practical mechanisms for the public to submit inputs on what should be audited.

#### **Procurement Process**

To improve the entire procurement process, the following should be done:

- The executive should introduce a bill in the SHoA to establish a Due Process body.
- A Tenders Board should be established to guide bidding and awards processes.
- There should be a procurement complaints body to manage all complaints arising from the procurement process in the state.
- Publish justification of awards and all community projects on the notice boards of MDAs.

#### **Access to Information**

To improve access to information in the state, the government should do the following:

- Domesticate the Freedom of Information (FOI) Act, 2011.
- Establish Freedom of Information (FOI) Agency in the state.

# 4. Anambra State

# **Findings**

Anambra state scores 27 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

• Public access to budget documents: Anambra state scores 20 out of 100 on the State Budget Document Availability Index. Only the State Budget Call Circular was published on the notice boards of ministries in the state. The Citizen's Budget and Quarterly Reports are the only documents that are not produced at all. The remaining documents are produced for internal use only.

- Public participation in the budget process: Citizens and CSOs in Anambra state have limited spaces to be involved in the budget process with a score of 39 out of 100. During the budget formulation stage, the Anambra State Ministry of Economic Planning and Budgeting holds annual participatory budgeting hearings to provide inputs on the State Draft Estimates. The Guidelines for Participatory Budgeting in Anambra State dictates what mechanisms the government develops to solicit inputs and publishes report on how these inputs were used. The budget approval process is open to the public, but no committees publish reports. The Anambra governor publishes a list of some beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs throughout the budget execution process. In the auditing process, citizens have no open spaces for public scrutiny.
- **Public access to procurement information:** With a score of 37 out of 100, citizens have limited access to procurement information in Anambra. The Anambra State Public Procurement Law 2011 regulates the entire procurement process and established the State Council on Public Procurement.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

# **Budget Transparency**

The government can easily increase budget transparency in Anambra state by publishing online and in a timely manner the following documents that are already produced:

- Anambra State Draft Recurrent & Capital Estimates
- Anambra State of Nigeria Appropriation Law
- Anambra State of Nigeria, Mid-Year Review of Capital Implementation
- Anambra State Report of the Accountant General with Financial Statements
- Report of the State Auditor-General on the Accounts of the Anambra State of Nigeria

In addition to publishing these documents, the Anambra State Ministry of Economic Planning and Budgeting should partner with CSOs in the state to develop a Citizen's Budget.

#### **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the government of Anambra state should do the following:

- Publish a report on how the inputs during the participatory budgeting spaces are taken into account to formulate the State Draft Estimates.
- Establish practical mechanisms for the public to provide inputs on how the budget is being implemented, and publish reports on how these inputs are used.

Similarly, the Anambra State House of Assembly should do the following:

- Open committee hearings on the specific sectors to the public where citizens and CSOs can testify, and publish committee reports.
- Open the hearings on the Auditor-General's Report to the public.

Lastly, the Auditor-General should do the following:

• Establish practical mechanisms for the public to submit inputs on what should be audited.

#### **Procurement Process**

To improve the entire procurement processes, the following should be done:

- The State Council on Public Procurement should establish a procurement complaint board that manages an alternative dispute resolution mechanism.
- The State Council on Public Procurement should publish all procurement decisions along with their justifications for all community projects.

#### **Access to Information**

To improve access to information in the state, the government should do the following:

- Domesticate the Freedom of Information (FOI) Act, 2011.
- Establish Freedom of Information (FOI) Agency in the state.

# 5. Bauchi State

# **Findings**

Bauchi state scores 14 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- Public access to budget documents: Bauchi state scores 11 out of 100 on the State Budget Document Availability Index. While most documents are produced in the state, not a single document is publicly available. Only the Citizen's Budget and Auditor-General's Report are not produced.
- Public participation in the budget process: Citizens and CSOs in Bauchi state have limited spaces to be involved in the budget process with a score of 14 out of 100. During the budget formulation stage, the public is essentially closed out of this process. The budget approval process is open to the public to attend some committee hearings but no committees publish reports. Both the budget execution and auditing processes are closed off to public scrutiny.
- Public access to procurement information: With a score of 23 out of 100, citizens have limited access to procurement information in Bauchi. The Bauchi State Public Procurement Law regulates the entire procurement process and established the Bauchi

State Budget Monitoring, Price Intelligence, and Public Procurement Unit. Tenders in Bauchi state are publicly opened with some delay after the bidding process is closed.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

#### **Budget Transparency**

The government can easily increase budget transparency in Bauchi state by publishing online and in a timely manner the following documents that are already produced:

- Bauchi State Call Circular
- Bauchi State Draft Estimates along with Bauchi State Medium Term Sector Strategy
- Buachi State Budget Appropriation Law
- Quarterly Reports
- Mid-Year Review
- Accountant General Report

In addition to publishing these documents, the Bauchi State Budget Monitoring Office should partner with CSOs in the state to develop a Citizen's Budget. The Auditor-General should produce and publish an annual report on the budget.

#### **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the government in Bauchi state should do the following:

- Open the budget formulation process to all constituencies; establish effective mechanisms to solicit the public's inputs on what should be included in the State Draft Estimates; and clearly articulate what the government expects to do with these inputs.
- Publish a list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs.
- Establish practical mechanisms for the public to provide inputs on how the budget is being implemented, and publish reports on how these inputs are used.

Similarly, the Bauchi State House of Assembly should do the following:

- Open all committee hearings on the specific sectors to the public where citizens and CSOs can testify and publish committee reports.
- Hold public hearings on the Auditor-General's Report.

Lastly, the Auditor-General should do the following:

• Establish practical mechanisms for the public to submit inputs on what should be audited.

#### **Procurement Process**

To improve the entire procurement processes, the following should be done:

- The Bauchi State Budget Monitoring, Price Intelligence, and Public Procurement Unit should establish a procurement complaint board that manages an alternative dispute resolution mechanism.
- The Bauchi State Budget Monitoring, Price Intelligence, and Public Procurement Unit should publish all procurement decisions, along with their justifications, and for all community projects, according to the State Procurement Law 2011.

#### **Access to Information**

To improve access to information in the state, the government should do the following:

- Domesticate the Freedom of Information (FOI) Act, 2011.
- Establish Freedom of Information (FOI) Agency in the state.

# 6. Bayelsa State

# **Findings**

Bayelsa state scores 29 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- Public access to budget documents: Bayelsa state scores 45 out of 100 on the State Budget Document Availability Index. The State Budget Call Circular, State Draft Budget Estimates, and State Budget Appropriation Law are publicly available on request. Citizens have access to all documents in both the budget formulation and approval stages that can serve as a basis to monitor how the government is executing the budget; however, none of the budget execution documents (Citizen's budget, quarterly budget implementation reports, Mid-Year Reviews, Accountant-General's Report, and Auditor-General's report) are publicly available. The Accountant General's Report and Auditor-General's Report are only produced for internal use, while the Citizen's Budget, Quarterly Reports, and a Mid-Year Review are not produced at all.
- **Public participation in the budget process:** Citizens and CSOs in Bayelsa state have absolutely no spaces to be involved in the budget process with a score of 0 out of 100.
- Public access to procurement information: With a score of 23 out of 100, citizens have limited access to procurement information in Bayelsa. The Bayelsa State Procurement Law 2009 regulates the entire procurement process and established the Bayelsa State Due Process Bureau. The Bayelsa State Due Process Bureau publishes all awarded contracts online.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

# **Budget Transparency**

The government can increase budget transparency in Bayelsa state by publishing online and in a timely manner the following documents that are already produced:

- Accountant General's Report
- Auditor-General's Report

The Ministry of Budget and Economic Planning of Bayelsa state should do the following:

- Partner with CSOs in the state to develop a Citizen's Budget.
- Produce and publish the Quarterly Reports and a Mid-Year Review on time.

# **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the government of Bayelsa state should do the following:

- Open the budget formulation process to all constituencies; establish effective mechanisms to solicit the public's inputs on what should be included in the State Draft Estimates; and clearly articulate what the government expects to do with these inputs.
- Publish a list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs.
- Establish practical mechanisms for the public to provide inputs on how the budget is being implemented, and publish reports on how these inputs are used.

Similarly, the Bayelsa State House of Assembly should do the following:

- Open all committee hearings on the budget to public where citizens and CSOs can testify and publish reports on these hearings.
- Open the hearings on the Auditor-General's Report to the public.

Lastly, the Auditor-General should do the following:

# 7. Benue State

#### **Findings**

Benue state scores 35 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- Public access to budget documents: Benue state scores 54 out of 100 on the State Budget Document Availability Index. The State Draft Budget Estimates and State Budget Appropriation Law are publicly available on request. Citizens have access to all documents in both the budget formulation and approval stages that can serve as a basis to monitor how the government is executing the budget; however, none of the budget execution documents are publicly available. The Budget Call Circular, Auditor-General's Report, Quarterly Reports, Mid-Year Review, and Accountant General's Report are only produced for internal use, while the Citizen's Budget is not produced.
- Public participation in the budget process: Citizens and CSOs in Benue state have limited spaces to be involved in the budget process with a score of 17 out of 100. During the budget formulation stage, the public is entirely kept out of this process. The budget approval process is open to the public but no committees publish reports. The Benue government publishes a list of some beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs throughout the budget execution process. In the auditing process, citizens have no space for public scrutiny.
- **Public access to procurement information:** With a score of 10 out of 100, citizens have almost no access to procurement information in Benue state.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

The government can increase budget transparency in Benue state by publishing online and in a timely manner the following documents that are already produced:

- Request For Submission of Budget Estimates From Ministries, Departments, and Agencies
- Benue State Quarterly Review

- Mid-Year Review
- Benue State of Nigeria Report of the Accountant General
- Auditor-General's Report

The Budget Office of the Ministry of Finance of Benue state should do the following:

- Partner with CSOs in the state to develop a Citizen's Budget.
- Publish the Auditor-General's Report.

#### **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the Benue state government should do the following:

- Open the budget formulation process to all constituencies; establish effective mechanisms to solicit the public's inputs on what should be included in the State Draft Estimates; and clearly articulate what the government expects to do with these inputs.
- Establish practical mechanisms for the public to provide inputs on how the budget is being implemented and publish reports on how these inputs are used.

Similarly, the Benue State House of Assembly should do the following:

- Open all committee hearings on the budget to the public where citizens and CSOs can testify and publish committee reports.
- Open the hearings on the Auditor-General's Report to the public.

Lastly, the Auditor-General should do the following:

• Establish practical mechanisms for the public to submit inputs on what should be audited.

# 8. Borno State

# **Findings**

Borno state scores 10 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- **Public access to budget documents:** Borno state scores 13 out of 100 on the State Budget Document Availability Index. While most documents are produced in the state, not a single document is publicly available.
- **Public participation in the budget process:** Citizens and CSOs in Borno state have no space for to be involved in the budget process with a score of 0 out of 100.
- **Public access to procurement information**: With a score of 17 out of 100, citizens have minimal access to procurement information in Borno. Tenders in Borno state are publicly opened with significant delays after the bidding process is closed.

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

The government can easily increase budget transparency in Borno state by publishing online and in a timely manner the following documents that are already produced:

- Budget Estimates from Ministries, Departments, and Agencies
- State Draft Estimates
- State Budget Appropriation Law
- Borno State Quarterly Reports
- Borno State Mid Year Review

The Ministry of Budget and Planning of Borno state should do the following:

- Partner with CSOs in the state to develop a Citizen's Budget.
- Produce and publish the Quarterly Reports, Mid-Year Review, Accountant General's Report, and Auditor-General's Report.

# **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the government in Borno state should do the following:

# 9. Cross River State

#### **Findings**

Cross River state scores 73 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

• Public access to budget documents: Cross River state scores 77 out of 100 on the State Budget Document Availability Index, ranked number one of all states. The State Budget Call Circular, State Draft Budget Estimates, Citizen's Budget, Quarterly Reports, and Auditor-General's Report are all publicly available online. Citizens have access to at least one document in each phase of the budget cycle that can serve as a basis to monitor how the government spends public funds throughout the budget process. The State Budget Appropriation Law, Mid-Year Review, and Accountant General's Report are only produced for internal use.

- Public participation in the budget process: Citizens and CSOs in Cross River state have significant spaces to be involved in the budget process with a score of 78 out of 100. During the budget formulation stage, the Ministry of Local Government Affairs in Cross River state maintains budget consultation forums where a wide variety of organizations are invited. The Cross River State House of Assembly opens all committee hearings on the budget approval process to citizens, with committees publishing reports on these hearings. The Department of Projects Monitoring and Evaluation establishes a mechanism to solicit inputs during the budget execution process. In the auditing process, citizens have no open space for public scrutiny.
- Public access to procurement information: With a score of 63 out of 100, citizens have moderate access to procurement information in Cross River state. The Cross River State of Nigeria Public Procurement Act of 2011 regulates the entire procurement process and establishes the Due Process Bureau. Tenders in Cross River state are publicly opened after the bidding process is closed. Procurement awards are published online. The Due Process Bureau has a procurement complaint board with alternative dispute resolution mechanisms.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

#### **Budget Transparency**

The governor can increase budget transparency in Cross River state by publishing online and in a timely manner the following documents that are already produced:

- Cross River State Appropriation Law within three months of enactment by the State House of Assembly
- The State Mid-Year Review annually by 30 September
- Accountant General's Report on time

#### **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the Cross River state government should do the following:

- Publish a list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs.
- Ensure that the mechanisms for the public to provide inputs on how the budget is being implemented are more accessible.

Similarly, the Cross River State House of Assembly should do the following:

• Improve the committee hearing reports by including written and spoken testimony presented, not just contentious issues.

Lastly, the Auditor-General should do the following:

• Establish practical mechanisms for the public to submit inputs on what should be audited.

#### **Procurement Process**

To improve the entire procurement processes, the following should be done:

- The Due Process Bureau should be granted more powers to be single procurement authority and publish all contract guidance documents per award.
- The Due Process Bureau should publish justification of each award online.
- The Due Process Bureau should publish procurement complaints review body decisions within 30 days of reaching such decision.

#### **Access to Information**

To improve access to information in the state, the government should do the following:

- Domesticate the Freedom of Information (FOI) Act, 2011.
- Establish Freedom of Information (FOI) Agency in the state.

# 10. Delta State

#### **Findings**

Delta state scores 30 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- Public access to budget documents: Delta state scores 32 out of 100 on the State Budget Document Availability Index. The State Draft Budget Estimates are publicly available online, while the Auditor-General's Report is available on request. Citizens have access to all documents in the budget formulation stage that can serve as a basis to monitor how the government is executing the budget; however, none of the budget execution documents are publicly available. The State Budget Call Circular, State Budget Appropriation Law, Quarterly Reports, Mid-Year Review, and Accountant General's report are produced for internal use only.
- Public participation in the budget process: Citizens and CSOs in Delta state have minimal space to be involved in the budget process with a score of 39 out of 100. During the budget formulation stage, the state government with the help of the United Nations Development Programme (UNDP) developed information centers where citizens can provide inputs on the State Draft Estimates. The Delta State House of Assembly opens some committee hearings on budget approval process. The UNDP Information Centers are also used to solicit inputs during the budget execution process. The Office of the

- State Auditor-General of Delta State maintains its own separate website where citizens can submit an "Audit Alarm" to facilitate their role as the "watch-dog of the resources of the public held on trust by the Government."
- **Public access to procurement information:** With a score of 17 out of 100, citizens have limited access to procurement information in Delta state. The Delta State Fiscal Responsibility Law of 2008 regulates the entire procurement process and established the Due Process Office.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

# **Budget Transparency**

The government can increase budget transparency in Delta state by publishing online and in a timely manner the following documents that are already produced:

- Guidelines for the Preparation of the Delta State Budget
- State Budget Appropriation Law
- Delta State Government Quarterly Reports
- Delta State Mid-Year Budget Performance by MDAs
- Delta State Government Accountant General Report

In addition to publishing these documents, the Delta State Budget Office should partner with CSOs in the state to develop a Citizen's Budget.

#### **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the government of Delta state should do the following:

- Promote the UNDP Information Centers as a way for all citizens to provide inputs on what should be included in the budget; clearly articulate what the government expects to do with these inputs; and develop a report on how these inputs were used in both the formulation and the execution phases of the budget.
- Publish a list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs.
- Constitute the state public procurement body.

Similarly, the Delta State House of Assembly should do the following:

• Open all committee hearings on the budget to public where citizens and CSOs can testify, and publish reports on these hearings.

Lastly, the Auditor-General should do the following:

• Promote the "Audit Alarms" throughout the state.

#### **Procurement Process**

To improve the entire procurement processes, the following should be done:

- The Due Process Office should be granted more powers to be single procurement authority and publish all contract guidance documents per award.
- The Due Process Office should promote the State Public Complaints Bureau Office to ensure that procurement complaints are adequately addressed.
- The Due Process Office should publish awarded contracts along with justifications of each award and community projects.

#### **Access to Information**

To improve access to information in the state, the government should do the following:

- Domesticate the Freedom of Information (FOI) Act, 2011.
- Establish Freedom of Information (FOI) Agency in the state.

# 11. Ebonyi State

# **Findings**

Ebonyi state scores 20 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- Public access to budget documents: Ebonyi state scores 19 out of 100 on State Budget Document Availability Index. The State Budget Call Circular, Accountant General's Report, and Auditor-General's Report are publicly available on request. Citizens have access to all documents in the budget formulation, execution, and auditing stages. The State Draft Estimates, State Budget Appropriation Law, Quarterly Reports, and Mid-Year Review are only produced for internal use.
- Public participation in the budget process: Citizens and CSOs in Ebonyi state have limited space to be involved in the budget process with a score of 28 out of 100. During the budget formulation stage, citizens are essentially shut out from providing inputs for the State Draft Estimates. The Ebonyi State House of Assembly opens some committee hearings on the budget approval process. Both the budget execution and auditing processes have no open spaces for public scrutiny.
- **Public access to procurement information:** With a score of 13 out of 100, citizens have limited access to procurement information in Ebonyi state. The State Tenders Board is in charge of the procurement process.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

# **Budget Transparency**

The government can increase budget transparency in Ebonyi state by publishing online and in a timely manner the following documents that are already produced:

- Approved Estimates of Ebonyi State Government of Nigeria
- Ebonyi State Budget Appropriation Law
- Ebonyi State Government Budget Performance Review
- Ebonyi State Government Mid-Year Budget Performance Review

In addition to publishing the documents that Ebonyi state already produces for internal use, the Ebonyi State Budget Office should partner with CSOs in the state to develop a Citizen's Budget.

# **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the government of Ebonyi state should do the following:

- Open the budget formulation process to all constituencies; establish effective mechanisms to solicit the public's inputs on what should be included in the State Draft Estimates; and clearly articulate what the government expects to do with these inputs.
- Publish a list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs.
- Establish practical mechanisms for the public to provide inputs on how the budget is being implemented and publish reports on how these inputs are used.

Similarly, the Ebonyi State House of Assembly should do the following:

• Open all committee hearings on the budget to public where citizens and CSOs can testify, and publish reports on these hearings.

Lastly, the Auditor-General should do the following:

• Establish practical mechanisms for the public to submit inputs on what should be audited.

#### **Procurement Process**

To improve the entire procurement processes, the following should be done:

- The government should introduce a law in the SHoA establishing a tenders board that oversees the whole procurement process and a procurement complaint board that manages an alternative dispute resolution mechanism.

# 12. Edo State

# **Findings**

Edo state scores 8 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- **Public access to budget documents:** Edo state scores 11 out of 100 on the State Budget Document Availability Index. While most documents are produced in the state, not a single document is publicly available.
- **Public participation in the budget process:** Citizens and CSOs in Edo state have almost no space to be involved in the budget process with a score of 3 out of 100.
- Public access to procurement information: With a score of 10 out of 100, citizens have very limited access to procurement information in Edo. The Edo State Public Procurement Law of 2012 regulates the entire procurement process and established the Public Procurement Agency. The state government publishes some awarded contracts online.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

#### **Budget Transparency**

The state executive can easily increase budget transparency in Edo state by publishing online and in a timely manner the following documents:

- Call Circular for 2014 Budget Preparation
- Proposed Appropriation Bill Edo State of Nigeria and Edo State Medium Term Fiscal Strategy Paper
- Proposed Appropriation Law, Edo State of Nigeria
- Budget Performance Reports
- Mid-Year Budget Performance Report
- Accountant General's Report
- Report of the Auditor-General of Edo State on the Accounts of Government of Edo State of Nigeria

In addition to publishing these documents, the Ministry of Budget, Planning and Economic Development should partner with CSOs in the state to develop a Citizen's Budget.

# **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the government of Edo state should do the following:

- Open the budget formulation process to all constituencies; establish effective mechanisms to solicit the public's inputs on what should be included in the State Draft Estimates; and clearly articulate what the government expects to do with these inputs.
- Publish a list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs.
- Establish practical mechanisms for the public to provide inputs on how the budget is being implemented and publish reports on how these inputs are used.

Similarly, the Edo State House of Assembly should do the following:

- Hold open committee hearings on the budget for the public where citizens and CSOs can testify, and publish reports on these hearings.
- hold public hearings on the Auditor-General's Report.

Lastly, the Auditor-General should do the following:

• Establish practical mechanisms for the public to submit inputs on what should be audited.

#### **Procurement Process**

- The executive should ensure that the Edo State Public Procurement Law is available to citizens
- The government should give the Public Procurement Agency the resources necessary to fulfill its duty and establish a procurement complaint board that manages an alternative dispute mechanism.
- The executive should publish all procurement decisions along with their justifications for all community projects.

#### **Access to Information**

To improve access to information in the state, the government should do the following:

- Domesticate the Freedom of Information (FOI) Act, 2011.
- Establish Freedom of Information (FOI) Agency in the state.

# **Findings**

Ekiti state scores 79 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- Public access to budget documents: Ekiti state scores 75 out of 100 on the State Budget Document Availability Index. The State Budget Call Circular, State Draft Budget Estimates, State Budget Appropriation Law, Quarterly Reports, Accountant General's Report, and Auditor-General's Report are all publicly available on request. Citizens have access to at least one document in each phase of the budget cycle that can serve as a basis to monitor how the government spends public funds throughout the budget process. The Citizen's Budget and Mid-Year Review and are not produced at all.
- Public participation in the budget process: Citizens and CSOs in Ekiti state have extensive spaces to be involved in the budget process with a score of 78 out of 100. During the budget formulation stage, the Ministry of Budget and Economic Planning of Ekiti state hold town hall meetings to solicit inputs for the State Draft Estimates. The Ekiti House of Assembly opens all committee hearings on budget approval process to citizens with committees publishing reports on these hearings. The Result-Based Budget Monitoring & Evaluation Procedure Manual establishes a mechanism to solicit inputs during the budget execution process. In the auditing processes, citizens have no open spaces for public scrutiny.
- Public access to procurement information: With a score of 100 out of 100, citizens have extensive access to procurement information in Ekiti state. The Ekiti State Bureau of Public Procurement Law of 2010 regulates the entire procurement process and established the Ekiti State Bureau of Public Procurement. Tenders in Ekiti state are publicly opened after the bidding process is closed. Procurement awards with their justification are published online. The Ekiti State Bureau of Public Procurement has a procurement complaint board with alternative dispute resolution mechanisms.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

#### **Budget Transparency**

The government can increase budget transparency in Ekiti state by publishing all budget documents online and in a timely manner.

In addition to publishing these documents, the Ministry of Budget and Economic Planning should partner with CSOs in the state to develop a Citizen's Budget.

# **Public Participation**

To effectively take advantage of knowledge of CSOs and citizens, the governor in Ekiti state should do the following:

- Introduce a bill to ensure that participation in the budget formulation process is institutionalized.
- Publish a report detailing how inputs were used in the State Draft Budget Estimates.

Similarly, the Ekiti State House of Assembly should do the following:

• Open the hearings on the Auditor-General's Report to the public.

Lastly, the Auditor-General should do the following:

• Establish practical mechanisms for the public to submit inputs on what should be audited.

# 14. Enugu State

#### **Findings**

Enugu state scores 28 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- Public access to budget documents: Enugu state scores 19 out of 100 on the State Budget Document Availability Index. The State Budget Call Circular is publicly available on request. The State Draft Estimates, State Budget Appropriation Law, Mid-Year Review, Accountant General's Report, and Auditor-General's Report are only produced for internal use, while the Citizen's Budget and Quarterly Reports are not produced.
- Public participation in the budget process: Citizens and CSOs in Enugu state have a limited space to be involved in the budget process with a score of 36 out of 100. During the budget formulation stage, the Ministry of Rural Development has a Visit Every Community mandate to solicit inputs for the State Draft Estimates. The Enugu State House of Assembly committees hold public hearings on the budget approval process. Both the budget execution and auditing process have no open spaces for public scrutiny.
- Public access to procurement information: With a score of 47 out of 100, citizens have minimal access to procurement information in Enugu state. The Enugu State Public Procurement Law of 2010 regulates the procurement process and established the Due Process Office.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

#### **Budget Transparency**

The government can increase budget transparency in Enugu state by publishing online and in a timely manner the following documents that are already produced:

- Enugu State Draft Budget Estimates along with Enugu State Medium Term Sector Strategy

- Enugu State of Nigeria: Report of the Accountant General Financial Statements

- **Public participation in the budget process:** Citizens and CSOs in Gombe state have no space to be involved in the budget process with a score of 0 out of 100.
- **Public access to procurement information:** With a score of 30 out of 100, citizens have minimal access to procurement information in Gombe. The Due Process Office of Gombe regulates the procurement process. Tenders are publicly opened after the bidding process is closed.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

The government can easily increase budget transparency in Gombe state by publishing online and in a timely manner the following documents:

The Ministry of Budget & Planning of Gombe state should do the following:

- Partner with CSOs in the state to develop a Citizen's Budget.
- Produce and publish the Quarterly Reports and Mid-Year Review.

To effectively take advantage of knowledge of CSOs and citizens, the government in Gombe state should do the following:

- Open the budget formulation process to all constituencies; establish effective mechanisms to solicit the public's inputs on what should be included in the State Draft Estimates; and clearly articulate what the government expects to do with these inputs.
- Publish a list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs.
- Establish practical mechanisms for the public to provide inputs on how the budget is being implemented along with reports on how these inputs are used.

Similarly, the Gombe State House of Assembly should do the following:

- Open committee hearings on the budget to public where citizens and CSOs can testify and publish reports on these hearings.
- Open the hearings on the Auditor-General's Report to the public.

# 16. Imo State

#### **Findings**

Imo state scores 15 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- Public access to budget documents: Imo state scores 13 out of 100 on the State Budget Document Availability Index. While most key budget documents are produced in the state, not a single one is published. The State Budget Call Circular, State Draft Budget Estimates, State Budget Appropriation Law, Accountant General's Report, and Auditor-General's Report are produced for internal use while the Citizen's Budget and Mid-Year Review are not produced.
- Public participation in the budget process: Citizens and CSOs in Imo state have limited space to be involved in the budget process with a score of 19 out of 100. During the budget formulation stage, the public is essentially kept out from providing inputs. The Imo State House of Assembly holds committee hearings on budget approval process. In conjunction with Local Government Areas, town hall meetings are held during the budget execution process to assess how public works projects are implemented. The auditing process has no open space for public scrutiny.
- **Public access to procurement information:** With a score of 17 out of 100, citizens have limited access to procurement information in Imo state. The Imo State Public Procurement Law of 2010 created the Bureau of Public Procurement, which regulates the procurement process in the state.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

# **Budget Transparency**

The government can easily increase budget transparency in Imo state by publishing online and in a timely manner the following documents that are already produced:

- Call Circular for Submission of Proposals
- State Draft Budget Estimates along with 4-year Rescue Development Plan
- Imo State Enacted Budget
- Imo State Budget Performance Reports
- Imo State Financial Statements
- Annual Report of the Auditor-General on the Accounts of the Govt. of Imo State of Nigeria

The Budget Directorate of Imo state should do the following:

- Partner with CSOs in the state to develop a Citizen's Budget.
- Produce and publish the Mid-Year Review.

# 17. Jigawa State

#### **Findings**

Jigawa state scores 49 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

• **Public access to budget documents:** Jigawa state scores 44 out of 100 on the State Budget Document Availability Index. The State Budget Call Circular and State Budget Appropriation Law are publicly available on request while the State Draft Budget

Estimates are available online. Citizens have access to all documents in the formulation and approval stages of the budget cycle that can serve as a basis to monitor how the government spends public funds. Both the Accountant General's and Auditor-General's Reports are produced for internal use only while the Citizen's Budget, Quarterly Reports, and Mid-Year Review are not produced at all.

- Public participation in the budget process: Citizens and CSOs in Jigawa state have moderate spaces to be involved in the budget process with a score of 47 out of 100. During the budget formulation stage, the Jigawa state Economic Empowerment Programme hosts the Talakawa Summit to solicit inputs from the disabled community for the State Draft Estimates. The Jigawa State House of Assembly opens all committee hearings on the budget approval process to citizens. Both the budget execution and auditing process have no open spaces for public scrutiny.
- Public access to procurement information: With a score of 70 out of 100, citizens have significant access to procurement information in Jigawa state. The Jigawa Due Process & Project Monitoring Bureau Amendment Law of 2012 regulates the entire procurement process and established the Jigawa State Government Due Process & Project Monitoring Bureau. Tenders in Jigawa state are publicly opened after the bidding process is closed. Procurement awards are published online. The Jigawa State Government Due Process & Project Monitoring Bureau publishes quarterly reports on the implementation of projects including the contractor, amounts disbursed, and project completion rate.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

#### **Budget Transparency**

The government can increase budget transparency in Jigawa state by publishing online and in a timely manner the following documents online that are already produced:

- Public participation in the budget process: Citizens and CSOs in Kaduna state have limited space to be involved in the budget process with a score of 7 out of 100. During the budget formulation stage, the public is essentially closed off from providing inputs. The Kaduna State House of Assembly opens some committee hearings on budget approval process. The budget execution and auditing process have no open space for public scrutiny.
- Public access to procurement information: With a score of 3 out of 100, citizens have almost no access to procurement information in Kaduna. The Bureau of Budget Implementation, Monitoring and Price Intelligence issued the Manual on Government Procurement Policy in Kaduna State.

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

Citizens only have access to budget execution documents that can serve as a basis to monitor how the government spends public funds. The remaining reports are produced for internal use only, while only the Citizen's Budget is not produced.
- Public participation in the budget process: Citizens and CSOs in Kano state have limited spaces to be involved in the budget process with a score of 27 out of 100. During the budget formulation stage, the Kano State Ministry of Women Affairs and Social Development holds some consultations to solicit inputs for the State Draft Estimates. The Kano State House of Assembly opens all committee hearings on budget approval process to citizens and publishes detailed reports on these hearings. The Kano state government holds meetings during the budget execution process to solicit inputs on how to improve and releases a report. The auditing process has no open space for public scrutiny.
- **Public access to procurement information:** With a score of 10 out of 100, citizens have almost no access to procurement information in Kano state. Tenders in Kano state are publicly opened with a significant delay after the bidding process is closed.

- Partner with CSOs in the state to develop a Citizen's Budget.

- Public participation in the budget process: Citizens and CSOs in Katsina state have limited space to be involved in the budget process with a score of 8 out of 100. During the budget formulation stage, the public is essentially closed off from providing inputs. The Katsina State House of Assembly opens some committee hearings on budget approval process. The budget execution and auditing processes have no open space for public scrutiny.
- Public access to procurement information: With a score of 3 out of 100, citizens have almost no access to procurement information in Katsina. While there are no formal regulations on the procurement process in Katsina state, the financial instructions of Katsina State (1984 revised version) and the stores regulations (1968) regulate contracting and procurement procedures.

The State Budget Call Circular, Accountant General's Report, and Auditor-General's Report are all publicly available on request. Citizens have access to some budget formulation and execution documents that can serve as a basis to monitor how the government spends public funds. The remaining reports are produced for internal use only, while only the Citizen's Budget is not produced.
- Public participation in the budget process: Citizens and CSOs in Kebbi state have limited spaces to be involved in the budget process with a score of 22 out of 100. During the budget formulation stage, the Kebbi State Ministry of Women Affairs holds few consultations to solicit inputs for the State Draft Estimates. The Kebbi State House of Assembly opens few committee hearings on budget approval process to citizens. Both the budget execution and auditing process have no open space for public scrutiny.
- **Public access to procurement information:** With a score of 20 out of 100, citizens have limited access to procurement information in Kebbi state. The Procurement of Construction, Goods and Services Law of 2008 regulates the procurement process and established the State Tenders Board.

Citizens have access to all documents in approval, execution and auditing phases of the budget cycle that can serve as a basis to monitor how the government spends public funds throughout the budget process. The remaining budget documents are only produced for internal use, while the Citizen's Budget is not produced.
- Public participation in the budget process: Citizens and CSOs in Lagos state have extensive spaces to be involved in the budget process with a score of 78 out of 100. During the budget formulation stage, the Ministry of Economic Planning and Budget of Lagos state maintain budget consultation forums where a wide variety of organizations are invited to solicit inputs for the State Draft Estimates. The Lagos State House of Assembly opens all committee hearings on budget approval process to citizens. The Lagos state government continues these budget consultation forums during the budget

- **execution** process and publishes reports on these inputs. In the **auditing** processes, the Auditor-General has established a mechanism to solicit inputs into the auditing scheme.
- Public access to procurement information: With a score of 60 out of 100, citizens have moderate access to procurement information in Lagos state. The Lagos State Public Procurement Law of 2011 regulates the entire procurement process and established the Lagos State Public Procurement Agency. Tenders in Lagos state are publicly opened after the bidding process is closed. Procurement awards are published online. Lagos State Public Procurement Agency has a procurement complaint board with alternative dispute resolution mechanisms.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

### **Budget Transparency**

The government can improve budget transparency in Lagos state by publishing online and in a timely manner these budget documents that it already produces:

- State Budget Call Circular
- State Draft Estimates

In addition to publishing these documents, the Ministry of Budget and Economic Planning should partner with CSOs in the state to develop a Citizen's Budget and publish it within three months of enacting the budget.

#### **Public Participation**

- **Public access to procurement information:** With a score of 20 out of 100, citizens have limited access to procurement information in Nasarawa. The Nasarawa Tenders Board Office in the Ministry of Finance regulates the procurement process and publishes guidance documents for potential bidders.

The State Budget Appropriation Law, Accountant General's Report, and Auditor-General's Report are available on request. The majority of the remaining documents are produced, but are not publicly available. The Citizen's Budget and Quarterly Reports are not produced.
- Public participation in the budget process: Citizens and CSOs in Niger state have limited spaces to be involved in the budget process with a score of 39 out of 100. Citizens and CSOs are essentially shut out from the budget formulation process. The Niger State House of Assembly holds public committee hearings during the budget approval process. The government publishes a very limited list of beneficiaries of projects, subsidies, social plans, and targeted spending from MDAs during the budget execution process. Meanwhile, the auditing process is closed off to the public.
- Public access to procurement information: With a score of 23 out of 100, citizens have limited access to procurement information in Niger state. While there is no formal law regulating the procurement process, the Niger State Guideline for Economic and Due Process Document of 2007 established the Niger State Budget Implementation, Monitoring and Price Intelligence Unit to oversee the process. This Unit publishes guidance documents for potential bidders.

Citizens and CSOs are invited to few town hall meetings during the budget formulation process. The Ogun State House of Assembly opens most committee hearings to the public during the budget approval process. The government publishes a very sparse reports on how inputs were used during the budget execution process. Meanwhile, the auditing process is closed off to the public.
- **Public access to procurement information:** With a score of 17 out of 100, citizens have limited access to procurement information in Ogun state. Some MDAs publish information for potential bidders.

The Ondo State House of Assembly opens most committee hearings to the public during the budget approval process. The government publishes a very limited list of beneficiaries of projects, subsidies, social plans, and targeted spending from MDAs during the budget execution process. Meanwhile, the auditing process is closed off to the public.
- Public access to procurement information: With a score of 33 out of 100, citizens have minimal access to procurement information in Ondo state. While there is no formal law regulating the procurement process, the Ondo State Project and Price Monitoring Unit regulates the procurement process.

- **Public access to procurement information:** With a score of 37 out of 100, citizens have minimal access to procurement information in Osun state. While there is no formal law regulating the procurement process, the Osun State Tenders Board regulates the procurement process.

This Bureau is the source of all bidding guidance documents and opens bids with a slight delay after the bidding process is closed. All procurement awards are published online. The Bureau has a fully functioning procurement complaint board that publishes all disputes online.

Tenders are opened immediately after the bidding process is closed.

Taraba state scores 39 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

- Public access to budget documents: Taraba state scores 37 out of 100 on the State
  Budget Document Availability Index. The State Budget Call Circular and State Budget
  Appropriation Law are publicly available on request. The remaining documents are
  produced, but not publicly available. The Citizen's Budget, Quarterly Reports, and MidYear Review are not produced.
- Public participation in the budget process: Citizens and CSOs in Taraba state have limited spaces to be involved in the budget process with a score of 25 out of 100. Citizens and CSOs have minimal input to the budget formulation process. The Taraba State House of Assembly opens all committee hearings to the public during the budget approval stage. The government publishes a list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs during the budget execution process. Meanwhile, the auditing process is closed off to the public.
- Public access to procurement information: With a score of 67 out of 100, citizens have adequate access to procurement information in Taraba state. The Public Procurement Law of 2012 regulates the procurement process and established the State Bureau for Public Procurement. All bidding guidance documents are available from the Bureau. Tenders are opened immediately after the bidding process is closed. Awarded contracts are available on the notice boards of MDAs procuring the service.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

The government can easily improve budget transparency in Taraba state by publishing online and in a timely manner the following documents that are already produced:

- State Auditor-General's Report

The Taraba State Ministry of Finance, Budget, And Economic Planning should do the following:

- Partner with CSOs in the state to develop a Citizen's Budget.
- Produce and publish Quarterly Reports and Mid-Year Review.

- Open the budget formulation process to all constituencies; establish effective mechanisms to solicit the public's inputs on what should be included in the State Draft Estimates; and clearly articulate what the government expects to do with these inputs.

### **Findings**

Yobe state scores 25 out of 100 on the State Budget Transparency Index. The following are specific findings for each of the three pillars of the Index:

• Public access to budget documents: Yobe state scores 37 out of 100 on the State Budget Document Availability Index. The State Budget Call Circular, State Budget

- Appropriation Law, and Auditor-General's Report are publicly available on request. The Citizen's Budget is the only document that is not produced at all. The remaining documents are produced in the state but, not a single budget document is published.
- Public participation in the budget process: Citizens and CSOs in Yobe state have limited spaces to be involved in the budget process with a score of 20 out of 100. Citizens and CSOs are completely shut out from the budget formulation process. The Yobe State House of Assembly opens all committee hearings to the public during the budget approval stage. The public is also closed off from the budget execution process. Meanwhile, the State Auditor-General's Office has an email address to solicit request on what should be audited.
- **Public access to procurement information:** With a score of 0 out of 100, citizens have no access to procurement information in Yobe state.

#### Recommendations

CIRDDOC recommends the following to improve budget transparency, public participation in the budget process, and transparency in the procurement process:

#### **Budget Transparency**

The government can easily increase budget transparency in Yobe state by publishing online and in a timely manner the following documents that are already produced:

- Quarter Budget Performance Reports
- State Mid-Year Review

The Yobe State Ministry of Budget and Economic Planning should partner with CSOs in the state to develop a Citizen's Budget.

- Public access to budget documents: Zamfara state scores 14 out of 100 on the State Budget Document Availability Index. The State Budget Call Circular is publicly available on request. The Citizen's Budget is the only document that is not produced at all. The remaining documents are produced in the state but, not a single budget document is published.
- Public participation in the budget process: Citizens and CSOs in Zamfara state have limited spaces to be involved in the budget process with a score of 25 out of 100. Citizens and CSOs are essentially shut out of the budget formulation process. The Zamfara State House of Assembly opens all committee hearings to the public during the budget approval process. The government publishes a condensed list of beneficiaries of projects, subsidies, social plans, and other targeted spending from MDAs during the budget execution process. Meanwhile, the auditing process is closed off to the public.

• **Public access to procurement information:** With a score of 0 out of 100, citizens have no access to procurement information in Zamfara state.

#### Recommendations
