UPDATE IN THE IMPLEMENTATION OF THE SPRM PROCESS IN STATES

Anambra State: The Anambra State Initiation/ Stakeholders' Workshop, which formally commenced the implementation of the SPRM process in States, took place on 14th September 2011. It was preceded by the Inaugural Meeting with the Executive Council of Anambra State held on Friday 22nd July 2011. The First draft of the Self-Assessment Report is ready and the SPRM Team would be visiting the State on 8th February 2012.

Ekiti State: The meeting with Ekiti State Executive Council was held on 7th September 2011 paving way for the Initiation/ Stakeholders' Workshop that took place on Friday 11th November 2012. A complete Report on the Initiation/Sensitisation for the State has been circulated. The SPRM Team visited the State this week to facilitate the preparation of the Self-Assessment Report.

Niger State: The Inaugural Meeting with the Executive Council of Niger State took place on 22 November 2011. Arrangements are on-going to fix the dates for the Initiation/ Sensitization Workshop earlier scheduled for January 2012, but postponed due to the strike over the removal of petroleum subsidy.

Jigawa State: At the request of the Governor, arrangements are on-going to visit the state for the preliminary meeting with the Executive Council.
