JIGAWA STATE IN BRIEF

Jigawa State was created out of the old Kano State on August 27th, 1991. The state comprises of 27 Local Government Councils, 30 State Constituencies, 11 Federal Constituencies and 3 Senatorial Districts.

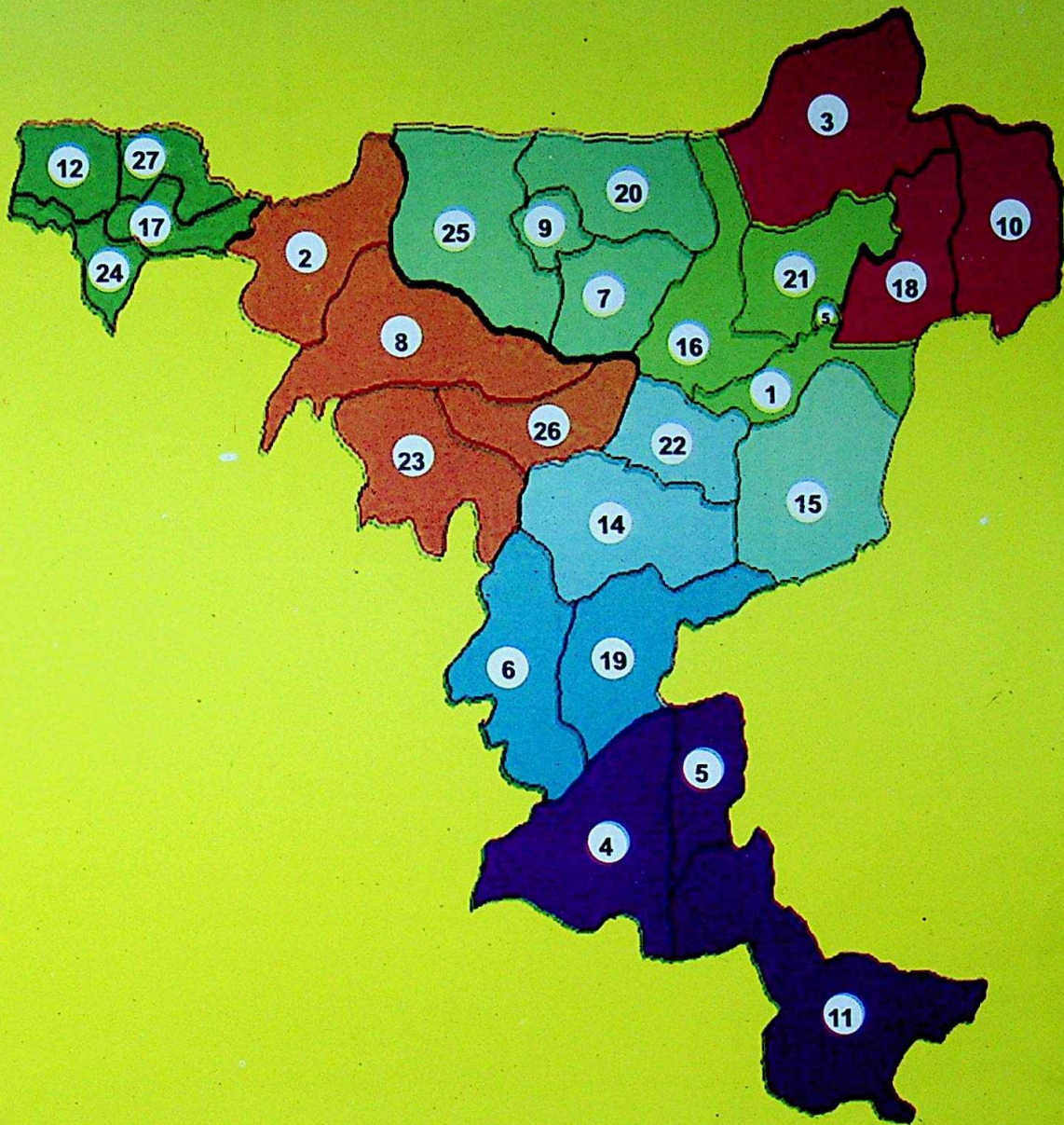
The State is in the North-Western geographical zone between latitudes 11.00°N to 13.00°N and longitudes 8.00°E to 10.15°E . The State has common border with Kano and Katsina States to the West, Bauchi State to the East and Yobe State to the North-East. It also shares an international border with Zinder Region, Niger Republic to the north, which is a unique opportunity for cross-border trading activities. Government readily took advantage of this by initiating and establishing a Free-Trade Zone at the Border town of Maigatari.

The State has a total land area of approximately 22,410 square kilometres, with an estimated population of 4.38m (Census,

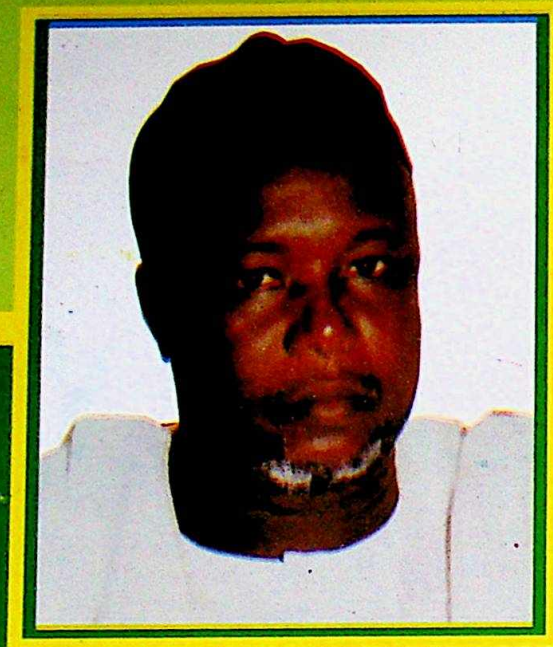
2006). Its topography is characterized by undulating land, with sand dunes of various sizes spanning several kilometers in parts of the State. The southern part of the State comprises of Basement Complex rocks while the northeast is made up of sedimentary rocks of the Chad Formation. The main rivers are Hadejia, Kafin Hausa and Iggi, with a number of tributaries, feeding extensive marshlands in north-eastern part of the State. Hadejia and Kafin Hausa Rivers traverse the State from West to East through the Hadejia-Nguru wetlands and empties into the Lake Chad Basin.

The population is predominantly of peasant farmers largely involved in subsistence farming. However, the new government has recently introduced large-scale farming for cash crops which has drastically reduced rural-urban migration and encourages self-reliance.

FROM THE DESK OF THE DIRECTOR GENERAL



The Bureau, within the Year 2016, has witnessed activities that brought so many people together under the context of procurement related issues, which ultimately increased their level of awareness. The workshop on project/budget monitoring and tracking for nongovernmental organizations (CSO/CBOs) in the state, on 21st December, 2016, led to the creation of a portal on the Bureau's website, which gives details of all on-going projects in each local government for tracking progress. This has increased the level of transparency and accountability of the administration in the eyes of the citizens. Also demand by Tax payers for information on what government is doing in their constituencies, has reduced significantly because of the details provided on projects under implementation.

The indigenous contractors, earlier in March 2016, were hosted to another workshop in the state, on procurement issues, translated in our local language (Hausa), which really improved their understanding on the subject, thereby resulting in increased participation in tendering process. The impact of the workshop led to the increase in percentage of the indigenous contractors that secured contracts in the state, from less than 30% in the previous year to 67% in 2016.

Another major achievement recorded was the registration of contractors wishing to do business in the state. There was 44% increase in the number of registered contractors doing business, this year, due to increased confidence on the administration for its judicious use of resources. At this juncture it is worth noting that as from 1st January, 2017, electronic contractors' registration has commence, thereby reducing the time lag for the exercise and easing business with the state.

On a final note, our responsibility as an agency, to provide relevant procurement and budget performance information to the public, the State Governor, in his brief review of 2016 Fiscal Year, as stated, has summarized it all. That, "Despite the enormous challenges posed by the negative growth environment characterized by dwindling revenues, high inflation, low level of economic activity in a number of sectors and inability of the economy to absorb more labor, I am glad to tell you that the numbers have shown that we have weathered the storm in many respect. Our approach to financial management, which places high premium on prudence, value-for-money and fiscal discipline, has helped us to achieve relative resilience to the economic shocks that have continued to bedevil many other States".

BACKGROUND

The Budget Monitoring and Price Intelligence Unit (BMPIU) / Due Process was established by the former President of Nigeria in 2001 in fulfillment of his desire to ensure transparency and accountability in the management of public resources. It was established as a result of the study conducted in 2001 on the state of Federal Government Public Procurements that revealed that the country lost several hundreds of billions of Naira over the last two decades. These losses arose as a result of flagrant abuse of procedures for award of public contracts, inflation of contract costs, and lack of transparency and competence-based competition and lack of merit as the fundamental criteria for award of public contracts.

Rules and regulations governing the activities of the Bureau were set since time immemorial; however, our inability to observe them led to our present predicaments. Public procurement is no exception hence public money was wasted as a result of undue influence, favoritism or fraud. These have resulted in poor quality of contract execution, lack of value for money in project / procurement implementation, over invoicing of contracts, etc. With the advent of the Civilian administration in Jigawa State, and in compliance with the Federal Government directives that each state should enact a similar domesticated law to suit its purpose, a committee was set up in 2007 to that effect.

The first draft Law No. 5, guiding the activities of the Bureau was signed on 26th May, 2009 and subsequently revised as Law No. 14 on November 2012 and has been in use including its guidelines apart from amendment No. 1 of April 2013 referred as Law No. 5, 2011 which allow the Director General to exercise the powers of the Governing Council subject to the approval of the Governor. Also the spending limit of the Governor was revised from N20 Million Naira to N100 Million Naira without reference to the Executive Council.

STRUCTURE

The Bureau is divided into mainly two sections: (A). Governing Council and (B). Management

- A) The Governing Council, which is yet to be constituted, however, has its powers now vested on the Director General, as per Law No5, 2013, Amendment of Section 9.
- B) The Management headed by the Director General, as the accounting officer, has a Secretary, seven Directors, assisting him in coordinating the activities of the Bureau. The Directors included:
 - I. Secretary, who also deputizes the Director General when the need be
 - II. Director, Administration and Finance Department
 - III. Director, Building Engineering Department
 - IV. Director, Civil Engineering Department
 - V. Director, Electrical Engineering Department
 - VI. Director, Local Government Unit
 - VII. Director, Mechanical Engineering Department
 - VIII. Director, Water Engineering Department

The Directors coordinate the activities of their respective departments and report to the Director General through the Bureau Secretary. All documents pass through the DG to the Secretary, Directors and other schedule officers. Currently, the Bureau has a total of 60Nos staff of various disciplines and out-sources other specialists as the need arises.

FUNCTIONS

1. Regulate and set standard to enforce harmonized bidding and tendering process in the state;
2. Enforce general policies and guidelines on procurements of goods, service and construction works by the all Government Agencies;
3. Monitor to ensure the efficient and effective implementation of all capital

- project and procurements in line with Due Process principles from point of contract awards to the commissioning stage with proper documentation at all levels;
4. Vet and make recommendations on project designs, bills of quantities and other projects technical requirements and specifications prior to contracting and implementations;
 5. Develop, update and maintain relevant database and technology for the state on all procurements by government agencies;
 6. Uphold professional ethic and report erring procurement personnel, State Government functionaries, department and private sector companies and their personnel to relevant authorities for appropriate sanctions;
 7. Monitor prices of tendered items and provide price database advisory service to the procuring entities
 8. Perform procurement audits
 9. Coordinate trainings to promote capacity building of procurement personnel of all the MDAs in the state.
 10. Sensitized, promote and educate the citizens and other stakeholders in the state on public procurement issues;
 11. Advise the government on the status of State Government procurement in relation to the annual appropriation;
 12. To make periodic recommendation to its Policy Coordinating Councils on the execution of the Due Process guidelines either in their substance or operationalizations:
 13. Provide relevant budget performance information in relation to progress on the execution of projects, procurements and service contracts throughout the public service in the States to any interested persons institutions within the outside government.
 14. Any other task that will be entrusted to it by the government or the policy coordinating council as they relate to its Due Process functions.

LIST OF ACHIEVEMENTS OF DPPMB FOR THE YEAR 2016

The major achievements recorded by the Bureau in the year 2016 includes:

1. Supervision of training / workshops for the personnel of the Bureau at the state level. This was achieved in collaboration with key stakeholders such as SPARC, SLOGOR and MDI.
2. Registrations of staff with professional bodies:
 - a) 2No. for Nigerian Institute of Quantity Surveyors (NIQS).
 - b) 1No. for councils for the regulation of Engineering in Nigeria (COREN)
 - c) 1No. for Nigerian Society of Engineers.(NSE)
 - d) 1No. for Nigerian Association of Technologist in Engineering (NATE)
3. The Bureau Audited Account for the year 2015
4. Full compliance and implementation of the provision of the law as applicable to Local Government Councils
5. In addition, the unit has actively participated in guiding Local Government Councils at tender board meetings to ascertain competent and suitable bidders for proposed contracts.
6. Saved the sum of ₦871,720,424.59 in favour of the government from 355 project proposals.
7. E-Registration of contractors
8. Registration of 349 contractors
9. Issuance of blank Bill of Quantities (BOQ) to NGOs in compliance to the freedom of information act.
10. The sum of ₦2,466,000.00 was generated by the Bureau as revenue to the government.
11. The State to date has recorded significant budget performance of an average of 45% in 2015-2016.

TRAINING AND WORKSHOP

In an effort to carry the general public along in all its activities, the Jigawa State Due Process and Project Monitoring Bureau organized a 2-day workshop to enlighten the Civil Society and Community Based Organizations on their roles in the monitoring of projects going on in their localities, so as to assist in achieving the desired quality and timely completion.

LEARNING VISIT BY KATSINA AND YOBE STATE PROCUREMENT AGENCIES

Katsina and Yobe State Governments, facilitated and supported by their respective SPARC co-ordination offices, visited the Bureau.

KATSINA VISIT

The objective of the visit was to study and articulate aspects of the Due Process and Project Monitoring Bureau Laws and Guidelines for easy replication and smooth take up of their procurement agency.

The Katsina State contingent arrived Dutse on 24th February, 2016 and was engaged 25th February 2016. In his speech the Director General Jigawa State Due Process and Project Monitoring Bureau introduced the Bureau's staff, and gave a brief history of procurement bill up to the passage of the bill into Law in 2009. He specifically appreciated efforts of EU-SRIP for dedicating a consultant to guide the process. The Director General also highlighted the vision, mission and objective of the Law and Guidelines of the Bureau.

The challenges towards implementation of the laws and guidelines as well as the benefits of the procurement laws in general procurements processes were also mentioned. Finally the Director General listed the success story of Jigawa State since the inception of the Bureau, some of the successes recorded include:-

- 1) Ranking of Jigawa State as 1st in doing business in Nigeria by the World Bank (2010).
- 2) The sum of N13.86 Billions was saved from contractors (2007 – 2016) by the Bureau (details posted in the website).
- 3) Effective project monitoring mechanism.
- 4) Establishing of Local Government Unit
- 5) Hosting of a website for the Bureau (www.jigawadueprocess.com)

In his response, the leader of the delegation, who is also the Chairman of the implementation Committee thanked the Director General for the courtesy accorded them since their arrival, and also expressed his deep appreciation on what they learned, which he believed will reduce the volume of their task to the barest minimum.

Some of the delegates asked some vital issues bordering around the structure and operations of the Bureau training and retraining of staff and relationship with other MDA's. At the end of session, the Special Adviser to the Governor on Due Process expressed his happiness with the choice of Jigawa State as a reference point for any form of reform objectives. He wished them well and hoped that one day they will invite us to come and see their progress.

Copies of the Jigawa State Due Process Laws and Guidelines were presented to the team with a view to hasten and ease their process of articulating their bill.

YOBE VISIT

The Yobe State government in its desire to further strengthen its governance reform agenda and to improve transparency, accountability and value for money in its Public Financial Management recently established a Bureau for Public Procurement. Being a new agency, the bureau paid a learning visit to the Jigawa Due Process and Project Monitoring Bureau, on 11/01/2017. They were received by the by the management at the DPPMB's conference hall.

Among the dignitaries present was the Directors General, of the two Bureaus, the SA to the Jigawa State Governor on Due Process Alh. Ibrahim Baba Chaichai, the Chairman House Committee on Due Process, the Bureau Ag Secretary Engr. Kabiru Ibrahim Majia and unit directors, the coordinators ACE-DFID programs from the two states and other staff of the Bureau.

The meeting began with introductions from both sides, followed by a welcome address by the DG Jigawa Due process Alhaji Ado Hussaini _{MON}, and a brief response by the DG Yobe State Bureau of Public Procurement. Three papers were presented as follows; Structure and Operations of the Jigawa Due Process, by QS Ahmad Isa, Benefits/Achievements of the Due Process by the Alhaji Ado Hussaini _{MON} and What the Due Process is Doing to meet up with Best Practice by M. Suleiman Sani. The presentations were followed by Breakout.

The question and answer sessions and presentation of copies of the Bureau Laws and Guidelines as souvenir to the visiting team by the Director General, Jigawa State Due Process and Project Monitoring Bureau Alhaji Ado Hussain.

CONCLUSION

The Bureau, like any other government reform outfit, is aimed at improving the socio-economic well-being of its people through implementation of its laws and guidelines to enable it achieve its objectives. Better understanding of these laws and strict adherence to its tenets leads to making an well informed decision; thereby bringing the anticipated positive changes.

The Jigawa State Due Process and Project Monitoring Law and Guidelines aimed at improving the process of procuring goods and services with a view to having an effective, efficient, transparent and accountable Bureau that meets government and people expectations. Also, enhanced transparency and accountability in governance, help rebuild the confidence of people on the leaders thereby raising its integrity.

It is hoped that successive government will give the needed support to enable the Bureau record more success in the country and also attain the highest possible grade available in the Public Expenditure and Finance Accountability (PEFA) assessment scheme.

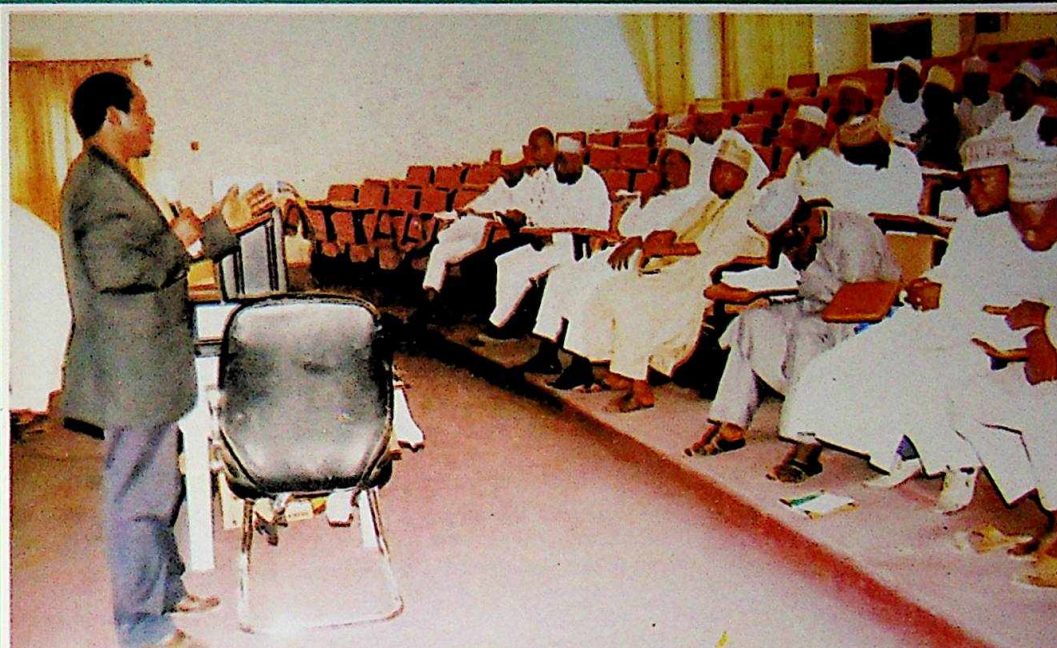

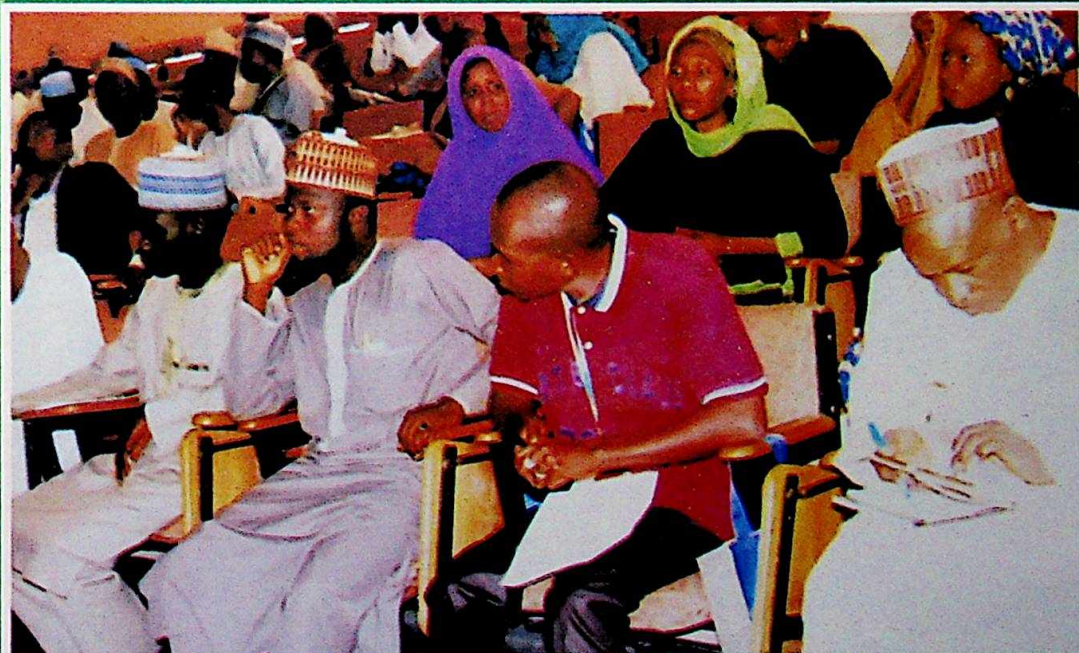
