Overview of the Millennium Development Goals (MDGs)

- Millennium Development Goals (MDGs) were formulated
 - In 2000
 - · At the United Nations Millennium Summit in New York.
- The Declaration represented a global commitment by all nations who signed the treaty (189 Heads of States signed) to
 - · reduce poverty and
 - improve lives

- · These 8 Goals have targets that are
 - measurable and
 - · time bound
- Within these 8 Goals are
 - 18 Targets and
 - 48 Indicators
- All are to be achieved by 2015.

- Goal 1 Eradicate Extreme poverty & Hunger
- Goal 2 Achieve Universal Basic Education
- Goal 3 Promote Gender Equality and Empower Women
- Goal 4 Reduce Child Mortality
- Goal 5 Improve Maternal Health
- Goal 6 Combat HIV/AIDS, Malaria and other diseases
- Goal 7 Ensuring Environment sustainability
- Goal 8 Develop a Global partnership for Development.

Road Map to achieving MDGs in Oyo State

- The framework of OYSEEDSI and OYSEEDS II designed towards attainment of MDGs
- LEEDS document initiated for the 33LGAs
- The 13 point Strategic Integrated Development of Oyo State (SIDOS) Action Plan
- Funds are made available to Ministries to execute MDGs related Projects in the area of Water, Education, Health, Works, Women's Affairs, Agriculture, Environment/Housing and Youth.
- Debt Relief Gain (DRG) are accessed as Conditional Grants, to aid the State to scale her MDGs plans.
- · Social Safety Net Initiatives to empower

Oyo State and the Conditional Grants Scheme

- Conditional Grants from Federal Government's component of Paris Club debt relief are accessed by States to support MDGs related projects at Local Governments and Communities
- Grants are contingent on specified conditions
- Serves as a platform on which States and Local Governments harmonise their budgets to nation's Medium Term Fiscal Framework

Oyo State and the Conditional Grants Scheme cont.

- In 2008, Oyo State accessed N1.88b to execute projects and programmes in the following sectors:
 - Health
 - · Water and Sanitation
 - · Youth Development
- Most Projects and Programmes have been completed for 2008
- State won additional N1.76b for 2009 projects
- All projects are equally funded by the Federal and Oyo State Government

Millennium Development Goals: Putting People First



2008 CGS PROJECTS

Health Sector

- Procurement and distribution of 100,000 Long Lasting Insecticide Treated Net (LLITN);
- procurement of ACT drugs and sulphadoxin pyrimethamine drug;
- advocacy to all stakeholders at State and 33 local Governments as well as community leaders on IMNCH;
- · scale up training on the control of communicable diseases;
- different level capacity building of 330 health service providers in the 33 local Government Areas and 220 state health providers on LSS;
- procurement and distribution of Essential drugs to 33 LGAs and Oyo
 State owned Health institutions;
- Rehabilitation of 63 Primary Health care and Maternity centers;
- construction of nine (9) 16-beded comprehensive Health Centre powered by Solar energy distributed at 3 per district to the three (3) senatorial districts.

Outcome

- at least 5% of women aged 15-49 years and 5% of children under 5 years have access to Long Lasting Insecticide Net (LLIN), ACT Drugs and sulphadoxin Pyrimethamine drugs combination;
- improved access to health care services for women, Children, Youth in the three (3) Senatorial Districts of Oyo State leading to reduction in maternal and infant mortality;
- building capacities of health workers on diagnosis and treatment of malaria and other Communicable diseases;

Skill Acquisition

- purchase of trade equipment for eight (8) skill acquisition centers in eight (8) LGAs and Youth Village at Egbeda Local Government Area;
- two weeks intensive training on selected trades for 990 selected unemployed Youth for the 33 Local Government Areas;

Expected Outcome

 empowerment of 990 youths on entrepreneurship and thereby reducing youth unemployment;

Water and Sanitation

- Construction of 200 Boreholes fitted with hand pumps;
- construction of 120 Boreholes fitted with Solar Motorized pump with storage tanks.
- Outcome:
 - increased access to potable water supply thereby reducing water borne diseases.

Success Stories

- SUCCESS STORIES
- Improved access to health care services in the 33 Local Government Areas of Oyo State;
- Construction, Rehabilitation and Equipping of Primary Health Care Centres to achieve Goals 4; 5 and 6 of the MDGs:
- Reduced under Five and Infant Mortality through implementation of Integrated Management of Maternal Neonatal and Childhood Health (IMNCH) towards achievement of Goals 4 and 5 of the MDGs:
- Improved Rural Water Supply and Basic Sanitation towards the achievement of Goal 7 of the MDGs:
- Training of unemployed youths for empowerment towards eradication of extreme poverty and hunger and achievement of Goal 1 of the MDGs;
- · Collaboration in policy implementation between the three (3) tiers of government;
- · Transparency and Accountability in use of public fund;
- · Improved services delivery to the citizenry especially at the grassroots;
- Improvement in community participation of project conceptualization and implementation;
- · Capacity building of State and Local Government Officials for better service delivery;
- The conduct of baseline survey to capture data/statistics and identify gaps for effective development planning, monitoring and evaluation;
- · Policy coordination among MDAs.
