COMPREHENSIVE REPORT OF IN-BETWEEN AND THIRD ROUNDS IMMUNIZATION PLUS DAYS (IPDs) ACTIVITIES MARCH, 2012.

INTRODUCTION:

The third round Immunization Plus Days (IPDs) was conducted from 31ST March to 3rd April 2012 throughout the 23 Local Government Areas (LGAs) of the State.

Before the implementation, some key activities were conducted considered to be indispensable to the success of the programme. These activities are known as "In-between Round activities" which includes Film Shows, Community dialogue, Announcements, Jingles, Drama, Programmes, engagement of Modibbos/FORMWAN, advocacy visits to Ministry for Local Government and some selected high risk LGAs e.g. Sabon Birni, Kware, Gwadabawa, Illela, Sokoto North and Sokoto South. Visits to Traditional and Religious leaders was also part of the advocacy.

A publication on Polio Eradication was made and jointly sponsored for distribution by the Sokoto State Primary Health Care Development Agency (SSPHCDA) and TSHIP Sokoto.

Detailed activities performed are as follows:

1. Pre-Implementation Activities in High Risk Communities:

- (iii) **Modibbo** Female Islamic preachers conducted house to house Social Mobilization of caregivers aimed at maximizing Polio Immunization coverage.
- (v) Translated and printed various Da'awa and Papers presented by Islamic scholars on the safety of Polio Vaccine, and being distributed.

2. Advocacy:

- (i) Conducted three consecutive visits to Hon. Commissioner for Local Government and Community Development in preparation for conduct of the scheduled Immunization Plus Days (IPDs) (31st to 3rd April, 2012). "In all instances, discussions were made with the Permanent Secretary of the Ministry and his Director Local Government Matters"
- (ii) Conducted meeting with 23 LGA Directors of Primary Health Care (PHC) and Local Government Immunization Officer on the needs for effective supervision, provision of logistic and participation in daily evening review meetings on 5th March, 2012.
- (iii) Conducted first State Team meeting on 8th March, 2012 with all the Partners and other stakeholders on planning for the proposed Immunization Plus Days (IPDs) to be conducted on 31st March to 3rd April 2012.
- (iv) Conducted second State Team meeting with all the Partners and other stakeholders to determine level of individuals LGA preparedness on 19th March, 2012.
- (v) Conducted visit to 9 Local Government Councils (Sabon Birni, Kware, Gwadabawa, Illela, Sokoto South, Sokoto North, Shagari, Tureta and Wamakko) on 30th March, 2012 to ascertain the commitment of the Councils to the IPDS activities.

- (vi) Requested the Commissioner of Police and the Director, State Security services on the need to provide security backup as a result of perceived threat to the dialogue Team earlier in Tungar Bahago against block non-compliance on Polio Vaccine. Friday 2nd, March 2012.
- (vii) On the issue of Simon delivered by Sheikh Abubakar Jibrin against the safety of Polio Vaccine, The Imam was convinced beyond reasonable doubt on the safety of the vaccine based on the evidence of the findings of International Islamic Scholar headed by Professor Yusufu Qordawi.
- (viii) Presented an update on Sokoto State Polio Eradication Initiatives (PEI), March 2012 to His Excellency, the State Executive Governor. (Copy attached).

Skills Improvements:

- (i) Conducted Train the Trainers Workshop on House-to-House mobilizer in conjunction with UNICEF.
- (ii) Cascaded the training of volunteer mobilizes in 8 LGAs.Sokoto South, Sokoto North, Kware, Wamakko, Illela,Gwadabawa, Isa and S/Birni

Implementation Progress Correspondences:

(i) Requested the Ministry for Local Government and Community Development for the bulk purchase of Pluses for successful implementation of Third (3rd) round of

- Immunization Plus Days (IPDs). 6th March, 2012. (Copy attached).
- (ii) Reminded the Ministry for Local Government and Community Development for purchase of 1,058 cartons of required pluses as per target population on 29th March, 2012. (Copy attached).
- (iii) In view of the importance the Agency attached to resolutions of non-compliance in Polio Eradication, it engaged the services of thirty-nine (39) Medical Doctors, Nurses and Community Health Officers in uniform posted to high risk wards to serve as supervisors and vaccinators where applicable.
- (iv) Paid advocacy to six (6) high risk LGAs in collaboration with the Ministry of Health via letter attached.

Implementation:

(i) Conducted Flag-Off exercise on 31st March, 2012 at Chimola District in Gwadabawa LGA perceived over by His Excellency the Executive Governor, ably represented by the Permanent Secretary, Ministry of Health and His Eminence The Sultan ably represented by the Galadiman Gari Alh. Aliyu Attahiru.

High Level Supervisors:

(i) High level supervisors were deployed from the State to all the 23 Local Government Areas (LGAs) to ensure effective wide coverage of the target group, below is the list of the Supervisors:

Achievements:

The following achievements were recorded

- (i) One Million, Three Hundred and Forty-Six Thousand, One Hundred and Thirty-One (1,346,131) were immunized
 - (ii) Engagements of Medical Doctors, Nurses and Community Health Officers as supervisors/vaccinators during implementation of the exercise.
 - (iii) Effective press coverage by Local and International media outfits.
 - (iv) Supervision by Districts and Village Heads during implementation of the exercise.
 - (v) Resolutions of non-compliance by combined Team from the State Primary Health Care Development Agency, Sultanate Council, Arabic and Islamic Education Board, officials of the NPHCDA and TSHIP. This brought about reduction of non compliance.

- (vi) Translation, transliteration of Fartawa on the safety of Polio Vaccine from intervention Islamic scholars for distribution as a strategy to enlighten the public.
- (vii) Denouncing of anti Polio publication made by Malam Umar Faruk Suleiman Sokoto and the copy is being reviewed for publications and distribution.
- (viii) Conducted dialogue with Malam Abubakar Jibrin Sokoto on anti-Polio Simon delivered on Friday, 16th March 2012.

Challenges:

- (i) Non supply of Pluses for the third round by the Ministry for Local Government and Community Development.
- (ii) Inadequate supervision by the individual Local Government Councils during the exercise.
- (iii) Persistent non-compliance by elite in the metropolitan LGAs.
- (iv) Non compliance by conservative elites and Ulama'as in Sokoto North, Sokoto South and Wamakko.
- (v) Poor team selection in some LGAs.
- (vi) Poor environmental sanitation.
- (vii) Bureaucratic dichotomy between the Agency, Ministry of Health and Ministry for Local Government and Community Development.

Way Forward:

- (i) To inaugurate State Task Force on Immunization as approved by His Excellency with clear mandate. 26th March 2012.
- (ii) Need for legislations to make it compulsory for every Sokoto State child to be immunize against childhood killer diseases.
- (iii) To inaugurate LGA Task Teams with clear mandate as approved by His Excellency of 26th March, 2012.
- (iv) As part of its strategy to skills improvement, the agency planed to organize a seminar/workshop for Traditional, Religious and Immams of all the 23 Local Government Areas in the State on Polio Eradication Initiative to be performed before the implementation of Child Health Week scheduled for 14th to 18th May, 2012.
- (v) Central purchase of all the required Pluses by the Min. for Local Govt. and Community Development for the remaining IPDs for 2012.
- (vi) Strict adherence to the provisions of the Laws that establishes the Agency via Edict No. 5, of 2010.
- (vii) On non-compliance by the elites and conservatives, the Agency has concluded arrangements to conduct dialogue with the affected communities.
- (viii) On Team selections, the Agency, the Partners and Traditional leaders will pay particular attention to the process of Team selections in Wards and Settlements across the 23 LGAs of the State.
- (ix) On poor environmental sanitation, Government should direct relevant Agencies to intensify efforts in improving the sanitary condition in the State.

- Inadequate supervision of the programme at all evels.


WAYFORWARD

- LGA Chairmen to inaugurate LGA taskforces on polio eradication in their respective LGAs.


Polio Victim In Maganawa Village, Wamakko LGA

RE - POLIO ERADICATION INNITIATIVE - CONDUCT OF COMMUNITY DIALOGUE IN TUNGAR BAHAGO DUE TO BLOCK NON COMPLIANCE.

I am directed to inform you that during the conduct of the just concluded 2nd Round 2012 Immunization Plus Days (IPDs) which commenced on 21st – 25th February 2012 throughout the State, an Immunization team posted to Tungar Bahago village in Kware Local Government Area encountered block non compliance in that village.

As a result, the State Team comprising of Sultanate Council, Ministry of Health, SSPHCD Agency, and the World Health Organization visited the area to conduct dialogue with the Heads of Household in the village aimed at creating better understanding of the need to have eligible children fully immunized against Polio. During discussions, it was apparently clear that the community were vehemently resisting Polio Vaccination, which may eventually give rise to the outbreak of the Disease.

In view of the above, the assistance of your Command is required with officers to support the efforts of the committee for the second round of dialogue with the said community scheduled to hold on Friday, 2nd March, 2012 at 2:30 p.m. at Balkori Village in Kware LGA.
