1.0	Commencement	
	The meeting started at 11:13 am with an opening prayer by the Governor of Anambra State.	
2.0	Minutes of the Last NGF Meeting	
2.1	Minutes for the last meeting held on the 31 st of October, 2012 were reviewed and the following amendments were made:	Secretariat
	 a. The word 'be' should be inserted to item f(i) on page 10 so that it reads, "Due to the financial constraints of the states, financial autonomy of speakers would be impossible" b. In future, attribution of statements made by individual members of the House should be less specific. Rather, minutes should simply attribute statements to "a member of the house". 	
2.2	Motion for adoption of the Minutes was moved by Sokoto State Governor, and seconded by the Kogi State Governor.	
3.0	Chairman's Brief	
3.1	The Chairman welcomed all to the meeting and briefed the House on the committee meetings that held since the last Forum meeting in October.	
3.2	On the Good Governance and Peer Review Committee, the Chairman said that the committee was scheduled to meet on Monday 19 th November, but due to poor turnout with Kano, Rivers and Adamawa only, the meeting was postponed pending a reschedule. It was also agreed that a team of governors would be constituted to undertake peer review visits to the States.	
3.3	The Chairman also informed the House that the constitution amendment Committee met twice on Monday the 19 th of November and again on Monday the 26 th of November 2012. The Chairman noted that a few members were absent from both meetings without apologies and encouraged all members to participate in future.	
4.0	Feedback from Constitution Amendment Committee Meeting	
4.1	The Chairman stated that agreement had been reached on most items on the Exclusive Legislative List (ELL) as detailed in Annex 4, while it was agreed that some would be referred to the General Forum for further consideration.	

- 4.2 Reading through the list of items, the Chairman noted in particular that:
 - a. Item 1: The Chairman said that an amendment to the wording was required, highlighting that the proposed wording as detailed in Annex 4, should reflect the separation between officers of the federation and officers of the Federal Government.
 - b. Item 3: Aviation To remain on the ELL but wording to be modified to read, "Aviation regulation, safety of aircraft, carriage of passengers and goods...but shall not extend to building, construction and management of airports". This he said was important to enable States to Build, operate and maintain their own airports.
 - c. Item 22: Election to the Offices of President, Vice-President or Governor – Chairman noted that the committee felt there should be no change but upon deliberation by the House, it was agreed that this should be modified so that all elections from the gubernatorial elections to the grass roots should be conducted by individual states.
 - d. Item 34 Labour: It was agreed that the Constitution be altered to reflect and include the following: (i)"prescribing a minimum wage for the Federal Government of Nigeria as passed by the National Assembly; (ii) prescribing a minimum wage for the States as passed by the States' Houses of Assembly of the states of the Federal Republic of Nigeria."
 - e. Item 39: Mines and minerals, including oil fields, oil mining, geological surveys, and natural gas The Chairman noted that the committee did not reach a decision on this item, and it was agreed that it should be referred to the House for further discussion. He said that three models were proposed:
 - Return to the 1960 constitution where each state would mine its own resources and contribute an agreed proportion to the centre
 - ii. The German model, where though each state mines its own resources, a national benchmark for monthly revenue would be set so that any state falling below the bench mark could be supplemented by richer states.
 - iii. No change to current status.

	After much deliberation, it was agreed that option (iii) should remain for now, but this could be revisited in future.	
	f. Item 59: Taxation of incomes, profits, and capital gains – The Chairman noted that this was set aside pending Expert advice. The Niger state Governor however noted that upon further consideration of the potential effect on poorer states, it would be better to leave this as it is.	
5.0	Update on Polio Eradication Initiative	
	Mr Jeff Raikes, CEO of the Bill and Melinda Gates Foundation Paid a courtesy call on the Chairman. Following extensive discussion by the Forum, it was agreed that intensive effort on engaging all stakeholders in the fight against Polio should continue.	
6.0	AOB	
6.1	The issue of engaging State Assembly members was raised, and after some deliberation it was agreed that zonal meetings with State Assembly members should be held to work out outstanding issues.	
7.0	Adjournment/Conclusion	
7.1	The meeting adjourned at 3:40pm.
