A. COMMENCEMENT

The meeting started at 5.55 pm with opening prayers by the Governors of Jigawa and Enugu States.

CHAIRMAN'S OPENING REMARKS

The Chairman welcomed members and thanked them for their attendance. He informed the Forum that they were scheduled to meet with Mr. President later that night and reminded them of their last meeting with the President over the October FAAC stalemate. At that meeting, the Governors had protested the deductions from the Federation Account and had received assurances from the President that not only would the deductions be stopped forthwith, the amount already deducted would be refunded by 2011.

However, in spite of the President's assurances, the sum of N181 billion was deducted from the November Federation Account as follows- N78 billion [for Nigeria National Petroleum Company (NNPC)] and N103 billion [for Petroleum Products Pricing Regulatory Authority (PPPRA)], resulting in the rejection of the November FAAC accounts by members of FAAC.

Members deliberated over this situation especially in the face of the obvious disregard of constitutional provisions as well as the apparent refusal of top government officials to implement the promise of Mr. President to members of the Forum. The Forum resolved that it was opposed to the illegal deductions and as such the States would not accept the November monthly FAAC allocations until the agreements with Mr. President were met. Members also agreed that in the event of non-compliance with their earlier agreement, they would return to their meeting at the Rivers State Governor's Lodge (from their meeting with the President at the Villa) and take a position on their next course of action.

The Chairman also informed members that one of the reasons the President sought to meet with members was to seek their advice on the way forward on the issue of oil subsidy.

ANY OTHER BUSINESS

Members decried the increase in banking rates without due consultation with stakeholders.

The meeting ended at 1.20 am with closing prayers by the Governors of Enugu and Zamfara States.
