### Background

- Yobe State started implementing the Drugs Revolving Fund Scheme (DRFS) since its creation in 1991
  - Previous attempts to make safe and affordable drugs and medical consumables available and accessible to clients have not met expectations.
  - Some of these schemes include the PTF-DRF; hospital based DRFS; the free MNCH (including under 5) & accident victims; SDSS; and PBF
  - In addition, the preponderance of fake and substandard drugs posed a huge threat to the provision of a sustainable drugs and medical consumables supply, and to the health and well being of the people of Yobe State
  - Lastly, the sub-optimal coordination of donated drugs and other inputs also led to wastages
- All these informed the decision by the current administration to sign the enabling laws establishing the Yobe State Drugs and Medical Consumables Management Agency (YODMA)

Access to capacity building opportunities for the YODMA Staff around operations


