# Subsidy Removal

## EKSG rolls out palliatives for Ekiti workers, citizens

kiti State Governor, Mr Biodun Oyebanji has approved the recommendations of the committee set up to look into the various measures the government could take to cushion the effect of fuel subsidy removal on the citizens of the state.

Briefing Journalists at the Conference Hall of the Governor's Office, Ado-Ekiti, the State Commissioner for Finance and Economic Development, who is chairman of the committee, Mr Akintunde Oyebode, said the palliative measures cover people in the formal and informal sectors as well as the elederly and the indigent citizens.

According to Oyebode, some of the succour to be enjoyed by workers, tagged Ekiti State Subsidy Relief Programme include immediate payment of consequential adjustment of the minimum wage to officers on Grade levels 14-17; leave bonus of 2017 as well as the implementation and payment of 2020 and 2021 promotion arrears.

Other palliatives as approved by the Governor for the

informal sector are N5,000 monthly conditional cash transfer to 10,000 poor and most vulnerable households from August to December 2023 with particular emphasis on the aged; while another 10,000 residents and most especially the aged would be considered for free medical attention through the EKHIS programme (Ulera wa).

To cushion the effect of the high cost of transportation especially on workers and students, the Ekiti government would make available mass transit buses as free shuttles for workers and students to and from their places of assignments while foodstuff would also be distributed to the poor and most vulnerable households.

Other approval of the Governor, according to the committee included the implementation of 90percent CONHESS and 100 percent Hazard allowance for local government Health Workers as well as salary parity for clinical staff of the Hospitals Management Board.

Oyebode restated the commitment of Governor Oyebanji led government to the people of the state and assured them that the increased revenue which culminated from the removal of fuel subsidy would lead to improved service delivery from the government as Governor Oyebanji was irrevocably committed to his vision of shared prosperity driven by the six pillars of his administration.

"In response to this discomfort, Governor Oyebanji set up a committee to propose an urgent intervention that will soften the impact of these necessary decisions. The committee which I had the honour of chairing, met with various stakeholders, including representatives of organized labour to discuss possible interventions, within the limited resources available to us. We have now completed our assignment, and will now present Ekiti State Subsidy Relief Programme to you.

"In addition to the already mentioned interventions, the Governor has also approved additional interventions designed to directly impact our poorest and most vulnerable residents to include a food distribution programme that will commence this month, distribution of inputs to farmers as well as

financial support to small businesses and our informal sector." The Commissioner stated.

In their responses, leaders of organized labour in the state including Chairmen, Nigeria Labour Congress, Comrade Kolapo Olusola; Trade Union Congress, Sola Adigun and Joint Negotiation Council, Comrade, Ajoloko Oluwafemi, who were present at the media briefing, took turns to express their appreciation to Governor Oyebanji for his love for workers and the entire citizens of the state, describing him as the first Governor who had taken stringent and enduring measures to ameliorate the suffering of the people inherent from fuel subsidy removal.

The labour leaders described the action of the Governor as unprecedented in the annals of labour –government relationship in Nigeria, stressing that Governor Oyebanji assented to all the proposals brought before him without hesitation.

Other members of the committee at the briefing included Secretary to the State Government, Dr Habibat Adubiaro and Head of Service, Barr. Bamidele Agbede.



# Tinubu's food emergency:

# Zulum visits Baga, shares food to 23,000 households

bout 23,000 households received food palliatives recently at distributions that were directly supervised by Borno State Governor, Babagana Umara Zulum in Baga town of Kukawa Local Government Area.


"Distribution of palliatives is one of the agenda of President Bola Ahmed Tinubu. He (Tinubu) has declared an emergency on food security, and in line with this objective, Borno State Government is distributing food items to communities. We have provided food and non-food items to over 20,000 men and women (today)" Zulum said.

While working on permanent livelihoods through revival of commercial acativities and farming, Governor Zulum frequently distributes food palliatives to beneficiaries who could not farm in substantial quantity to feed them year round due to over 10 years of the Boko Haram insurgency.

Zulum's latest intervention in Baga reached 13,000 households in Baga town itself, 3,500 at Cross Kauwa, a town near Baga and 6,500 in Doro Baga, another community, making 23,000 households in total.

# Tackling Ceruical Cancer - The preventive way

... As Nigeria launches vaccine for Human Papilloma Virus

ervical cancer is the second most common cancer in women and also the second most frequent cancer death among women aged 15 to 44 years in Nigeria. Cervical cancer forms in the tissues of the cervix (the connecting organ between the uterus and the vagina). It is a slow growing cancer that can be prevented through regular screening. It is curable if detected and treated early. Current estimates indicate that every year about 14,000 women are diagnosed with cervical cancer and 7968 die from the disease.

About 99.7% of cervical cancers are caused by persistent Human Papilloma Virus (HPV) infection. HPV is a very common virus as such anyone who is sexually active can be infected at sometimes in their lives. Statistics has it that about 80% of individuals are infected at one time or the other in their lives but the body immune system will usually help in clearing it off. Of the over 150 strains of the human papillomavirus, 25% are genital strains and hence transmitted mainly by sexual contact. The HPV types 16, 18, 31, 35, 51, 52 are all high risk and are prevalent serotypes in Nigeria with serotypes 16 and 18 responsible for 66.9% of Nigeria's cervical cancer prevalence. About 3.5% of women in the general population are estimated to harbour cervical HPV-16/18 infection at a given time. To raise awareness and call for action against the silent killer,

the World Health Assembly (WHA) in 2020 adopted the Global Strategy for cervical cancer elimination and this include:

Vaccination: 90% of girls are vaccinated with the HPV vaccine by the age of 15;

Screening: 70% of women screened using a highperformance test by the age of 35 and again by

HPV vaccines prevent infection by certain types of Human Papillomavirus. The HPV vaccines have the potential to prevent more than 90 per cent of HPVattributable cancers.

Nigeria with support from Partners especially Gavi plans to introduce the HPV vaccine using a phased approach. This approach has been used for

disease. Potentially Nigeria's **HPV** vaccine introduction for girls aged 9-14 is expected to avert 71,000 deaths annually target coverages are achieved. The key criteria for the selection of the 19 states are;

Level risk of cervical cancer

disease among women; Optimal cold chain Optimal capacities at State and lower local government levels; and

Good Penta3 coverage as reported through admin and survey data.

Phase 1 of the HPV vaccine

rollout is expected to commence in September 2023 with 16 states. The mode of delivery of the vaccine to these young girls is the campaign style which involves delivery at health facilities and any place where the target population can be reached such as schools, communities, markets, social gatherings, religious houses, traditional leaders' compounds where temporary fixed post will be cited. The vaccine is expected to be included in the routine immunization schedule in 2024 for girls 9 years of age.

The Introduction across the States will take place in two phases over the next two years:

Phase 1: Reach 16 States by September 2023

Ibom, Anambra, Bauchi, Bayelsa, Benue, Enugu, FCT, Jigawa, Kano, Lagos, Nasarawa, Ogun, Osun, Taraba,

Phase 2: Reach 21 remaining States by May 2024

Borno, Cross River, Delta, Ebonyi, Edo, Ekiti, Gombe, Kaduna, Katsina, Kebbi, Kogi, Kwara Imo, Niger, Oyo, Ondo, Plateau, Rivers, Sokoto, Yobe, Zamfara


The second phase is expected to commence in Q1 2024 with 21 states using the same method as that of phase 1 with a bid for the vaccine to be routinized in 2025 for girls 9 years of age in the phase two states.

The target age group for the introduction is 9 – 14 years girls which are found mostly in schools except the out of schoolgirls. Majority of this age group are children still leaving

with their parents or guardians.
Funding for the introduction
is being provided by the Federal government of Nigeria and Gavi, though little counterpart funding is expected from the states.

At the induction ceremonies for the Governors spouses, championing the introduction in their respective states was discussed since this is a girls/ women affair and they are in a better position to champion it as issues related to women are better handled and appreciated by them. It is expected that the First Ladies will be the champions of the roll out in their respective states and will lead the advocacy for the successful roll out of the HPV vaccine.

In summary, the introduction of the HPV vaccine would be a highly cost- effective investment for the Nigerian government and it would have a significantly positive results for women's health in the country. Especially in the context of the challenges faced by the secondary screening prevention program in Nigeria, adding a primary prevention strategy could accelerate the reduction of disease burden and prevent the acquisition of infection in the vulnerable Abia, Adamawa, Akwa adolescent female population.

"He further expressed the willingness of the Zamfara State Government to partner on the exploration of its mineral deposits for the good of its people."



fund, BeyondNetZero, at its inception in 2021. Banga served as Co-Chair of the Partnership for Central America, a coalition of private
organizations that works to advance economic opportunity across underserved populations in El Salvador, Guatemala, and Honduras. He
was previously on the Boards of the American Red Cross, Kraft Foods, and Dow Inc.

Ajay Banga is a co-founder of The Cyber Readiness Institute and was Vice Chair of the Economic Club of New York. He was awarded the Foreign Policy Association Medal in 2012, the Padma Shri Award by the President of India in 2016, the Ellis Island Medal of Honor and the Business Council for International Understanding's Global Leadership Award in 2019, and the Distinguished Friends of Singapore Public Service Star in 2021.

"Among the confirmed nominees also are Capt. Bala Mairiga (retd); Abdul'aziz Sani (SAN), Ahmed Vandi, Wadatay Madawaki, Airk Yandi, Wadatau Madawaki, Aisha Anka, Bello Auta, Abdulmalik Gajam, Mahmud Muhammad and Dr Nafisa Maradun," the statement read in part.

Earlier, the Majority Leader of the House, Mallam Bello Mazawaje (APC – Tsafe East), moved the motion on the governor's request for the screening and confirmation of the nominees.

The motion was seconded by the Minority Leader, Mallam Aliyu Ango (APC-Talata-Mafara South). Mazawaje appealed to his

colleagues to agree and set aside the House Order XV Rule 6 (6) of its standing orders in order to admit the nominees into the chamber for the screening.

After the screening, the lawmakers unanimously confirmed the 18 nominees to serve as commissioners and members of the State Executive Council.

# IPOB's sit-at-home: Enugu governor threatens traders who fail to open their shops

overnor Peter Mbah of Enugu State has again threatened to revoke shops in various markets in the state if the owners in obedience to the sit-athome order fail to open their shops on Mondays.

The sit-at-home order is being enforced by a faction of the outlawed Indigenous People of Biafra (IPOB).

Mr Mbah stated this when he visited Ogbete Main Market in Enugu while monitoring the effectiveness of a ban he placed on the sit-at-home order in the state.

The governor had, in June, banned the Monday sit-athome in the state, explaining that the civil action was killing the "spirit of entrepreneurship, commerce and creativity" of Igbo people in the South-east region.

He had, earlier ordered all public servants and political office holders in the state to begin reporting to their places of work on Monday or face sanctions.

Within the same week, he equally threatened to shut schools and markets that observe the civil action in the state. It was however, reported that the civil action has continued to hold in the state despite the ban by the governor.

Apparently angered by the continued observance of the illegal order, the governor warned that he would begin revoking shops whose owners fail to open for business on

"We are going to come with the Enugu Capital Territory Development Authority to put a seal on any shop that is found locked on Monday because of the illegal sit-at-home. We will take it that you are not ready to do business," he said.

"We are going to revoke your licence to operate. We will revoke your shop title and reallocate it to someone else, who is ready to do business. This is something we must enforce with immediate effect," Mr Mbah added.




### ...Enugu traditional rulers commend Mbah's efforts, assure of cooperation on community policing

raditional rulers Enugu state have commended Governor Peter Mbah over his laudable security measures since assumption of office, assuring his administration of their unswerving cooperation in strengthening community policing in their respective communities.

It was also the first meeting since the emergence of Gov. Uzodimma as the Chairman, Southeast Governors Forum.

"We wish to state categorically that the perpetrators of the insecurity in our region and their sponsors are criminals and should not be seen as legitimate agitators," he said.

He added that the forum firmly resolved to fight insecurity decisively in the region in partnership with the Federal Government and other stakeholders.

The governor added that the forum resolved to hold a security and economic summit on a date to be announced.

He further commended the security agencies for their cooperation so far and encouraged them not to relent.





# The Blossoming Success of Governor Inuwa Yahaya's Tree Planting Campaign in Gombe

n the heart of Nigeria's northeastern region, lies the fascinating terrain of Gombe State, amicably dubbed Jewel in the Savannah. Marked by its well-rounded hills and verdant landscapes, its beauty has been unfortunately marred by the harsh hand of environmental degradation. The constant adversary has been deforestation and desert encroachment.

The reality heralded a pressing need for change; a cry that has been answered by the state governor, Muhammadu Inuwa Yahaya. Experts had uncovered that desert encroachment was moving at an alarming speed of 600 metres per annum in Gombe State. The menace was said to have claimed over 12 kilometers of land across the state in decades before 2019.



overnor Alex Otti of Abia State has sworn in 16 new commissioners with a charge for them to work in line with his administration's agenda for building a new Abia.

The nominees, who failed to appear before the assembly for clearance, include Mike Akpara (Finance), Ngozi Blessing Felix (Women Affairs and Poverty Alleviation) and Ikechukwu Monday (Power and Public Utilities).

Mr Akpara was said to be receiving medical treatment outside the country, while Mrs Felix and Mr Monday were said to have recently returned from a foreign trip.

#### The new commissioners

The 16 newly sworn-in commissioners and their portfolios include Monica Ironkwe (Agriculture), Eme Uche (Education), Joel Ogbonna (Petroleum and Mineral Resources), Kingsley Anosike (Budget and Planning), Philemon Asonye Ogbonna (Environment and Urban Renewal), Okey Kanu (Information and Culture), Ikechukwu Uwanna (Justice/ Attorney-General) and Chaka Chukwumereije (Lands and Housing). Others are Uzo Nwachukwu (Local Government and Chieftaincy

Affairs), Chima Emmanuel Oriaku (Science and Technology), Nwaobilor Nwadimma Ananaba (Sports and Youths Development), Chimezie Isaac Ukaegbu (Trade, Commerce and Industry), Otumchere Oti (Works), Okebugwu Onwuma (Transport), and Mathew Chikodi Ekwuribe (Digital Economy and SMEs).

Three professors were among the commissioners.

Mr Otti said the commissioners were carefully chosen for the job, urging them to show commitment, excellence and a sense of duty in carrying out their assignments.

# in the begining

I was born in Lagos, during the Civil War, over 50 years ago and it was a lovely childhood. Not long after, my dad went to the US as an information attaché to the embassy of the United States of America where I went with him. Much of my early childhood was there and he inspired me so much because apart from being the information attaché, he was also a prolific writer and he used to have so many stage plays in so many places around the US. I remember going with him to the University of Massachusetts to watch one of his plays. His plays were on Voice of America and so many others. So, those were my enduring memories as a child and I told him, (I think when I was seven), that I wanted to become a diplomat. We returned to Nigeria and the rest of my schooling was in Lagos. I did a first degree in history, and I did a postgraduate diploma in mass communication, and then I did a master's in international law and diplomacy and then later on I got the doctorates in good governance and social development. While I did that, we went ahead to get the necessary forms for me to join the Foreign Service.

My mum was a bit in the background, serene, but making sure things were on in the background as well. That was basically my childhood, very happy, always engaged in debates with my dad and his colleagues. So, it was a fabulous upbringing for a girl to grow up in because, you were not in any way hampered. I was always allowed to join the big people's table and discussions and to make inputs. He would turn to you and say "what do you think?", and that was always fantastic because, you now learn a lot more and also participate in the conversation. Even though I was interested in those big and important conversations, I was also girly and I did all those things that girls were doing. I did not miss out on anything. I always recall my childhood with a smile and I'm grateful to my parents for that.

What would you bring back from your childhood and why?

I told you I enjoyed going to the theatre. My dad in the early 60s ran what he called Stage Craft, so, he used to put on shows for people to watch. I wasn't born then. But later on, I got used to going to watch his stage plays which were featured all over. He was also one of the founders and early writers for Village Headmaster and my mum's elder sister was casted Fatia, who was the niece of the Village Headmaster. So, I loved the drama of those years and that type of life, it was very nice.

I grew up with a lot of events in the back garden, with entertainment and my dad played instruments. He would play the flute and the saxophone and things like that really inspired me. I didn't imbibe any of those things, but that was nice to grow up to, the garden with music, and laughter. Those are the things I would love to bring back from my childhood.

**Getting into diplomacy** 

It was lovely to get into. You have representation from all the states of Nigeria and you go for training. Basically, the training for me, was what I had done in my masters in international law and diplomacy. So, a lot of it was similar. You have to go for a training to be a full-fledged foreign service officer and diplomat, and over the 28 years, I've served in different departments and I've been posted to different countries around the world, served in places like South Africa, the UK, France, and also, I've gone on different diplomatic trainings in different countries like Germany and Greece. Sometimes, you do exchange programs and all that. I've served in various offices such as the office of the honourable minister, permanent secretary and other such high-ranking

Thankfully, it's been a wonderful 28 years of doing this. I will like to encourage women to get into such fields and make their mark because at the end of the day, half of Nigeria's population is female, so, why not go into diplomacy? I know sometimes women are a little bit reticent because it involves a lot of movement around the world and they wonder how to raise a family with such things to do. But I have to tell you that diplomatic children are one of the most exposed and learned children that you can find because, they've been exposed to various cultures and civilizations and they've seen a lot. Take for instance; my experience with my dad in the US was part of what shaped me into my diplomatic sojourn.

So, this is where we are, and obviously, the crowning glory of a diplomat, is when you're able to go out as an ambassador and represent your country somewhere. I think that's what every diplomat looks forward to in their career.



# Being first lady of kwara state

I've been in government for 28 years and always exposed, at the highest level too. So, it wasn't a huge transition. For the governor, he has always been an international businessman. His background is in oil and gas management. He was an oil magnate and his company was the first indigenous oil company in Nigeria. So, He's always used to being very busy, active, and always traveling because his job entailed that anyway. So, I wasn't worried as per capacity or as per what we're going to bring to the table, as we were already practically in that environment. The only thing is, a lot of the times, your time is not your own anymore.

The governor drove himself to the inauguration, which made headlines because he has this attitude of being very simple and always likes to drive himself. So, he jumped into the car, I jumped next to him and the kids jumped into the back and we practically just drove ourselves to the inauguration and that made headlines about how simple he is. I think everybody can see that that is his nature, the simplicity that he brings to the job.

The first day was very amazing, it was good to meet everybody and it was very obvious that there was this quest for this type of development and for this type of change in Kwara. It was fantastic and everybody was on board. The support has been immense and I'm very happy with how everybody has been supporting across the board, helping with the vision for the state and it's been great to that effect.

#### What makes Kwara tick?

Kwara is like a melting pot. It's called the state of harmony. With all the different tribes in the state, they stay together. It's called a state of harmony because, it is very harmonious. It's fantastic to be there. Now, why would you want to be there? The food, the culture, there are lovely things to do, the Wara (cottage cheese) that's very well established in Kwara, it's fantastic to be there and there are sites to see, the amazing waterfall at Owu. There are so many different places to visit that are very beautiful. If you're so industrious, you come and you do so many things.

### Championing the cause for TB in Kwara

First of all, Nigeria has successfully eradicated polio. Which we played a part in doing that because; I also worked on polio vaccinations. Then, we were now told to do the TB and this now made us to go back to our states, and look at what was going on in the TB area. I had a meeting with the team from the state and also with the Stop TB team which works very well with the First Lady of Nigeria as well, and we

mapped out a strategy of how to go about things.

They gave us all the statistics and we saw that the TB centre in Kwara was working very and that it had the capacity to even take other people from other states. People were being properly looked after and the doctor who runs the

Obviously, we have a few incidents, but we're happy to note that in the last 4 years, those incidents have been going down. Although, what was now reported was that, there seemed to have been a spike in drug-resistant tuberculosis and this is a worry because the drugs don't work. Nevertheless, we're working really hard to make sure that those types of cases are really taken care of and eradicated.

There is a massive campaign. I did some jingles on radio and TV with the Centre to tell people where they need to go if you have the problem or you think you have a cough. This was what my sensitization was about: that if you have a cough that has lasted for about two weeks, or a little bit more than that, you really need to go and check it out because it may be more than what you think it is. So far, so good, we're working on that, and we're hopeful that the same way we saw an eradication of polio; we'll be able to see an eradication of TB very soon.

#### Aiike Centre

I have to thank family members and so many other people who actually said, apart from being the First Lady, you also need to do something that would give you an additional platform to reach more people. I'm peopleoriented, so, it was fantastic to have that idea to set up this additional platform with which to reach people. I had some people who came up to me, brought me a concept as well and they're still part of Ajike now and they're doing a fantastic job. This was the genesis of how we came about Ajike, and it's basically for me to be able to reach more vulnerable groups like women, youth, and children.

I talk about the youth a lot because I have a lot of youths around me, and like have them in everything that I do. The youths are our future, so the more we engage them, the better it is. So, that was why we did Ajike. I wanted to do things like skill acquisition for women, I wanted to be able to empower our children and reach the youth because I happen to be matron of many organisations, so, I knew I had to reach the youths. They are my target audience when I'm talking about drugs and sporting activities. We've done a lot on grassroots sports like softball, baseball, table-tennis, football, and this is the reason why Ajike is functioning.

#### Youths in substance abuse and cvber crime

I am the matron of the Drug Eradication Committee in Kwara and this is something that the committee has been working on and they are doing a fantastic job. We have a lot of other groups that are

involved in this activity, including the governor, obviously, the governor as head of the entire government is well aware of what is going on and we're trying our best to curb this menace. In 2018, UNODĆ did a survey and Kwara was seen to have a 13 percent drug prevalent rate and therefore, we

were judged to be the highest in the North Central zone of Nigeria. In 2019, it became something that was on the back of our mind that we really needed to work on this and get to the bottom of it. So, that is why we started a lot of initiatives, making sure that a lot of youths are effectively engaged in grassroot sports and youth centres. They need avenues with which to channel their creativity. It's very important we put in avenues with which to engage our youths so that they do not go towards the negative

curve. Apart from youth centers, there

is also a need to create jobs. When you channel their energy into something positive, this is what works. The young people are generally restless; they need avenues with which to engage, so you cannot close off society from them. They need to be part of the discussion.

In Kwara for instance, the governor chose a 26-year-old to be commissioner for youth and sports, this was a very deliberate thing because, he made sure the youth are connected to that ministry so that they can engage themselves positively. So, this is the way we're trying to work and make sure that we mitigate these effects of drug abuse. On


#### Why women should get involved in governance and leadership

# Oyo First Lady attends HIV conference, seeks support for state health system

he wife of Oyo State governor, Engineer Tamunominini Makinde, attended the 12th International AIDS Society Conference on HIV Science in Brisbane, Australia, where advancements in taming HIV were discussed.

At the conference, which is the world's most influential meeting on HIV research and its applications, hope for the cure of HIV was raised as delegates were

introduced to the "Geneva patient", the sixth person considered to be "cured" of

The Geneva patient is a Caucasian male whose viral load remains undetectable after 20 months of discontinuing Anti-Retroviral Therapy (ART).

Mrs Makinde, who led the Oyo State contingent to the conference which held between 23rd and 26th July, 2023, took the opportunity to solicit support not just for HIV programme in Oyo State, but also for the state health system, especially data management.

She held discussions with the teams from the University of Manitoba, Canada, led by the Project Coordinator, Institute of Global Public Health, Dr. Kalada Green and the Global Fund team through Dr. Greg Ashefor on the need to support the efforts of the government to improve healthcare delivery in the state.

She also interacted with the World President of the International AIDS Society (IAS), Sharon Lewin.

The over 5000 people who participated at the conference physically and virtually were regaled with progress being recorded in taming HIV, including the discovery of a drug that can preferentially prime latent cells to die and facilitate clearance of the viral reservoir.

Using a humanised mouse model, researchers found that daily doses of the drug for a few weeks significantly delayed viral rebound following cessation of ART.

Sessions of the IAS 2023 explored all aspects of long-acting injectable options, including how to ensure this injectable reach all who need them.

Long-acting ARVs were described as probably the greatest advancement in HIV field in recent years.

He explained that the accounts would remain frozen because there were hyenas and hawks who were waiting to feast on them the moment the he lifts the embargo.

The Governor who made the disclosure during his maiden interaction with the media in the state said the embargo had not hindered the operations of Ministries, Departments and Agencies, MDAs of the state.

The Governor said: "On May 29 which was the day I was sworn in, few minutes after I called for the closure of the accounts of Benue state. And I was so right to have done that.

'Even now as I speak there are hyenas and hawks waiting for just anything to drop into those accounts and they will take them out; because land mines were already planted.

'And in that context it is not yet time for the unfreezing to be done. I am still looking closely at each of the parastatals, each of the Ministries and each of the Agencies.

'And if I invite you to take a peep into what I am looking at, you will be so amazed and you will in fact ask me to close the accounts till next year.

"But while the freeze is still

in place, it is very vital that any Ministry, Department or Agency, MDA, that has a need, they bring it to the appropriate quarters at the Government House and it is treated."

He urged Benue people to rally round his government and give him the necessary support to help him deliver on his promises.

He said his doors would remain open and he would continue to be accessible to the people assuring that all actions

# Rivers: Fubara appoints Commissioners, demands patriotism in service

ivers State Governor, Sir Siminalayi Fubara has charged newly sworn-in commissioners and other appointees to see their appointments as an opportunity to exude patriotism and offer selfless service to Rivers State to enable the new administration succeed.

The Governor gave the charge during the formal swearing of four Commissioners; Prof Zacheous Adango, Dr Alabo George Kelly, Prof. Chinedu Mmom and Barr Isaac Kamalu at the Executive Council Chambers of

Government House, Port Harcourt, urging the appointees to be diligent and patriotic in the discharge of their official duties.

The four commissioners were with the immediate past Governor Nyesom Wike until his handover to Fubara.

Also sworn in were the new Head of Rivers State Civil Service, Dr George Nweke, whose appointment the Governor described as strictly on merit, and a member of the Rivers State Independent Electoral Commission RSIEC, Ibierembo Thompson.

He disclosed that the task of governance before the new administration was enormous, stressing that no stone would be left unturned to ensure that the administration started on a strong foundation and

He assured that the right incentives and modalities would be put in place for the transformation of the state pointing out that the people of Rivers State were looking up to the new administration with high expectations that required a high sense of patriotism on the part of the executive.

The governor congratulated the appointees and urged them to deploy their wealth of experiences in the service as they had served the state in various capacities

in the past, noting that the task of development in the state required the efforts of all stakeholders.

He cautioned against tendencies of undermining his administration, warning against unruly antics as no one should take his simplicity for granted. #### **Introduction:**

The education sector in Nigeria is in crisis. Federal and subnational governments are expected to declare a state of emergency in the education sector to mitigate mirage of challenges bedeviling the sector. Unfortunately, this is not the case as we speak. However, this workshop is a step in the right direction to identify, contextualize and address challenges in the sector. The ARISE AGENDA of the Executive Governor of Akwa Ibom State is based on Agricultural revolution, Rural development, Infrastructural maintenance and advancement, Security management, and Educational advancement (ARISE). The government's Economic Blueprint is anchored on eight (8) goals: Poverty reduction, Job creation, Price stability, Sustainability of Economic growth, Improved standard of living, Environmental sustainability, highly educated, healthy, and skilled populace, and safety and security. These goals were further narrowed down to four (4) Aspirations: Agricultural Revolution, Tourism and Environmental Management; Rural Development, Women, and Youth Empowerment; Infrastructural Maintenance and Advancement; Security Management and Advancement, Quality Educational and Health Sector Management; and Economic, Industrial and Social Advancement.

The policy directions arising from the fourth (4th) Aspiration were to: ensure the safety and security of lives and property; further reduce illiteracy in the state and achieve optimal self-reliance of citizens; promote, and provide high standard education system, which will produce highly educated and skilled people to meet industry demands, creating jobs for themselves, as opposed to being job seekers; encourage digital inclusiveness in all education and training programmes for all level of citizens; and promote and strengthen research and development activities as well as innovation capacity in order to support industry development among others. The government hopes to build model primary and secondary schools in each of the ten (10) federal constituencies, prioritize training and retraining of teachers to enhance their productivity, embark on an extensive renovation of dilapidated school buildings and related infrastructure, establish and expand technical and vocational training centres, Sustain and improve the free and compulsory education policy with a view to making it more functional, and promote student scholarship schemes to qualified Akwa Ibom students in Nigerian public tertiary institutions. These are the focal action policies of the government in the education sector.





igeria occupies an "enviable" position as the country with the highest out-of-school children in the world. The global estimate for out-of-school children (OOSC) is 258 million. In sub-Saharan Africa, 62 million children are estimated to be out-of-school. In Nigeria, over 12 million children are estimated to be out-of-school. In June 2022, UNESCO and UNICEF estimated that 1 in 3 children in Nigeria are out-of-school. 10.2 million at the primary school level and 8.1 million at the junior secondary school level. The report also stated that 12.4 million children in Nigeria never attended school and 5.9 million left school very early. This means that Nigeria accounts for 15% of the global figure of out-of-school children. Regrettably, 70% of children in Nigeria cannot read with meaning or solve simple mathematical problems.

At the senior secondary school level, 1 in 3 adolescents eligible for senior secondary school are not attending, and 50% of girls are not attending school in basic education level. 7.6 million girls are out of school in Nigeria, 3.9 million at the primary level and 3.7 million at the junior secondary level. Only 9% of girls from the very poor homes attend senior secondary school compared to 81% from the upper middle class.

Between 2001 and 2017, Nigeria allocated 1.9% of Gross Domestic Product (GDP) per year to education. In 2021, 2.1% of GDP was allocated to education. This was one of the lowest in Africa. 1.2% of public expenditure is allocated to education at the federal level. For both the federal and state budgets, 10% was allocated. This was below the recommended global benchmarks of 15-20% for pre-primary and primary education. Also, between 2018 and 2020, 36% (N792 billion) of the education sector budget in Nigeria was underspent. N46 billion of the Federal Government's Universal Basic Education (FGN-UBE) Matching Grant to states have been un-accessed as of April 30, 2023. Let us look at education sector statistics in Akwa Ibom State.

#### **BASIC AND SENIOR SECONDARY EDUCATION IN AKWA IBOM STATE**

Akwa Ibom state has over 2,826 public and private primary schools as 2020. There are about 3.2 million children in these schools. The out-of-school children in Akwa Ibom state was about 581,800 in 2020 according to UBEC figures. Between 2015 to 2022, State Universal Basic Education Board (SUBEB) received over N9 billion from the FGN-UBE matching grant. The state also made some progress in addressing out-of-school challenges through budgetary provisions.


From 2016 to 2019, the state budgeted N19.5 million and released N11 million for campaign against non-enrollment of school age children.

This was aimed at checkmating hawking and loitering of children during school hours in the state. The budget for awareness creation for free and compulsory education in remote areas in the state was N6 million between 2016 to 2018. The state also budgeted N277.5 million to conduct community and household research and survey on out-of-school children from 2019 to 2021. The collation and publication of report on out-of-school children in booklet form from 2019 to 2021 was N3.4m. Mass mobilization and sensitization program to mop up out-of-school children from 2019 to 2021 was N17m.

Subvention spent on education monitoring and evaluation between 2015 to 2020 in the Ministry of Education and Office of the Secretary to the State Government was N171 million. The amount budgeted for subventions for over 1164 public primary schools in Akwa Ibom state between 2015 and 2021 was over N3.6 billion. Budgetary provisions for interventions for 251 secondary schools between 2015 and 2021 was N4.2 billion. Data for actual releases and implementation are not available.

There is free and compulsory primary and junior secondary education in Akwa Ibom State (Free Education Law, section 4(10, 2015). Every child in Akwa Ibom state has the right to free, compulsory, and universal basic education and it should be the duty of the government of Akwa Ibom state to provide such education, (The Child Rights Law of Akwa Ibom State, 2008). On Friday, July 14, 2023, His Excellency, the Executive Governor of Akwa Ibom State declared a state of emergency on primary education in Akwa Ibom state during an unscheduled inspection of Christ the King primary school, Uyo, in the state capital.





kwa Ibom State has one state owned university, Akwa Ibom State University (AKSU). The university, just like the polytechnic has two campuses, Ikot Akpaden, Mkpat Enin, and Obio Akpa, Oruk Anam. Akwa Ibom State Polytechnic is located at Ikot Ekpene and Ikot Osurua. Nigeria has over 123 public and 147 private universities. The former Executive Secretary of the National Universities Commission (NUC) Prof. Rasheed Abubakar said NUC is currently processing 292 applications for private and public universities in Nigeria.

Between 2017 and 2019, 187,942 students (2017 = 62,346; 2018 = 57,857; 2019 = 67,739)sat for the Joint Admission and Matriculation Board (JAMB) exams in Akwa Ibom state. However, only 71,166 students were admitted according to JAMB records (2017 = 14,899; 2018 = 36,884; 2019 = 19,383). JAMB applicants for 2023 from Akwa Ibom State was 66,380. Similarly, between 2017 and 2019, 164,450 students from Akwa Ibom state sat for the West African Senior Secondary Certificate Examination (WASSCE) (2017 = 55,152; 2018 = 54,986, 2019 = 54,312) out of this number, 104, 932 students passed with five credits in English Language and Mathematics. (2017 = 33,583, 60%; 2018 = 39,621, 54%; 2019 = 31,728, 58%) according to reports from WAEC. That is 57% average.

In 2023, approximately 1.7 million students are competing for 700,000 places in the university system in Nigeria. However, the combined carrying capacity of all Nigerian universities is approximately 1.9 million. The

Nigerian universities offer over 2,300 academic programmes at all levels and have approximately 51,000 academic staff and 9,000 professors. The 2020, NUC report also stated that 43% of academic staff in the universities do not have doctorate degree, and 52% were Lecturer 1 and below. About 83% of all academic staff in the universities are men, and 16% women. Nigeria has about 22,548 academic vacancies across all disciplines in the universities according to the NUC 2020 report.

### EDUCATION BLUEPRINT FOR THE ADMINISTRATION: THE ARISE AGENDA

- 1. The new administration in Akwa Ibom state has set the ball rolling by declaring a state of emergency in the primary education sector. Education should be at topmost priority of the government to address the out of school children challenges. Education stakeholders and development partners should team up together and present a blueprint on how best the challenges in the education sector should be addressed in the state. The drive to tackle out-of-school children challenges should commence with the prompt subventions to basic and senior secondary schools in the state. Building of ten model primary and secondary schools as part of the ARISE agenda will increase enrolment in the state and address out of school children challenges if there is adequate funding and releases of subventions to primary and secondary schools. Acceleration and retention of girls will be possible through empowerment to reduce poverty in the state.
- 2. Schools in Akwa Ibom State charge hidden fees. Pupils and students pay N500 for interventions, N500 for P.T.A, N1,500 for continuous assessments, N500 for opening of files among others in most public schools. Government should provide subventions to schools to accommodate these charges and activate the free and compulsory basic education in the state. As government intends to embark on an extensive renovation of dilapidated school buildings and infrastructural development, efforts should be made to ensure that schools receive prompt subventions to carter for running cost and limit opportunities for hidden charges.



- 3. Similarly, the state should appropriate about 15% of its fiscal budget to education. The global benchmark is between 15 and 20%. There should be prompt accessing of the FGN-UBE Matching Grant through the Universal Basic Education Commission with the payment of the counterpart fund every fiscal year. This should also be the case with the newly established National Senior Secondary Education Commission (NSSEC). NSSEC will receive 2% Consolidated Revenue Funds from the Federation Account to address senior secondary education challenges across the states. Funds for senior secondary schools will be accessed the same way UBEC Funds are accessed with counterpart funds. This will help the government to have funds for infrastructural development, training and retraining of teachers and establishment and expansion of technical and vocational training centres in line with the ARISE agenda. The Nigeria Governors' Forum (NGF) will support NSSEC on state-based needs assessment. Akwa Ibom state should constitute a State Senior Secondary Education Board (SSSEB) like SUBEB in the state.
- Passion for education should be the major criteria in the appointment of the Commissioner of Education in the state. There are programmes by the World Bank, UNESCO, UNICEF, FCDO etc. to address out-of-school children, foundational literacy and numeracy, girl child education, acceleration, and retention of girl child education to senior secondary level, among others. The government should partner with donor agencies and international developmental partners to fund and support educational development in the state. For example, the Adolescent Girls Initiative for Learning and Empowerment (AGILE) project is a federal government project supported by the Word Bank to create safe learning spaces in secondary schools, improving existing schools' infrastructure and empower the girl child on school enrolment, acceleration, and retention in senior secondary schools. Additional states are incorporated in the

- phase two after the successful implementation of the project in seven states in phase one. Akwa Ibom state government should reach out to the Federal Ministry of Education on this project.
- 5. Bursary and scholarship should be provided for students in the tertiary institutions to ameliorate their financial burden. This is also part of what the ARISE agenda for education is set out to do. The existing tertiary institutions in the state should be adequately funded in the areas of capacity building and infrastructural development. Sustainability of the existing ones is far better than establishing new ones. The temptation to do that should be resisted at all costs. The

Nigeria Governors Forum (NGF), Committee of the Vice Chancellors of the Nigerian State-Owned Universities (CVCNSU), Joint Admission and Matriculation Board (JAMB), National Universities Commission (NUC), Tertiary Education Trust Funds (TETFund), and Federal Ministry of Education (FME) will carry out a needs assessment of all stateowned universities in Nigeria on manpower, funding curriculum development, governance structure, infrastructure, and human resources management, among others. The report of the Peer Review Mechanism of state-owned universities will be presented to the 36 states governors for evaluation and implementation. This will help to address challenges in the management of tertiary education and provide a policy document for implementation.

#### **CONCLUSION**

Finally, monitoring and evaluation of the education sector will go a long way in identifying critical challenges from time to time and proffer solutions on how to promptly address them. Educationists and community leaders with integrity and fear of God should be assigned duties of periodic monitoring and evaluation of basic, senior secondary and tertiary education to enable the state governor to be well informed on practical ways of addressing educational challenges in the state for the collective socio-economic benefits of citizens. The Nigeria Governors' Forum is committed to providing technical supports for states to enable them conduct independent and reliable evaluation of the education sector periodically.

#### **Background**

HE presented the blueprint of his Administration – the A.R.I.S.E Agenda, to members of the secretariat and invited the NGF Secretariat to collaborate with the State to host the first ever Akwa-Ibom dialogue. Members of the public would be drawn from various sectors with a charge on them to critique and provide tangible solutions and how they can be achieved for the actualisation of the vision of his government.

### The ARISE Agenda is elaborated below:

- 1. Agricultural Revolution, Tourism & Environmental Management
- 2. Rural Development, Women & Youth Empowerment
- 3. Infrastructural Maintenance & Advancement
- 4. Security Management, Quality Educational & Health Sector Management
- 5. Economic, Industrial & Social Advancement

The Agenda seeks to consolidate on the economic gains of previous administrations while expanding the frontiers of the state economy in the post-COVID era. It is equally poised to highlight strategies and actions that will be deployed at the onset of

the new administration to sustain all existing economic recovery efforts. According to HE the Governor, this would be achieved through the sustainable and efficient use of highly developed human and material resources within the framework of SMART solutions as well as innovative digital and green technologies in all sectors of the economy to create value and wealth, and improve the quality of life of the people in a clean, safe and secured environment

Over the period of the dialogue, 21 foal sectors within the ARISE agenda

were allocated to resource persons and facilitators to critique and provide tangible solutions and how they can be achieved for the actualisation of the vision of his government in these focal sectors.

#### **Rural Development**

Members were tasked with creating a rural development plan that seeks to gradually integrate the rural areas with the urban areas, that will lead to the sustained improvement of the quality of life of the rural population by increasing their access to finance, capacity building as well as basic services including potable water, electricity, good roads, education, healthcare, etc.

To strengthen rural development planning by adoption of measures that promote a better and more equitable integration of the rural sectors with the rest of the state's economy, the committee broke down the sector into the various thematic areas include Roads, Water, Sanitation and Hygiene (WASH), Health Care, Electricity, Education, and Farmers' Support Programmes.

Sector analysis provided a clearer view of the prevailing conditions, possible solutions/recommendations, an action, and Sustainability Plan. Poor farm roads remain a challenge. To address this, members recommended additional funding of RARA to commence intervention in partnership with the 31 LGA Councils in line with the provisions of the State Roads Fund (SRF). Other recommendations include the creation

of primary and secondary markets, processing centres and farm settlement linkage roads should be prioritized in rural roads selection.

#### Conclusion

The dialogue provided an avenue for the administration to chart a pathway to sustained improvement of the quality of life of the rural population by increasing their access to finance, capacity building as well as basic services including potable water, electricity, good roads, education, healthcare, etc. And strengthen rural development planning by adoption of measures that promote a better and more equitable integration of the rural sectors with the rest of the state's economy.

Well, we are looking for a strong legacy to give back to the state. So, we are not going to let our people down.

"I want you to know that we have a lot to do for our people. We already prepared the roadmap for sustainable development 2023-2027. Please key into it. These are very difficult times.

2027. Please, key into it. These are very difficult times.

A lot has happened in this second tenure, and from what we have seen, a lot will be required from us. Please, there should not be laxity. You have all taken the oath of office and I expect you to deliver according to the oath you have just taken."

He, therefore, assured them that he would continue to provide a platform that would engender personal growth while pursuing the

overall development of the state.

The governor later posted the commissioners to their respective ministries.



kiti State Governor, Mr Biodun Oyebanji told his commissioners and special advisers to justify their presence in the government through excellent discharge of duties in their respective MDAs.

# Bayelsa Govt. to publish list of beneficiaries of monthly economic empowerment scheme'

he Bayelsa State Government has disclosed it would soon publish the comprehensive list of the beneficiaries of its monthly N200,000 Economic Empowerment Scheme for women and youths in the state.

The Deputy Governor of the state, Lawrence Ewhrudjakpo, made the disclosure at a meeting with the Douye/Law Continuity Mandate Initiative (DLCMI) in Government House, Yenagoa, saying the present administration had done a lot in the area of empowerment through different

He pointed out that the publication of the names of the beneficiaries became necessary in order to correct some misconceptions about the initiative.

He further explained that such a publication would promote accountability and transparency about the programmes, including the Diri Digital Entrepreneurial Empowerment Programme (D-DEEP) geared towards supporting indigenous women and youths to grow their businesses.

Ewhrudjakpo, who specifically responding to a remark that women in the rural areas were not being carried

along in the scheme of things, said four women and youths were selected from each of the 105 wards of the state for the economic stimulus scheme monthly.

He noted that the Gov. Douye Diri-**Prosperity** led Administration positively had touched the lives of so many women, adding

going forward, the Ministry of Women and Children Affairs, Empowerment, and Social Development would publish the names of the beneficiaries according to their respective Local Government Areas (LGAs).

His words: "Even though we don't like parroting about our achievements as a government, let me just correct an impression. We are actually doing a lot for women in this

"This government empowers 4 persons (women and youths) in each ward every month with a minimum of N200,000. If you multiply that amount by the 105 wards we have, you will know what government is spending on this purpose every month.

'And they are not the same people. We give to new beneficiaries every month. You see, the problem with Bayelsa is that most Bayelsans are greatly ungrateful.

This is a state where people even hide their appointments. That is why those who have benefited from this economic empowerment programme, hide it because they don't want people to know.

They will even complain or cry more than those who have not benefited. So, we are going to publish the names of those who have benefited, local government by local government, for the world to know," he said.

Earlier, in his written address, the Coordinator of the Douye/Law Continuity Mandate Initiative, Mr Austin Okpeh, said the group was throwing its full weight behind the second-term bid of the Governor and his Deputy,

because of their impressive performance.

While commending the Prosperity Administration for its laudable developmental strides so far, Mr Okpeh appealed to the Governor not to leave them out in the scheme of things.

In another development, Deputy Governor Lawrence Ewhrudjakpo gave a pass mark to the Tari-Ere Ogbo of Bayelsa State, for diligently spreading its membership umbrella to cover all the eight LGAs of the state.
