# Tweaking the Health Space, Leveraging Governance

n this edition, the 2023 Universal Health Coverage (UHC) Day, where, in a decisive call to action, Nigeria's 36 state governors converged in Abuja for its commemoration, an event graced by His Excellency, President Bola Ahmed Tinubu, is our cover choice. Chairman of the Nigeria Governors' Forum, NGF, His Excellency,

Abdulrazak Abdulrahman, the Executive Governor of Kwara State, highlighted the imperative to "save lives, reduce physical and financial pain, and produce health for all, "through a Sector Wide Approach (SWAp).

The recent convergence of state health commissioners at the induction retreat organised by the NGF, Secretariat, Abuja, and Nigeria Commissioners of Health Forum, NCHF, underscores the centrality of

health in the human development story. Obviously raring to go, the health sector technocrats entrusted with managing the sub-nationals' health space in consonance with their governors' broad health governance visions did not betray misapprehension of their critical mandates.

"Health is not merely a sector; it is a fundamental right and a cornerstone of a thriving society. Your leadership is pivotal in achieving health equity, improving healthcare access, and addressing the numerous health challenges facing our states," NGF Chairman, H.E. Abdulrahman, told the rapt state health minders.

Dr. Oyebanji Filani, NCHF Chairman, advised his peers to expect multifaceted challenges in their new offices, "ranging from technical and administrative hurdles to navigating complex political landscapes," and stressed the need for "a profound understanding of the complex and dynamic healthcare landscape in Nigeria."

burden of non-communicable diseases in Nigeria, regretting that Nigeria has the highest outof-pocket expenditure on health in the West African region.

His words: "The health situation in Nigeria requires uncommon approaches to

make a remarkable difference. With the on-going increase in the burden of noncommunicable diseases on the background of the high burden of communicable diseases, multiple outbreaks, and the highest out-ofpocket expenditure on health in the region, more Nigerians are falling into poverty due to ill health while many do not have access to the quality essential health services they need."

Mulombo charged the health new commissioners not to be deterred by the prevailing economic

challenges in their respective states, but ensure to take advantage of their new positions to steer their state governments towards the right



In line with the recent 45th anniversary of Alma-Ata and 5th anniversary of Astana declarations on primary health care in Astana Kazakhstan, he urged the commissioners to prioritise primary health care by "shifting focus from mere concepts to actions with demonstrable results, for greater resilience in the health sector, even in the face of emergencies."

On his part, the former Chairman, Nigeria Governors' Forum (NGF), Dr. Kayode Fayemi, asked the Nigerian Dental and Medical Registration Council

(NDMRC) to seize the license of newly graduated health workers until they complete between three to five years of service in the country.

Fayemi who was also former governor of Ekiti State, held this course is important to address the scourge of brain drain which was currently crippling the Nigeria health sector.

He said: "First, for doctors that we've trained. I think we should have even for our health workers generally, there'll be some kind of scheme, call it National Health Service scheme for newly licenced health workers that would enable

them to spend some time in a fixed period not limitless three, five years.

"Whilst you're doing that your licence is



held by the Nigerian dental and medical registration body that gives you that licence. Once you're done, you can leave you can decide you want to stay or you want to leave."

While noting that his recommendations were not heart-shaking, he further recommended that countries interested in recruiting health workers, especially doctors from Nigeria should pay for the training of their substitutions, and partnerships with governments of other countries should be established to train health workers in Nigeria.

"For countries that want to come and recruit doctors from Nigeria, or health workers from Nigeria, you should pay for the training of



For countries that want to come and recruit doctors from Nigeria, or health workers from Nigeria, you should pay for the training of the substitution the substitution. So it isn't just about you taking a doctor you want outside yourself for three or five years or an optometrist or a pharmacist or a nurse. "I'm worried about the entire health resource force that

I'm worried about the entire health resource force that we have not just doctors, you must pay us. I would say equivalent of training two doctors if you are taking one doctor out of our system. You must give enough funding for training those two doctors.

"Train people on the ground with support from the British government and other partners that would enable an accelerated training of health workers, particularly nurses on the ground. We cannot continue this way."

Fayemi who argued that by such a policy he was not downplaying the need to improve the remuneration packages of doctors, urged state governors to prioritise the health sector by improving its funding.

"You heard what I said about health financing so we can ramp up the figures of people who are benefiting from health insurance. Not 100,000, not 200,000. We need to do it in the millions. We will be the third most populous country in the world by 2050 and it is not just enough to have a huge population, we

need a viable population that can replace the workforce in the world."



# NGF PHC Leadership Challenge Regional Peer Review Meetings

he NGF Secretariat in partnership with NPHCDA and UNICEF hosted a series of regional review meetings on the PHC Leadership Challenge for key state health officials from October to December 2023.

The purpose of the review meetings was to disseminate the findings of the PHC performance assessment, share best practices that can improve PHC outcomes, and guide state teams on to how to improve PHC performance ahead of the next assessment/Award slated for next year.

The meetings had in attendance, a total of Thirty (30) Honourable Commissioners of health, Thirty-four (34) Executive Secretaries of the State Primary Health Care Boards (SPHCBs), Thirty 30 Executive

Secretaries of the State Social Health Insurance Agencies, Thirty-seven (37) Directors of Planning, Research and Statistics of the SPHCBs, and Twenty-nine 29 ALGON Chairmen. In addition to the State participants, members of the PTC (NGF, NPHCDA and UNICEF), Independent the Verification Agents (IVAs) and Independent Judging Panels (IJPs) were also in attendance.

Amongst the various lessons learned, a major highlight is the need for improved knowledge management through experience sharing and proper documentation of activities and best practices.

With a commendable spirit of sportsmanship, state teams unanimously committed to improved performances at the next round of assessment. Ostensibly, this initiative is seen to foster the needed performance-driven and positively competitive intent to serve communities better and improve health outcomes in the country.

The PHC Leadership Challenge was put together to accelerate the implementation of the Seattle Declaration made by Governors in 2019 and to catalyze renewed political commitment of all Governors to improve PHC outcomes at scale. The challenge provides an opportunity for the 36 states and FCT to equitably compete within their respective geopolitical zones for an annual best performing and most improved awards in PHC delivery, of which Borno state emerged as the national winner in the maiden edition.

# Subnationals Must Upscale Management of Epidemiological Challenges Prof. Tomori

Eminent Professor of Virology and infectious diseases expert, educationist and ex-Regional Virologist for the World Health Organization, Africa Region, OYEWALE TOMORI, says that sub-nationals must step-up in managing epidemiological challenges and speaks on wide ranging and crucial health sector issues. LOUIS ACHI provides excerpts

You are a key father figure in Nigeria's health sector and internationally, over decades, in terms of mentoring personnel and conceptualizing policy. Would you say Nigeria's broad health sector situation today meets with your growth and development expectations? No, it doesn't. We should have done much better than we are doing. Part of it is that - you know there are two

aspects of development. There is something we call capacity building. There's also capacity retention. So if you build and you don't create an enabling environment for them to function, then they will go to where they can function. That's why we have "Japa" today.

#### Okay, the brain drain?

Exactly. A lot of people think that brain drain is because you are looking for better life. That's part of it but there is also the fact that you train me to be a doctor or a lawyer or whatever and then the environment does not allow me to have fulfillment professionally. So a lot of people go out making the mistake they are all looking for money and for whatever.

Sometimes, professional fulfillment is more satisfying. A little bit of money here and there, but if you are professionally satisfied you'll stay. There are a lot of people holding back in this country not because they can't go anywhere. But rather because you know, whatever it is they are doing, they are professionally satisfied.

So we must always look at both together. First, yes, you need money to survive, but at the same time after you've trained me to be a doctor, I have no hospital to go. I go to the hospital there's no drug. I can't be of any help. I'm trained to help people for the good and then because you don't give me the resources, I cannot help the people.

What is the use of an engineer who you sent to go build a bridge and you don't provide him with all the materials to build a bridge. What use is he? So there is the issue of professional satisfaction as well as you know the

#### Creating enabling environment is the key issue here. Do you foresee any change in this narrative in the nearest future, as new administration is in place?

You see, one keeps hoping. But I know how many times our hope has been dashed in this country and so it's difficult even though we have the hope that a new administration will do better. But then if we look back too and you said how many administrations have we had. What have they done? So you hope that they will, but you don't have any confidence from past experience that anything better will come out of the new administration.

# In confronting epidemiological challenges, what should be the role of subnationals? The federal government usually takes the lion share

The diseases start at the subnational level not at the federal level. Most of the cases are occurring in the rural areas. It starts from the subnational level, not even at the state level but at the local government level. We need to strengthen those local government areas at the state level to take responsibility for solving disease problems in their

> Then our National Center for Disease Control will not be running helterskelter all over the place. In fact they will do less of control and do more of coordination so that you know when the things are happening. We will only need the federal to assist and coordinate. The central government's role is to empower the states and the state will contribute to it so that we can spread the capacity to do this work well.

We need to strengthen those local government areas at the state level to take responsibility for solving disease problems in their region





monetary livelihood - all those combined. So we train; we build capacity. But we don't retain our capacity because we don't create the enabling environment for them to be fulfilled.

> If each state is handling its own problem and it needs minimal support the NCDC can provide that one. But when NCDC is the one providing the full support when is it going to be able to handle the situation and that's why we are having the problem we are having. States and local governments must take care of their

> responsibility. They must be responsible for solving those initial problems. Actually let me start from how those pandemic starts. It starts with one case. So a case occurs in a place just like we are seeing diphtheria. Now, a case starts in one place and you don't do anything about it, more cases arise in a local government.

> If we don't do anything about it, it spreads to the state. If the state doesn't do anything about it, then it spreads to the country and where the country doesn't do anything about it, it spreads to the world and that's how COVID started.

> COVID started with one single case in Wuhan, spread to other parts and cities of China then to the world. That's where we are today. So epidemic starts with one case. If you manage to control it at that point, then you won't have an epidemic and you cannot sit in Abuja and see the epidemic in my mother's village.

> There are people in the villages, officers, who will see that single case, who will report it and take the appropriate actions so that it doesn't spread from my village to my town to my local government to my state to my country and to the world.

#### Is there a linkage to the structure of our federalism with states' apparent inability to handle certain critical health sector responsibilities?

You know everything is in the center in this country and I think someone said the center can no longer hold. We started this country not as these federal parts; we had regions. At the time there were two regions that had set up governments and we were developing then. I grew up in the Western region. It was what made me to be what I am today.

In my region we had free education, free health and other free things.

Then we broke all that down and now have a federal that is running everything. The state has been incapacitated. The local government has been





incapacitated. But if go back to those days, let everyone manage his own.

Let each state own it and contribute to running the federal. That's the way things can be handled. That is what people have been saying. It worked very well for us in those days before independence and soon after. So why did we move into federalism. Remember in our constitution we never really had a Nigerian constitution. It was made by the military fiat. So we need to go down to base on what works well for us in the past. That's all.

A few months ago, the Nigerian government confirmed the outbreak of diphtheria. The NCDC reported dozens of deaths then, mostly children from the disease and even more clinically suspected cases and said it's monitoring situations in Lagos, Kano, Osun and Yobe states. What do you think is driving the resurgence of diphtheria in Nigeria, given that world-wide, diphtheria has reduced dramatically in the past five decades?

We are reaping the result of our poor immunization coverage. Over the years, go and check the records, our immunization coverage has never gone beyond sixty percent. Go and check their record. They will give you some figures they are seventy to eighty but all those data they are not correct. It is better to check the WHO, UNICEF data. It will give you the true situation of things.

So in the last 10 years or more, we've never had coverage of GPG or the petal reaching sixty percent. So let me break it down. Five years ago we had a hundred children; we vaccinated only sixty of them. So what happens as we have forty left. Next year we have another hundred children which should be more than hundred, but let's just assume its hundred. We still vaccinate only sixty percent. You've added another forty

We still vaccinate only sixty percent. You've added another forty to the one you didn't vaccinate. So in the next three, four, five years, you are accumulating children who have not been vaccinated because diphtheria is a vaccine preventable disease.

So when you now add forty over the next five years, we have two hundred children who have not been vaccinated. Of course so when the thing comes, you see a lot of children going down. It's not that we are not getting diphtheria every year but they are occurring one there, two there, three there and our detection system doesn't catch this things so we don't know that this is going on.

The signs are there for us but we miss all those signs. So now we've accumulated and that will have this large number coming out about the same time and because it's coming out in different places at different times, it becomes obvious that there is a big problem going on. All those figures they are giving you - forget it - is probably premised on their simulation than on what exactly is happening.

# So if we upscale our vaccination, we can contain it better?

Of course; I mean go and check the children, the age group of the children who are having the disease now. You will find many of them maybe five years and above or something and also who have never received vaccination. So vaccination is the key. Vaccinate your people.

All other parts of the world have prevented diphtheria occurring. They have mass-vaccinated their people; I mean their children and you rarely find them reporting diphtheria as we are doing now. So it's the failure of our immunization program that is leading us to what we are getting now.

The COVID-19 pandemic exposed the serious inadequacy of Nigeria's domestic vaccine production and this has national health security implications. What kind and scope of intervention should the government deploy to urgently address this gap?

It is not that we have not been making attempts to produce vaccine locally. We were producing vaccine locally before in the 1990's for yellow fever and so many others. But each time we have a change in government policy and one government comes and does not build upon what the others have built, and that's where we are today. A country that in the 1990's was producing

A country that in the 1990's was producing vaccine and no longer producing now is a failure of continuity of government in good programs. You mentioned the words - this a health security issue. A country that cares about the health security of its people will make this a priority no matter which government is coming in.

But that's not what is happening in Nigeria. One government does it another one forgets about it and then that's the end and that's where we are. So it's not as if we have not been producing vaccine in Nigeria before. We have been doing that. We've been producing vaccine regularly since 1924, so how come in the human side we have failed to achieve that. Again I use one word, I think it's were your selfinterest overrides your national interest - you get yourself to where you are right now.

You have been an active player in the lassa fever case management for the last fifty years in Nigeria, what is the government doing wrongly in the management of this disease?

Let me make a small correction. I've not been that active in the management. I've been involved with laboratory diagnosis but there are doctors who are involved in the management. But having said that lassa fever has been with us since 1959. That's almost fifty something years ago and we are still behaving as if it's a new disease every year.

This is because we have not learnt from past lessons. If we learnt any lesson at all, we have forgotten about it. It's a disgrace and a disaster for Nigeria to be every year shouting "oh lassa fever is here, doctors are dying" we've been saying that for the last twenty years or more and we know the number of cases.

We know the seasonality of lassa fever, it occurs throughout the year and we know it comes in dry season, October, November. So we should be prepared for it. But we are as usual a country that only prepares when the battle has started and that's not how it should be.

We should be prepared before the problem like they used to say - you are making ammunition at the war front. When you are making it, the people are going to shoot you and that is what is happening to us now, not just over laser but for every other disease we think we've learnt from COVID-19. We have not. If another disease comes into this country tomorrow we'll be running helter skater like decapitated chicken all over the whole place.



# Polio: Combe Targets 981,710 Children For Vaccination

overnor Muhammad Inuwa Yahaya of Gombe State has initiated the third phase of polio immunization, targeting 981,710 children under five years old to eradicate polio from the state.

Represented by the Commissioner for Health during the launch, Dr. Habu Dahiru, the governor emphasized the importance of this action to eliminate the disease.

Mai Kaltungo, the deputy chairman of the Gombe State Council of Chiefs, along with Engineer Sale Muhammad and the Lamido of Gona, Alhaji Umar Abdulqadir Abdussalam, urged community leaders, parents, especially women, and caregivers to support health workers by ensuring their children receive vaccination. They highlighted how immunization would bolster children's immune systems against deadly illnesses.

Dr. Abdulrahman Shu'aibu, the Executive Secretary of Gombe State Primary Health Care Development Agency (PHCDA), detailed that the vaccination program covered polio,

#### deworming, malaria, and more to protect children's health.

Meanwhile, the Emir of Kano, Alhaji Aminu Ado Bayero, advocated for enhanced access to vaccinations to strengthen comprehensive health coverage during a visit from the New Incentives-All Babies Are Equal (NI-ABAE) initiative management.

In response, the emir pledged complete support and encouraged a respectful and collaborative approach with various stakeholders in expanding vaccination efforts. Zaharadden Sabi'u, NI-ABAE's Senior Stakeholder Manager (SSM), highlighted their efforts to address the lack of transport fare hindering parents and caregivers from taking their children for immunization.

Sabi'u detailed how NI-ABAE provides cash incentives totaling N6,000 over six visits to caregivers bringing their children for routine vaccinations against fatal childhood diseases. He noted that the program, operational across 41 LGAs and over 1,000 public primary healthcare facilities in Kano, has disbursed N528 million to caregivers and enrolled over 250,000 children for vaccination since its launch in February.



# ACHIEVING ZERO GRAZING

igeria is an agrarian country, with 87% of the total population directly and indirectly involved in agriculture.

The country is also adorned with an array of different agro-ecological zones comprising Sahel Sudan and guinea savanna in the North. While the South has the mangrove, rainforest and the derived savanna.

Nigeria has abundance of livestock population estimated at more livestock than the human population. The livestock sub- sector has contributed greatly to the GDP of Nigeria, through the exportation of hides and skins and other animal by- products.

Nigerians are also "natural meat lovers". Most Nigerians do not take a meal without meat and it's common in Nigerians to see a single pot of soup with pieces of meat like - lamb, goat, chicken, snail and other orishirishi combined.

However, the pattern of raising livestock - nomadic pastoralism - has since become rudimentary and archaic.

The constant movement of cattles from Borno to Port Harcourt and Sokoto to Lagos on annual basis has significantly reduced the by-products of the cattle. This applies particularly to dairy and beef, in addition to the myriad of security challenges all over the country.

The constant farmers versus pastoralist conflicts include cattle

rustling and other negative vices keep on increasing as a result.

The modern method of grazing all over the world now is termed "Zero Grazing." Instead of moving with the animals to look for food and water, the animals are now stationed "in-situ," in one place and their feed and water served to them.

A typical zero grazing concept involves a piece of land, grasses (pastures and forages).

A permanent source of water, a shed for protection from the sun and rainfall are also key related factors.

Another is a special shed for delivery and calving; also another for pregnant cattles as well as a vet clinic with a veterinary doctor on stand-by.

As part of the farm's corporate social responsibility, a school, hospital and a market should be provided for the workers tending to these animals.

Security is another point of attention. The area should be well secured to prevent harm to both the livestocks and its tenders.

One major challenge is the lack of access roads to the farmlands or pens. This should be improved on for commuters to include the farmers, livestocks as well as distributors and buyers.

The above scenario will make the cows produce more dairy products such as milk, yield better quality of beef and also increase the calving ratio.

The zero grazing policy if well-articulated, will end the constant farmers /pastoralists clashes.

In Nigeria, The ARCN has about 18 Research institutes, Oil palm Research Institute at Benin, Institute of Agricultural Research (IAR), Samaru Zaria, National Institute for Horticultural Research, Jericho Ibadan, Rice Research Institute Badaggri.

Roots and Tuber Crops Research Institute,

Umudike etc.

However, there is a big disconnect between the Research Institute and the real farmers on the field.

Similarly, with about 5 Federal Universities of Agriculture, several federal, state and public universities, polytechnic and colleges of education and the massive research conducted ends up on the shelves of scholars.

The rural farmers, through subsistence need all the information they can in Agricultural inputs, planting modules, weather data forecasts, impending pests, diseases, grasshoppers and quell birds infestation etc

Introduction

he third AfSNET Conference was held on 18 November 2023 in Cairo, Egypt, as a side event of the IATF2023 Trade and Investment Conference. The theme of the conference was "African Sub-Sovereign Governments Network as a Vehicle for Promoting Intra-African Trade and Investment". The Conference was co-hosted by the African Export-Import Bank (Afreximbank) in collaboration with the United Cities and Local Governments of Africa (UCLGA).

The conference aimed to provide a platform for African sub-sovereign governments, such as states, regions, provinces, counties, municipalities, and cities, to share their experiences, challenges, and opportunities in promoting intra-African trade and investment.

The conference was attended by more than 250 participants, including governors, mayors, ministers, business leaders, financial institutions across the continent.

# Objectives of the 3rd AfSNET Conference

The main objective of the conference is to strengthen the institutional framework established between Afreximbank and UCLG Africa and to facilitate increased collaboration in the promotion of trade, development and investment initiatives within the context of AfCFTA.

Specifically, it will aim to:

i) Promote dialogue and advocate for the smooth and efficient implementation of the AfCFTA

Prof. Peter Nyongo, Governor, Kisumu County, Kenya, who highlighted the potential of Kisumu County as a gateway to the East African Community and beyond, by leveraging its strategic location, natural resources, and cultural diversity. He also emphasized the need for sub-sovereign governments to align their policies and plans with the national and continental agendas.

• H.E. Oluwaseyi Makinde, Governor, Oyo State, Nigeria, who outlined the steps taken by his state to boost trade and investment, such as establishing an economic advisory council, launching a one-stop shop for investors, and creating a special economic zone. He also stressed the importance of sub-sovereign governments in addressing the social and environmental impacts of trade and investment, such as poverty, inequality, and climate change.

• H.E. Senator Prince Bassey E. OTU, Governor, Cross River State, Nigeria, who showcased the achievements of his state in attracting and retaining investors, such as building a deep seaport, an industrial park, and a garment factory. He also called for more collaboration and integration among subsovereign governments, especially in the areas of infrastructure, energy, and transportation.

The second panel discussion focused on the need and modalities for setting up a subsovereign network to enhance intra-African trade and investment. The panelists agreed that there was a strong rationale for establishing such a network, as it would enable sub-sovereign governments to share best practices, exchange information, access resources, and advocate for their interests. They also discussed the possible objectives, membership, structure, and functions of the network, as well as the role of Afreximbank and other development partners in supporting its formation and operation.

The panelists for the second session were:

• H.E. Godwin Obaseki, Governor, Edo State, Nigeria, who proposed that the network should aim to create a common market for sub-sovereign governments, by harmonizing standards, regulations, and policies, as well as facilitating trade facilitation, dispute resolution, and market access. He also suggested that the network should have a rotating leadership, a secretariat, and a steering committee, as well as





thematic working groups and regional chapters.

A poignant quote by H.E. Godwin Obaseki, Governor of Edo State, Nigeria, underscored the significance of sub-sovereign governments: "There are no federal citizens." This statement highlighted the crucial role of sub-sovereign entities in directly connecting with and impacting the lives of the people.

• H.E. Mbarka Bouaida, President of the Association of the Regions of Morocco, who shared the experience of her association in promoting regional development and decentralization in Morocco, as well as its involvement in various regional and continental initiatives, such as the African Peer Review Mechanism, the African Charter on Decentralization, and the Covenant of Mayors in Sub-Saharan Africa. She also recommended that the network should adopt a bottom-up and inclusive approach, involving all levels and types of sub-sovereign governments, as well as other stakeholders, such as the private sector, civil society, and academia.

H.E Charles Soludo, Governor of Anambra State, Nigeria, was represented by Christian C. Udochukwu, the Commissioner for Industry. Mr. Udochukwu conveyed Anambra's commitment to leveraging its position as an entrepreneurial hub, outlining the state's strategic initiatives to become a leading trade center, not just within Nigeria but across the African continent, in alignment with the African Continental Free Trade Area (AfCFTA). He highlighted Anambra's focus on harnessing technological advancements, emphasizing the state's ambition to foster tech startups and develop e-commerce platforms. These initiatives are aimed at tapping into broader African markets, positioning Anambra as a key player in the digital economy under the auspices of the AfCFTA

• H.E. Dauda Lawal, Governor, Zamfara State, Nigeria, who highlighted the challenges faced by his state in terms of insecurity, poverty, and underdevelopment, as well as the efforts made to overcome them, such as launching a peace and reconciliation initiative, implementing a social protection program, and developing a mineral resources strategy. He also expressed his interest in joining the network and learning from the experiences of other sub-sovereign governments, especially in the areas of peacebuilding, governance, and resource management.

• Mr. M'Houdine Mohamed Zeine, Special Adviser to the Governor of Grande Comore (Ngazidja), Union of Comoros, who presented the specificities of his island, which is part of the Union of Comoros, a federal state composed of four autonomous islands. He also explained the challenges and opportunities of being an island state, such as the vulnerability to natural disasters, the dependence on maritime transport, and the potential for tourism and fisheries. He also expressed his willingness to participate in the network and benefit from the support of Afreximbank and other partners.

Mr. Humphrey Oriakhi, Managing Director & Chief Executive Officer, PAC Holdings, who represented the private sector perspective and underscored the role of sub-sovereign governments in creating a conducive business environment, by providing infrastructure, security, and incentives, as well as reducing bureaucracy, corruption, and red tape. He also highlighted the benefits of the network for the private sector, such as providing a platform for dialogue, partnership, and advocacy, as well as facilitating access to markets, finance, and technology.

Fight Against Hepatitis: Gov Sule Receives Continental Recognition

he Nasarawa State Government has received an award of recognition for outstanding contribution to the elimination of viral hepatitis in Africa.

The award was presented to the Nasarawa State Governor, Engineer Abdullahi Sule, during this year's African Hepatitis Summit in Abuja, recently.

According to Dr. Danjuma Adda, President, World Hepatitis Alliance, the award was to recognize champions whose efforts and contributions helped saved the lives of several people that would have died as a result of hepatitis.

Egypt, Rwanda and Nasarawa State were all honoured and recognized as champions in the fight against hepatitis in Africa.

Speaking shortly after receiving the award, Engineer Sule said his administration was

prompted to make inroads in the fight against hepatitis because of the high prevalence of the disease in the country and particularly in Nasarawa State.

The Governor explained that some of the decisions taken by his administration leading to the recognition were actions taken out of panic and as a fallout of the commitment as a result of the alarming data which was indeed frightening.

"When we actually started in Nasarawa, we never had any slightest idea whatsoever that our humble efforts and initiative would earn us an award on a day like this. We started purely from our commitment to provide leadership and our believe not money. if, indeed, is the issue, Nasarawa State would not be here," he said.

The Governor disclosed how he commissioned a consultant to undertake an independent assessment of the opportunities and challenges confronting Nasarawa State ahead of his joining politics to contest for the position of the Governor and how the survey discovered the startling prevalence of Hepatitis C, with the state recording 13.2 prevalence way above the national average of 1.1 percent.

"Some of the actions that we took that brought us to today that we are getting an award, we took some of these actions because of the panic that

we had. And so we became committed because the data was alarming and it was frightening," he said.

He added that, the study conducted showed that while Africa has the prevalence rate of 4.6 percent, with Nigeria recording 8.1 percent for Hepatitis B, Nasarawa has 11 percent which was even above the national average.

"That was what we got from the studies. As if that was not bad enough, Hepatitis C, whose prevalence is 1.1 percent, but in Nasarawa, it was 13.2 percent. These were the realities that we faced. And I was shocked to learn that one of the reasons was awareness. As simple as awareness. That awareness in Nasarawa State was less than 25 percent.

"I am happy to tell you that awareness today in Nasarawa State, especially at the rural areas, is 80 percent," Engineer Sule stated.

He used the opportunity of the event to highlight on other key initiatives taken by his administration to tackle the menace of hepatitis and other health challenges in the state.

"By the time we carried out

the baseline studies in the area of health, we now came head-on with the realities of our challenges in the state. We needed to upgrade and equip our primary, secondary, and tertiary health care facilities. We went ahead with the little resources at our disposal, equipping, renovating, and staffing the various categories of health care facilities in the state.

"We now have to look at a project that was started by the previous administration. At the time, it was just the civil works that

were done. That is the Infectious Diseases Diagnostic and Research Center. We completed it, and in relation to that, we went ahead and equipped it and staff it for it to start working.

"But we also went ahead and established one of the best things that ever happened to Nasarawa State in the area of health. That is the health insurance. I think my deputy as a doctor has so much impact on whatever we did in the area of health.



**KDSG Reaffirms** Commitment to Free Primary, Secondary, **Technical** Education

he Kaduna State Government has reaffirmed its commitment to providing every child resident in the state free primary, secondary and technical/vocational education. An extraordinary meeting of the Kaduna State Executive Council, held on Monday, 7th November 2022, described the provision of free education for the first 12 years of schooling as a legacy achievement of the State Government. The Council meeting, chaired by Malam Nasir El-Rufai, stated that free education is the pillar of the Kaduna State Government's commitment to human capital development and social mobility for the children of the most vulnerable residents of the state.

With careful implementation since 2015, this policy guarantees every child access to education from the first year of primary school to the completion of the final year of senior secondary school or technical/vocational school. Free education, up to the completion of senior secondary school, reflects the government's abiding belief in promoting equality of opportunity and expanding access to education as a lever of social mobility.

KDSG's deep conviction that government has an obligation to provide free education up to senior secondary level or its equivalent has been expressed in legal provisions that make it compulsory for every child to go to school for 12 uninterrupted years since the financial obstacle represented by school fees has been removed.

The extraordinary meeting of the Kaduna State Executive Council discussed a memo from the Ministry of Education on sustainable funding for the maintenance of school facilities. The Executive Council stated that the Kaduna State Government will continue to faithfully implement the free senior secondary education policy and to discharge the primary responsibility for its public schools. The Council recalled that in 2015 the government explicitly banned payment of PTA fees and other levies in public schools in order to ensure that the free education policy actually delivers education without burdening parents with hidden fees or levies.

Therefore, the Council observed that the circular issued by the Ministry of Education to school principals on collection of nominal fees is not consistent with government policy, and is thus invalid. The circular from the Ministry of Education to the heads of schools, dated 1st November 2022, is therefore

rescinded with immediate effect, and all monies that may have been collected should be refunded forthwith.

The State Executive Council has noted that community participation and ownership in the

administration of public schools is what led to the creation by law, of School Management Boards School-Based and Management Committees with membership drawn from all concerned stakeholders.

Accordingly, and noting that some alumni associations, community groups, charities and persons of means may be interested in further supporting particular schools, the Council directed the Ministry of Education to develop a suitable framework to guide school heads, parents, old students' associations, communities and other donors that may want to contribute to the development of any public school in the State. This framework is necessary in the interest of accountability and transparency. Such a framework will be widely debated by stakeholders

and approved by the State Executive Council before subsequent dissemination as an official directive to the Principals and Heads of Schools.

## Climate Impacts, Policies, and Actions at the Subnational Level In Nigeria

## 1. Introduction

Climate change is one of the biggest development challenges facing Nigeria today. Climate change impacts such as flooding, desertification, drought, erosion, and sea level rise are destroying ecosystems, livelihoods and pushing many Nigerians into poverty. The Nigerian government has committed to achieving net zero carbon economy by 2060 and has recently signed a National Climate Law which establishes a National Council on Climate Change (NCCC).

The federal government has a national climate policy, a Nationally Determined Contribution (NDCs) and some flagship projects such as the Great Green Wall, and the Nigeria Erosion and Watershed Management Project (NEWMAP) to address climate change. However, most climate change activities and initiatives have focused at the federal level, with very limited attention paid to the state of climate change policy, plans, and investment at the state level. This is a big gap considering that the impacts of climate change are mostly borne by states and that policies and actions at the subnational level are critical to addressing climate change and attaining Nigeria's net-zero target. The current situation calls for an improved understanding of the climate change governance landscape at the subnational level including the level of awareness of climate change, the extent and range of policies, and the degree of implementation.

The study was conceived as a first step towards raising awareness on climate action at the subnational level in Nigeria and facilitating improved climate change action and resilience among the state actors. It aims to assess the level of climate change awareness and action in the 36 states of the Federation and the FCT. The results of this effort at highlighting climate change actions, awareness, and policies across Nigerian states are expected to help guide future actions particularly policy designs and implementations across the 36 states and the FCT.

This study underscores the importance of understanding local challenges, formulating effective policies to address local challenges, and coordinating climate action across the tiers of government. Successful approaches and experiences can be shared, replicated, and scaled up to benefit other regions.

## 2. Research Approach and Methodology

## 2.1 Methodology


The research approach comprised two key methods as follows:

- Desk review include scanning of the internet, literature, policies, secondary data review, and the creation of a reference list for key documents. The research team used this method to assess states' online visibility, presence of climate policy and action plan, and climate change appropriation in state budgets.
- The second was using a survey tool to collate feedback on the perceptions of stakeholders on a number of issues including (i) respondents' knowledge of climate change; (ii) respondents perception of the level of climate awareness of the people and governments of their states; (iii) respondents perception of climate activities, plans and investments in their states, among other questions.
- The survey tool used was a simple questionnaire developed with Google Forms and circulated through the Climate Desk Officers of the 36 states as well as directly to other civil servants, climate organizations, and selected members of the general public who were identified as having some interest on climate change. A total of 1,306 participants responded to the survey (see section 2.1 below for the demography of the survey respondents).
- Results from the two sources were combined to produce a picture of the most significant climate impacts in the states.



## 2.2 Demography of Survey Respondents

A total of 1,306 participants responded to the survey. The distribution of these respondents, ranged from the state with the lowest respondents (Katsina with 10 respondents) to the state with the highest respondents (Taraba with 118 respondents).

The gender distribution, age group, level of education and employment institution of the respondents are presented in the graphs below. More males responded to the survey, with about two-thirds (72.7%) of the respondents being male and about one-third (27.4%) being female. See Figure 2below.




Figure 2: Gender Distribution of Survey Respondents




Figure 3: Age group of respondents.

People within the age groups of 26 – 45 years made up about 60% of the respondents. Those above 60 years were the lowest percentage of respondents comprising about 2% of the total. See Figure 3 below.




Figure 5: Employment institution of respondents.

The majority of the respondents to the survey were civil servants (52.5%). Roughly 25% of the respondents were from the private sector and the rest (23%) were from NGO and CSO institutions. See Figure 5 below.

#### **Employment Institution**

## Level of Education completed




Figure 4: Level of education of respondents.



## 3: CLIMATE IMPACTS, POLICY AND ACTIONS (DESK REVIEW)

This section presents the results of the desk review. As previously indicated this involved a review of websites, newspapers, published literature, and budgetary provisions of the states. The results gathered were without recourse to the results of the survey we administered.

## 3.1 Online Visibility and Publicity on Climate Change

We measured the online visibility of the states on climate action using the criteria in the table below






Based on the above criteria, the states that scored high include Oyo, Ogun, Lagos, Taraba, Plateau, Lagos. For the rest of the scores please see the figure below.



#### 3.2 **Climate Impacts and Vulnerabilities**

As might be expected, climate impacts vary across the states. States within the same or similar ecological zone share broadly the same climate impacts and vulnerabilities. Flooding is a dominant climate impact in the north-central states of Benue, Kogi, Kwara, Nasarawa, FCT, and Niger. Niger State also experiences drought, and this can be linked to its proximity to the northwest. The main impact of climate change in the North is desertification, land degradation, and drought. For the south, the major types of climate change impacts are flooding, gully and coastal erosions which have led to loss of arable land. It is important to point out that for the entire country, temperature changes are constant climate change impacts. This has resulted from an increase in global warming, and of course irregular rainfall patterns. The map below shows the Climate Impact, as spread across the entire subnational.





#### 3.3 Climate Policy

Only seven (7) states have climate policy documents that could be found online. These include Cross River, Delta, Ebonyi, Lagos, Osun, Rivers, and Yobe. Eight (8) states seems to have climate policy or some related documents that which are not fully finalised or adopted. These include Akwa-Ibom, Anambra, Enugu, Kaduna, Kogi, Nasarawa, Plateau, and Ondo.




Figure 8: The prescence and otherwise of climate policy in the states and FCT.

However, many states have some form of climate-related policies, such as polices on afforestation and waste management. Examples include Kogi State whose Ministry of Environment has an Environment Sector Policy, as captured in theKogi State Medium Term Sector Strategy. Some of the goals include enhancing forestry projects, accelerating forestry mapping, sustaining environmental development, erosion management and flood control, and relocating community from water channels; amongst others. There are several other examples. Kwara State has an Afforestation Policy of "cut one tree and plant five", and for new sites being developed, a number of trees must be planted. Enugu State has a Waste Management Policy.

Anambra State has the Anambra State Erosion, Watershed, and Climate Change Agency; Sokoto State has the Orchard Programme; Kaduna State has a range of policies including on the reclamation and rehabilitation of degraded lands, biodiversity conservation and eco-tourism, and waste management. Kano State has a pollution law and there are moves in recent years to enact a Forestry Law.

Delta State has mandated climate change considerations in every

project and economic planning andset up a climate change governance framework.

Bayela State has mandated the State's Environmental and Sanitation Authority to recycle and manage effluent discharged from industrial and domestic wastes. Ondo State has an Environmental and Social Management Plan. Edo State has launched its Flood and Erosion Watershed Management Agency (FEWMA) to address the issue of flooding and reclaim lands degraded by erosion

While what we highlighted above are state-specific policies (or lack of policies), it is necessary to flag that for the North, there is the Great Green Wall Initiative which covers eleven states viz: Adamawa, Borno, Kano, Katsina, Jigawa, Sokoto, Yobe, Zamfara, Bauchi, and Gombe. There is also the recently launched World Bank-supported ACReSAL project focused on the entire nineteen states of the north. The NEWMAP is aimed at rehabilitating degraded lands and reducing erosion and climate vulnerability in targeted areas. NEWMAP was originally implemented in seven States comprising Abia, Anambra, Cross Rivers, Ebonyi, Edo, Enugu and Imo. Following its success, the project was extended to several other states in the North.

Twelve states and the FCT have climate change action plans. These include Nasarawa, Yobe, Jigawa, Kaduna, Anambra, Ebonyi, Bayela, Cross River, Rivers, Lagos, Osun and Ondo. Lagos State has the most ambitious Climate Action Plan (2020-2025) to transform "the State into emission-neutral city by 2050."3 Rivers State on its own part is the first state in Nigeria to have a Climate Change Act4. Ebonyi State also has a Climate Change Law and a Climate Change Action Plan which specifically targets climate smart agriculture. It recommends the development and implementation of new agronomical interventions, provision of technical assistance/support for investors through extension services; facilitation of the introduction of buy-back programme to smallholder/ commercial farmers; and effort to scale up climate finance among several other actions.




Figure 9: Presence or otherwise of Climate Change Action Plan in the 36 States and FCT

## 3.5 Climate Change Appropriation

The 2023 budget of the 36 states were revied to see the extent to which specific provision is made for climate action in these states. We found that found that a large number of States make provisions for climate-related activities and procurements. These provisions range from erosion and flood control provisions, through tree planting and provision of solar-powered water sources and electricity, improved agricultural systems, pollution control to waste management; including Agro - Climate Resilience in Semi - Arid Landscapes (ACRESAL) Projects in the Northen States. In the longer version of this report, we provide a breakdown of the budgetary allocations of State Governments for climate-related projects, in their 2023 budgets. However, most states do not make a particular appropriation specified for climate change; the states found to have a clearly labelled Climate Change Budget Allocation for climate project programe and activities includes Nasarawa, Plateau, Yobe, Jigawa, Anambra, Ebonyi, Ondo, and Ogun.

## Taraba Gov Moves To End Water Crisis In Jalingo

overnor Agbu Kefas has inaugurated a committee to look into the water crisis crippling socio-economic activities in Jalingo, the state capital and environs following a last week report by Arewa PUNCH.

The state government obtained a N7.9bn loan from the African Development Bank to tackle the water challenge but which had shown no results.

Following reports on the water scarcity in Jalingo and the suffering the residents of the state are going through to source for potable drinking water, the government acted swiftly by inaugurating the committee on water resources.

In a statement released in Jalingo and signed by the Chief Press Secretary to the Governor, Mr. Yusuf Sanda, Governor Kefas mandated the committee to study and appraise the activities of Taraba Water and Sewerage Company to determine its ability to provide water in Jalingo and other areas.

The Committee, which is headed by Mr Yakubu Maikasuwa (SAN) who incidentally is the Attorney General and Commissioner for Justice as Chairman, has Engr. Naomi Tanko Agbu, Commissioner for Energy and Economic Development, and Comrade Julius Peter, Commissioner for Rural and Urban Development as members.

Other members of the committee include: Mr. Daniel Ishaku, Commissioner for Water Management and Aquatic Affairs, and Dr Sarah Enoch Adi, Commissioner for Finance, while Mrs Patricia Danna, Permanent Secretary, Career Management is to serve as Secretary.

The Governor in the statement mandated the committee to look at the revenue inflow of the agency and consider the self-sustainability of the agency or advice on full or partial commercialisation.

The committee, which has two weeks to submit its report, is also mandated to proffer any suggestion that will ensure seamless provision of potable water in the state capital and its environs.

Reacting to the constitution of the committee, Mr. Wole Ayodele, a public affairs analyst, commended Kefas for his prompt response to the challenge of water scarcity in Jalingo after the Arewa PUNCH report.



# Sustainable Devt: Niger State Govt signs \$65m MoU with Alternative Bank



he Niger State Government has signed a Memorandum of Understanding with the Alternative Bank on sustainable development of the State.

The MOU, which is expected to cover Education, Health, Agriculture, Transportation, Energy, and infrastructure among others was signed in Abuja recently.

Governor Mohammed Umar Bago who signed on behalf of the State Government, expressed delight with the financial institution for its readiness to partner the State Government, emphasizing that the move would allow the state harness its agricultural potential.

Governor Umaru Bago observed that the state has not been able to cultivate up to 1% of its arable land stressing that the State government intends to procure some earth moving equipment like Caterpillar, bulldozers, payloaders on a long lease to prepare land for the cultivation of about 4.5m hectares in the next ten years.

He further announced that the State was discussing with Almarai; a Saudi multinational dairy company for the production of Alfalfa plant due to the economic value of the plant.

The Executive Director of the Alternative Bank, Garba Mohammed who signed on behalf of the financial institution, explained that an international partner had already expressed willingness to invest 65 million dollars to set up a sugarcane plantation on five hectares of land in Niger State, with an estimated output of 50,000 tonnes of sugar annually.

He said when established the sugarcane plantation would create over 4,700 job opportunities, production of methanol, and provision of 40,000 tonnes of animal feeds and generation of 11mgwt of electricity.

Governor Soludo inks infrastructure deals with Afreximbank

igeria's Anambra State Investment Promotion & Protection Agency (ANSIPPA) signed various project agreements with African Export-Import Bank (Afreximbank) in November.

The deals were signed at the 2023 Intra-Africa Trade Fair (IATF) in Egypt in early November.

The biggest agreement involved ANSIPPA and the states of Ogun, Oyo and Ekiti signing a framework agreement with Afreximbank and Nigeria's Access Bank for the establishment of a Naira 500 billion (US\$640 million) global concessionary infrastructure financing facility.

The fund will support investments targeted at transforming the states into manufacturing and logistics hubs and growing the export of finished and semi-finished products.

"Ultimately, our objective is to export finished and semi-finished products to various countries across the African continent,"

said Ogun State Governor Dapo Abiodun, commenting on the agreement.

In addition, ANSIPPA signed an agreement with Afreximbank for the provision of capital raising advisory services amounting to US\$200 million for the development of critical projects such as the Anambra mixed-use industrial city, Anambra export emporium and the intra-city rail masterplan.

Afreximbank signed a further agreement to provide the Anambra government with financial advisory services for

the development of an operational and governance framework for the US\$250 million Anambra Diaspora Fund.

Meanwhile, ANSIPPA inked an agreement with ARISE Integrated Industrial Platform

(ARISE IIP) to advance discussions on becoming a potential joint venture partner for the planning, design, promotion, development and management of the Anambra Industrial City project. ARISE IIP agreed in principle to jointly develop the industrial park within the city.

Also known as Ikenga Industrial City, Anambra Industrial City is a mixed-use development planned to feature an industrial zone, commercial and retail spaces, research and development institutions, residential areas and recreation centres. It will have special economic zone (SEZ) status and will also promote the use of alternative energy sources. A memorandum of understanding (MoU) was signed with India's Mahendra Consulting Engineering in early September at the Anambra Investment Summit 2023 to design the project.

At the same summit, Canada-based CPCS signed a MoU for the delivery of the intra-city rail masterplan. The railway is intended to connect the cities of Awka, Ekwulobia, Nnewi and Onitsha.

Afreximbank recently signed another memorandum of agreement (MOA) in Nigeria with King's College London for a scoping study to determine the feasibility of jointly establishing a medical and nursing school alongside the African Medical Centre of Excellence (AMCE) in Abuja.

Afreximbank is developing the AMCE, which is at an advanced stage of development and set to open in early 2025. The 500-bed quaternary medical facility will provide a full range of medical services including diagnostics, nuclear medicine, surgery, and post-surgical care. The AMCE will operate in collaboration with the King's College Hospital in London.
