

A BILL

FOR

A LAW TO AUTHORISE THE ISSUE OUT OF THE CONSOLIDATED REVENUE FUND OF THE GOVERNMENT OF DELTA STATE OF THE SUM OF ONE HUNDRED AND SEVENTY-TWO BILLION, ONE HUNDRED AND FIFTY-FOUR MILLION, FOUR HUNDRED AND EIGHTY-FOUR THOUSAND, THREE HUNDRED AND FOURTEEN NAIRA AS RECURRENT EXPENDITURE AND THE SUM OF TWO HUNDRED AND TWENTY-THREE BILLION, THREE HUNDRED AND TWENTY MILLION, NINE HUNDRED AND NINE THOUSAND, THREE HUNDRED AND FIFTY-FOUR NAIRA AS CAPITAL EXPENDITURE FOR THE SERVICES OF THE YEAR ENDING ON THE THIRTY-FIRST DAY OF DECEMBER, 2020 AND TO APPROPRIATE SAME FOR THE PURPOSES SPECIFIED IN THE LAW.

BE IT ENACTED by the Delta State House of Assembly as follows:

1. This Law may be cited as the Appropriation Law, 2020 and shall come into force on the 1st day of January, 2020.

2. The sum of One Hundred and Seventy-Two Billion, One Hundred and Fifty-Four Million, Four Hundred and Eighty-Four Thousand, Three Hundred and Fourteen Naira shall be appropriated from the Consolidated Revenue Fund of the State as Recurrent Expenditure during the year ending on the 31st day of December, 2020 for the services set out in the First Schedule to this Law.

Appropriation of

as Capital
Expenditure.

3. The sum of Two Hundred and Twenty-Three Billion, Three Hundred and Twenty Million, Nine Hundred and Nine Thousand, Three Hundred and Fifty-Four Naira shall be appropriated from the Consolidated Revenue Fund of the State as Capital Expenditure during the year ending on the 31st day of December, 2020 as set out in the Second Schedule to this Law.
