## A Law to provide for the issue and Appropriation from the Consolidated Revenue Fund for Katsina State of the sums to meet the Expenditure for the purpose therein specified



Katsina State of Nigeria Law No. 1 ... 2022

> Date of commencement

BE IT ENACTED by the House of Assembly of Katsina State of Enactment Nigeria as follows:

This Law may be cited as the Katsina State Appropriation Short title Law, 2022.

This Law shall be deemed to have come into operation on Commencement 2. the 1st day of January, 2022.

The Accountant General of Katsina State may on the warrant of the Commissioner of Finance, issue from the Consolidated Revenue Fund of Katsina State during the year ending 31st day of December, 2022, any sum not exceeding the sum of THREE HUNDRED AND TWENTY THREE BILLION, TWO HUNDRED AND NINETY SIX MILLION, TWO HUNDRED AND TWENTY THOUSAND, NINE HUNDRED AND SIXTY ONE NAIRA ONLY Being the total amount set forth opposite to the Heads of Expenditure specified in the Schedule to this Law.

Expenditure of the N323,296,220,961 authorized out of Revenue Fund

The sum mentioned in Section 3 of this Law shall be Compliance with appropriated for the purpose and in the manner expressed in the Schedule to this Law.

## **EXPLANATORY NOTE**

(This note does not form part of this Law and has no legal effect)

The purpose of this Law is to provide funds for the services of Katsina State of Nigeria for the year ending 31<sup>st</sup> day of December, 2022. The amount for Recurrent Expenditure is ONE HUNDRED BILLION, ONE HUNDRED AND ELEVEN MILLION, FIVE HUNDRED AND SIXTY THOUSAND, THREE HUNDRED AND FIFTY NINE NAIRA (N100,111,560,359.00) and Capital Expenditure is TWO HUNDRED AND TWENTY THREE BILLION, ONE HUNDRED AND EIGHTY FOUR MILLION, SIX HUNDRED AND SIXTY THOUSAND, SIX HUNDRED AND TWO NAIRA (N223,184,660,602.00) ONLY. Giving a Total expenditure of THREE HUNDRED AND TWENTY THREE BILLION, TWO HUNDRED AND NINETY SIX MILLION, TWO HUNDRED AND SIXTY ONE NAIRA (N323,296,220,961.00) ONLY.
