

## **About the Leadership Challenge**

The PHC Leadership Challenge was put together to accelerate the implementation of the Seattle Declaration made by Governors in 2019 and to catalyze renewed political commitment of all Governors to improve PHC outcomes at scale. The Challenge provides an opportunity for the 36 states and FCT to equitably compete within their respective geopolitical zones for an annual best performing and most improved awards in PHC delivery. The Challenge is being implemented in partnership with National Primary Health Care Development Agency, UNICEF and funded by Bill and Melinda Gates Foundation and Aliko Dangote Foundation.
