# **NFIU Guidelines: So Unconstitutional**

he Nigerian Financial Intelligence Unit (NFIU) recently issued Guidelines to anti-corruption agencies, the Banks and other financial institutions in Nigeria, which Guidelines were to come into effect June 1, 2019. The Guidelines provide inter alia that:

1. No transaction should be allowed on the State and Local Government Joint Account without first paying to the Local Governments, all sums due

to them.

2. The amount standing to the credit of local government councils of a State

shall be distributed among the local government councils of that State and

not for any other purposes.

3. State Joint Local Government Account shall be reinstated as a Collection

Account

4. A minimum of N500,000 (five hundred thousand Naira) cash daily withdrawal limit from every Local Government Account and all subsequent

withdrawals must be by approved cheques or electronic payment

to promote registered transactions by all the local governments.

# Powers of the NFiu under the NFiu Act, 2018


Nothing in the NFIU Act confers on the NFIU the power to prescribe to the States the manner in which Local Government funds can be disbursed. Any act of the NFIU which is outside its specified functions in the NFIU Act means that the Unit is exceeding its legitimate powers. In the light of the above, the NFIU has no legitimate powers to prescribe to States, or financial institutions the way Local Government Council funds are to be disbursed, neither can they prescribe to the Local Governments the manner of withdrawal of funds in the

bank accounts belonging to Local Government Councils.

The Constitution of the Federal Republic of Nigeria in Section 162 (7) provides that Each State shall pay to Local Government Councils in its area of jurisdiction such proportion of its total revenue on such terms and in such manner as may be prescribed by the National Assembly.

(8) The amount standing to the credit of Local Government Councils of a State shall be distributed among the Local Government Councils of that State on such terms and in such manner as may be prescribed by the House



of Assembly of the State.

A study of the NFIU Act, particularly Sections 3 and 4 will reveal that the functions and Powers of NFIU revolve around requesting, receiving, analyzing and disseminating financial intelligence reports on money laundering, terrorist financing and other related information to law enforcement, security and intelligence agencies and other relevant authorities. This functions, duties and powers relate generally to the storage, use and management of financial intelligence data/information, as it relates primarily to combating money laundering, the financing of terrorism, proliferation of weapons of mass destruction and associated offences.

The power to give the directive which the NFIU purports to issue in its Guidelines resides in the National Assembly and the State Houses of Assembly of the 36 States of the Federation and in doing this, the NFIU has acted in excess of its powers and in complete disregard to the constitution of the country.

In effect, the purported adoption of the motion in respect of the NFIU Guidelines by the Senate has no bearing in law. The Guidelines remain unconstitutional, null and void until properly passed into law by both Chambers of the National Assembly and thereafter adopted by the House of Assembly of each State.

# Nigerian Governors Spouses Forum

ecently, the NGF induction of new and returning governors which held in Abuja delivered a new initiative bringing international personalities to hobnob with the governors as well as their spouses. The event, which had in attendance the 36 state governors also attracted the country's First Lady Mrs Aisha Buhari and her predecessors to rob minds with the governors' spouses. The sharing of experiences and narratives gave verve to their reawakening to look deeper at their pet projects with a view to taking the welfare of their people, especially women and children more seriously than they ever did in the past. The arrowheads of this new thinking, of course included Mrs Bisi Adeleye Fayemi.

Incidentally, the induction ceremony, culminated in the official launch of the Nigeria Governors' Spouses Forum (NGSF), which had been in existence but in partial abeyance.

Mrs Asmau Abdulaziz Yari Abubakar, wife of the former Governor of Zamfara State and chairman of former Chairman of the NGF, Abdulaziz Yari Abubakar, vacated the seat following the end of the tenure of her husband. However, the emergence of Kayode Fayemi of Ekiti State as the new chairman of the forum automatically makes his wife, Mrs Bisi Adeleye Fayemi as the chairlady of the newly berthed NGSF.

Mrs Bisi Fayemi is a British-born Nigerian, writer and feminist, who was born on 11th June, 1963 in Liverpool, United Kingdom. She is a graduate of Obafemi Awolowo University (OAU) Ile-Ife, sincerely an indication that in spite of her privileged background her heart remains not abroad but at home.

Mrs Fayemi is the co-founder of the African Women's Development Fund, which is the first pan-African foundation to support the work of women's rights organisations in Africa.

The new mantle of leadership, which requires the new NGSF Chairlady to reposition the role of women and children in states, will witness numerous improvement and achievement due to Mrs Fayemi's robust activism, creativity and wealth of experience.

This is the realistic expectation, even though the role of Governors' spouses has changed since the 90s and evolved considerably to a people focused affair. Governors spouses are now involved in political campaigns, running the domestic affairs in the government houses and championing social causes such as excursions, visitations, and sometimes they represent the governor at occasions. Governors' spouses have become so visible that they now publish their own memoirs which are viewed as not just additional information but very relevant anecdotes about their husbands' lives in office.

This is simply because the public is interested in their spouses' pet projects, even long after they have left office as their projects speak for them long after they are gone, when posterity sits in judgement. It is because of this that the NGSF under Mrs. Bisi Fayemi will be expected to undertake the following:

Learn about latest research, trends and activities in their areas of interest; Share experiences and advice with her colleagues about unique roles, responsibilities and their pet projects; Decide on meeting dates and venues; Matters affecting children, women and families which should be helped by the Ministry of Health/Developmental Partners (child mortality rate, pregnant women, tackling poverty childhood hunger/al-majiris, breast cancer awareness, cardiovascular diseases and different forms of mental illnesses.

This can eventually lead to the creation of the Office of Women's Health within states' Health Departments which will be targeted at lifting heavy burdens on families who yearn for good and affordable healthcare services and ultimately help win the trust of the citizenry as well as build diverse coalitions and share goals.



These are all with a view to helping foster a public- private partnership amongst the states, which eventually will translate to peer review mechanisms between the Spouses of the governors.

he Nigeria Governors' Forum HelpDesk is a technical support programme launched in collaboration with the Bill and Melinda Gates Foundation in March 2017 to support States by providing just-in-time demand-based technical support (capacity building and advisory services) to States in Public Financial Management (PFM) and domestic revenue mobilization. The HelpDesk process has been modelled to be participatory, evidence-based, credible, consistent and reform triggering.

The overall objective of the programme is to increase internally generated revenue and strengthen PFM at the subnational level.

# Programs, initiatives, Achievements and milestones c ustomized Just-in-time t raining and Advisory support:

Since inception, the programme has delivered capacity building training and advisory services on PFM and IGR related reforms to 18 States directly, training over 570 State officials across various MDAs including Ministries of Finance, Budget and Planning, Office of the Accountant General, Office of the Auditor General, Debt Management Office and States Internal Revenue Services. States supported directly include Cross River, Kaduna, Yobe, Benue, Katsina, Zamfara, Bauchi, Gombe, Plateau, Taraba, Nasarawa, Sokoto, Niger, Ogun, Kwara, Anambra, Ebonyi and Kogi States.

## r egional t raining

The Programme delivered a regional training for the North Central States Internal Revenue Services – Benue State IRS, FCT IRS, Kogi State IRS, Kwara State IRS, Nasarawa State IRS, Niger State IRS and Plateau State IRS - on Human Resources Management (HRM) and conducting effective Tax Audit and Investigation. About 35 State officials including chairmen, directors of audit and audit staff of the various States internal Revenue Services were in attendance.

## l earning Alliances and c ollaboration with Partner

Over the years the programme has collaborated with a large array of partners including DFID and the World Bank, delivering learning alliances such as a focus group discussion on the fiscal sustainability of States (2017), South-West & South-East learning alliance (2018), advocacy session with the forum of Commissioners of Finance on establishing Sub-National Fiscal and Economic Sustainability (2018) and regional workshops on the sensitization of States on the World Bank States Fiscal Transparency Accountability and Sustainability (SF-TAS) programme for result (2018). The NGF Helpdesk also attends the quarterly meeting of the Joint Tax Board to influence tax policy and coordination at the subnational level. Since inception the programme has attended 7 JTB meetings and participated as a country representative for Nigeria alongside other JTB regional representatives at the technical conference of the Common Wealth Association of Tax Administrators (CATA) which held in Fiji Nadi (2018) to contribute to the discourse on improving taxpayer management and addressing base erosion and profit shifting between countries of the common wealth assembly.

Sequel to the success of the HelpDesk programme in delivering technical support to States, the NGF (HelpDesk programme) has been selected to support the Federal Ministry of Finance (Home Finance Department) Programme Coordination Unit (PCU) for the World Bank States Fiscal Transparency Accountability and Sustainability (SFTAS) Programme for Results to provide technical assistance and capacity building training to States over a 4-year period (2019 - 2022) focusing on three (3) key result areas (KRAs): increasing fiscal transparency and accountability, strengthening domestic resource mobilization and strengthening efficiency in public expenditure. Activities to cover will include Developing and disseminating guidelines, knowledge notes and templates; Just-in-time customized on-the-ground support (Individual State technical workshops and advisory support through mobile teams of experts); Peer Learning Events; Exchange Visits and State Reform Experience Studies to build States' capacity. The HelpDesk programme in the coming months will commence implementation of approved



# **Inauguration:** How new & returning governors addressed their states

nsecurity, the minimum wage saga, rising youth unemployment, debilitating national poverty index and a grueling economic downturn, pervaded Nigerians' expectations before, during and after the 2019 general elections. And governors at their inauguration on May 29th responded accordingly, even though some of the reactions from some states left much to be desired.

No matter who is at the helm of affairs at the subnational level of governance,

the needs of Nigerians have practically remained the same - the provision of basic amenities, infrastructural development, a favorable and enabling business environment, adequate security, a stable economy, qualitative and affordable education, a vibrant and remedial health sector, amongst others are the things that the people desire.

So, when new governors were sworn in on May 29, many Nigerians were hoping to see them take off and address these issues, especially the basic ones. Though it is too early to begin to assess the governors, a good lot of them could be said to have hit the ground running in their quest to deliver the dividents of democracy to their people. At the Forum level, we followed their pronouncements and actions of the first 48 hours and here present our findings.

Whilst in Lagos State, for example, the new governor, Babajide Sanwo-Olu saw the need to tackle the perennial Apapa gridlock, in Imo State, his counterpart Hon. Emeka Ihedioha was preempted by his supporters to dismantle the legacies of former Governor Rochas Okorocha by demolishing edifices and statues around the state capital. Ihedioha became the first to take-off with public denials of actions perceived by people around the country to be regime intolerance. Soon enough, Governor Ihedioha unveiled free healthcare and education for his people. Governor

nor el-Rufai of Kaduna State also commenced his second term in office with an announcement on free medicare and an extended, precisely six-month long maternity leave for nursing mothers. He also capped it up with free and compulsory education for the girl-child to encourage them to attend school.

For Governor Umaru Fintiri of Adamawa State, his first line of action was to terminate all political appointments made on or before March 28, 2019 by his predecessor, Governor Muhammadu Jibrilla. He is joined in this move by Governor Inuwa Yahaya of Gombe State.

One thing is certain however, and that is, there is a revolution going on at the subnational level of governance, as the new and returning governors are jostling to dish out the dividends of democracy to their people.

## Seyi Makinde (Oyo State)

# Orders ex-political office holders to return official vehicles

Fresh from his inauguration as the Governor of Oyo State, Seyi Makinde, who in his speech promised the people that he would return the wealth of the state to them, ordered all former political office holders to return government vehicles and other assets in their custody with immediate effect.

Speaking in a statement signed by Chief Bisi Ilaka, his Chief of Staff, he observed that some former political office holders are still in possession of official vehicles attached to their offices in spite of the fact that they are no longer in the service of Oyo state.

He consequently directed that all former political functionaries who are still in possession of government vehicles to return the same to government transport

pool within 48 hours.

Failure to do this, according to him, security agencies shall be directed to retrieve such vehicles from where they may be kept.

The State Government also said it would take all necessary steps to ensure that all assets illegally taken away by the former officials are returned to the state.



Dr. Bello Muhammad Mutawalle approved the suspension of the Emir of Maru, Alhaji Abubakar Chika Ibrahim, and the District Head of Kanoma, Alhaji Ahmad Lawal, with immediate effect.

The duo were suspended after series of complaints on their alleged involvement in banditry and other criminal acts.

Matawalle said the emir and district head would remain suspended until the outcome of the first investigation panel.

He was directed to hand over official vehicles and all other government property in his possession to the most senior district head, while the suspended district head should hand over to the most senior village head.

The Zamfara State Governor Bello Matawalle also said work will begin on the proposed Gusau Airport within his first 100 days in office. The governor made the pledge when he paid an inspection visit to the proposed site of the airport.

A statement, signed by the Special Assistant to the governor on Media, Mallam Yusuf Idris, quoted Matawalle as saying that the construction of the airport was crucial to development and the opening of job opportunities. It said that government was committed to investing heavily in the economic sector and also initiating policies that would boost internal revenue.

"The governor promised to make the state more socially and economically viable; he also appealed to wealthy individuals to invest in Zamfara, promising lots of incentives". The statement said that Matawalle also visited the Gusau Hotel where he found out that most of its structures had become dilapidated. "The governor was embarrassed by the poor state of the facility, especially with many sections at the verge of collapse. He directed that it be reconstructed to meet international standards."

The airport project was conceived more than 10 years ago by former governor Mamuda Shinkafi. Budget estimates for the project consistently surfaced in various budget proposals during the eight-year administration of Matawalle's pre-

decessor, Governor Yari, but no work started at the site up till when he left office Governor Nasir El-Rufai of Kaduna State announced that female civil servants in on May 29, 2019.

## Free healthcare for women, children

Governor Bello Matawalle also announced that his administration will offer free healthcare services to women and children in the state.


He made the declaration shortly after taking his oath of office at the Trade

Fair ground, Gusau, said that the new government would be comprehensive.

"I am going to assemble enlightened, formidable and politically experienced persons, so that we take the state to better heights in the near future.

"Our women and children have gone through serious hardship in the past and we will reverse this situation for the better.

"The new administration will start with tackling the

"We are aware that poor education, poverty, and unemployment are the causes of criminal activities and I want to plead with members of the public that within the next few weeks we will come up with practical ways of handling these starting with free education and scholarships," he said.

He added that under his leadership, the state government would work closely with the federal government and other relevant bodies to improve the livelihood of the people of the state.

He appealed to PDP supporters in the state to be respectful to leaders and to the Rule of Law as "I am now a leader of all".

# Donates half of his salary to orphans

Governor Bello Matawallen-Maradun also showed that he is a leader that has come to ameliorate the sufferings of orphans in the state by dedicated half of his monthly salary to their.

Matawallen Maradun announced this when he visited the state's orphanage home in Gusau, the state capital. He said orphans are among the important personalities in the society, therefore they need to be given effective care and con-

the state would get six months as maternity leave.

The governor explained that the initiative was to ensure that children were adequately cared for, well-fed and received all the nutrients they would need within the first six months of their lives.

He also announced free medical care for children below five years in public hospitals in the state.

"In education and health, we have shown a commitment with investments to expand the access of ordinary people to these public goods,"

He added, "Our commitment to universal health coverage will continue. Therefore, we shall accelerate the implementation of contributory health insurance scheme as a priority of this administration.

"Our state executive council approved six months of maternity leave for female public servants. This is to encourage the healthy development of

"Mothers in our state are also reminded that children up to age five get free medical care in our hospitals. They are entitled to free regular medical checkups in all public hospitals. Please, take advantage of this."

# Free and compulsory education for girls

The governor also announced that his government has made free and compulsory education available for girls in the state.

"We took bold steps to improve the teaching standards. We have made basic education truly free in Kaduna state and we have made education free and compulsory for our girls up to the end of senior secondary school," he said.

He added, "We'll continue to fix existing schools and build new classrooms where necessary and support our teachers to deliver decent public education."


If there was any state where many commentators had expected instant roll back of certain actions or policies of the previous government, Kwara State probably ranked first on the list.

And not only are there many things some people might rightly expect immediate 'punitive actions' on, the new Governor, Abdulrahman Abdulrazaq, has a huge political capital to pursue such actions without much consequences beyond the cries of witchhunt by the affected parties.

If anything, he would be hailed for

In his inaugural address, the governor went conciliatory by saying that his is a people's government and will operate as such. When everybody expected him to sound like a belligerent war general on the actions of the previous government, he made it clear that whatever inquiry made into the past would be to the extent that such effort will help the public cause he intends to serve. In saying this, Abdulrazaq was clear about the fact that he is not interested in running after

work plan.

### **IGR Peer Learning**

Since the inception of the programme, the HelpDesk has supported the conduct of a peer learning event once every year. The IGR peer learning event in 2017 focused on raising the IGR of States, examining the lessons and opportunities from the experiences of performing States. At the 2018 IGR peer learning event, States were provided contextual background on Nigeria's volatility cycle, suc-

cesses in IGR, lessons for States, a practical approach to estimating IGR potential, effort and Space, budgeting and reporting IGR as well as a financing model that will increase informal sector tax compliance and raise additional funding for Universal Health Coverage (a form of Tax for Service). Commissioners of Finance, Chairmen States Internal Revenue Services were in attendance. Opening the 2018 session were the Governors of Kaduna State, Edo State and Kwara State who graciously chaired the session providing insights as to the required political support for effective tax administration.

# Development of Knowledge Resources, Tools and Templates

To influence reform discourse at the subnational level and facilitate self-learning and domestication by States, the programme develops easy to use knowledge guides, tools, templates, policy briefs and State reform studies documenting reform domestication processes, States' experiences, lessons and opportunities for improvements. Since 2017, the programme has developed and disseminated 4 research papers across different areas including

Revenue Generation (Practical and Effective Reforms to Improving Tax Administration in Nigeria: Appraising recent reforms across 7 States - Kaduna, Kwara, Kano, Akwa-Ibom, Ogun, Zamfara and Bauchi State and Raising the Internally Generated Revenue of States: Lessons and Opportunities), Revenue Potential (A study examining the IGR Potential of States: A Case Study of Kwara State), Estimating IGR (Budgeting and Reporting of IGR), States Integrated Financial Management Information System (Status of Integrated Financial Management Information System (IFMIS) implementation in States including case study reports for Plateau and Kaduna State), Sub-National Fiscal and Economic Sustainability and the State Internal Revenue Service (SIRS) Website Review (Reviewing website structure, content, functionality and security).

Similarly, 3 Knowledge guides on various tax reforms necessary for effective tax administration have been developed and disseminated to States including Achieving Effective Tax Administration (Preparing for Autonomy, Managing High Net Worth Individuals, Tax administration for Informal Sector, Taxing Solid Minerals), Human Resource Management (Workforce Planning, Recruitment Management, Assigning Roles and Responsibilities, Training and Development, Performance Management, Reward Manage-

ment, Career Management, Workflow Management), Practical Approaches to Conducting Tax Audits and Investigations (Tax Payer Rights and Obligation, Audit Process, Conducting Interview Meetings, Best of Judgment Assessment).

Other guides currently being developed by the programme include Communication Planning for States Internal Revenue Services (Developing a communications plan, Stakeholder Engagement, Communication Methods, Monitoring & Evaluation of Communication Methods), Taxpayer Compli-



ance Management (legal framework for taxpayer compliance and compliance risk management), Taxpayer Enumeration (Taxpayer enumeration, tax payer database management and complaints management), Developing a Taxpayer Charter (Articulating content of the charter, taxpayer rights, taxpayer Obligations, developing service standards, enlisting stakeholder support taxpayer feedback and grievances redress mechanism), Tax Legislation & Administration (Roles of Various Jurisdictions, Opportunities for Joint Administration), Taxpayer Management (Concept of taxpayer management, objectives of taxpayer Management and assessing taxpayer Management Operations). The HelpDesk also develop process maps and standard templates for forms, letters, notices, orders and Memorandum of Understandings (MOUs) to easily implement the recommendations in these guides.

More recently, in collaboration with the JTB the HelpDesk developed and launched a 12-point States' Action Plan on Revenue Generation focused on achieving 6 objectives at the just concluded NGF Induction programme for New and Returning Governors. These include Ending double/multiple taxation; Making the most of the SIRS, Improving Taxpayer Compliance, Blocking Revenue Leakages, Unlocking New Revenue Sources and Improving Revenue Budgeting and Reporting.



# As govs respect the NGF Constitution: Nigeria's future firmly in Fayemi's palms



o be the Chairman of the Nigeria Governors' Forum is a special baggage, all by itself. The Governors will rely on the chairman's outreach mechanism, the transgressing public servants will attempt to dribble him, his home state will miss your presence and the society in general will blame you for every states inability to provide one essential service or another. The powers that people repose in the Chairman of the Nigeria Governors' Forum allow him to traverse every political terrain or podium in the country without feeling like fish out of water. It was therefore not unexpected that the election of the Chairman of the NGF which took place barely a month ago generated such gargantuan national interest. The deliberate misconceptions surrounding the NGF have given birth to several assumptions on the concluded election of the Forum, which Governor Kayode Fayemi clinched on a unanimous decision.

The NGF is a legally registered entity with the Corporate Affairs Commission CAC. It therefore has a constitution, and abides dogmatically, by it. Its secretariat on the other hand is a non-governmental, non-profit and non-political development agency and so it has evolved over the years.

According to that Constitution, the Chairmanship of the Forum must rotate between the north south and only a second term governor is eligible to

lead the Forum. The two-term governor must also belong to the ruling party. The Governor of Ekiti State only just returned to an office he held until 2011. Technically, he is a second term governor and therefore a ranking member of the NGF. As things stand currently, Dr Kayode John Fayemi remains the only governor eligible to replace Governor Abdulaziz Yari Abubakar who vacated the chair on May 29th. And to most governors, so be it.

It would have been a different kettle of fish if Former Governor of Lagos State Akinwunmi Ambode had returned as Governor for another term. But he didn't. Indeed, there were speculations about some governors showing interest in the chairmanship of the Forum but that ambition soon took a back seat the moment it was explained to them that the constitution precludes them for certain obvious reasons. Moreover, knowing the political sagacity and dexterity of most governors, they would have attempted to test the envelop but each preached a respect for democratic ethos and sheathed their sword.

One Key disinformation however stood out; that Governor of Kaduna State Malam Nasiru el-Rufai, was favored by the presidency to run for the Forum's chairmanship, a fact that the governor himself debunked outrightly. In Fact, as a proof that this view is unfounded, the Kaduna Governor disclosed way before the election took place that he had encouraged Governor Kayode Fayemi

True to type, on May 16th once the Director-General of the NGFS Mr Asishana B Okauru read out the rules, proceedings for the election took a convivial direction. If there were any dust, it had been blown away. Governor of Kaduna nominated the Chairman and was seconded by Governor of Delta. There were no other contenders. The choice of the Vice Chairman was also just as tranquil. The Chairman elect as he then was got the approval of the entire house to pick Governor Sokoto, Aminu Waziri Tambuwal as his deputy. The house

The new NGF Chairman Governor Fayemi is known as a liberal leader, cerebral intellectual and progressive politician who has built bridges across all primordial and other sundry divides. He also has the privilege of being close to President Buhari. The peaceful manner of his election is a clear indication that the NGF has risen beyond party differences to see their association as a purely democratic pathfinder for the country. It is Nigeria's most informed gathering, as well as the most privileged.

Far from the uninformed presumption that it is a pressure group, the NGF and its secretariat has quietly warmed itself into the heart of governance in the country and a solid support for oiling the wheel of progress, even for the presidency, that many think it was built to oppose. As proof, the NGF has inched closer to the presidency, which explains its ability to dialogue and most of the time concur with each other at each one's hour of need. Even the States Peer Review Mechanism for which the Forum has been receiving a flak for its discontinuation, has remained relevant among governors who no longer need a drill sergeant visitation to adopt. Instead, Governors speak to each other at every meeting and replicate in the various states whatever seems to be happening right in one state. A typical example is the NGF HelpDesk, whose activities, like training states on new and modern ways of raising internally generated revenue, has caught all the states like wildfire. Today, NGF is arguably the strongest political unit in the country. The governors are united across party lines and they have used the NGF platform to bring good governance nationwide, the result of which is gradually seeping through different communities across the country.

This amount of progress has also endeared the Forum not just to the President who listened carefully to governors and encouraged them to remain united each time they met him but also the Vice President Yemi Osinbajo who is usually amazed at the NEC with the level of cohesion the NGF has achieved since its troubled days of 2013. For this fete, the NGF persuaded President Muhammadu Buhari to approve the release of almost N2trillion to states, including N713.7 0b special intervention funds to states and infrastructure expenditure refund.

The immediate past chairman and Governor of Zamfara State governor might have had problems in Gusau, the capital of his state but he has offered exemplary leadership, and displayed appropriate conduct to the Forum. However, it is expected that Team Fayemi and Tambuwal would continue in the same vein. Many analysts look up to Fayemi who is a Development expert to rise above board and consolidate on what is already achieved to take the Forum to where there is healthy competition, development and self-sufficiency in states.

It is only realistic to expect that as a development expert, Governor Fayemi's tenure would witness remarkable progress in the half-a-dozen core mandate areas of the NGFS which include, but are not limited to education, health, agriculture, the economy, security and infrastructure development among others. In the past, the NGFS has provided invaluable service to the states, which are tailor-made, purpose driven and promptly delivered. It is expected that with Governor Fayemi in the chairmanship saddle, more states would find a good reason to solidify and promptly take ownership of the presence of the NGFS for quickfixes whenever they feel letdown by the robust civil service architecture that they inherit in their states.

It can therefore be said effectively and without fear of contradiction that the future of Nigeria, considering the strategic position that the NGF occupies, is in the hands of Governor Kayode John Fayemi of Ekiti State and Chairman of the Nigeria Governors Forum until 2021. The Chairmanship of the NGF is a two-year tenure except the members decide to unanimously allow the occupant of the seat to continue unchallenged, as it happened in the case of Governor Abdulaziz Yari Abubakar.



# How NGF facilitated Fiscal Restructuring for States

he last four years were eventful for the subnational level of the polity. This is especially so regarding the economy, where governors achieved a resounding victory and received the confidence of President Muhammadu Buhari. It is important to document the role of the Nigeria Governors' Forum, especially as this relates to the change of baton from Governor Abdulaziz Yari Abubakar of Zamfara State to Dr Kayode Fayemi of Ekiti State.

Just as he stated during his opening remark at the Induction of new and returning governors in the Banquet Hall of the Aso Rock Villa in Abuja, the last set of governors took the saddle of their governorship amidst troubled waters, or more precisely, virtually in the wake of the fiscal crisis caused by falling oil prices since mid-2014. The indefatigable leadership of the time, With Governor Yari Abubakar at the helm led the Nigeria Governors' Forum to hold a series of meetings with the federal government (including Mr. President) to find sustainable ways of addressing the crisis which had affected the day-to-day operations of State governments.

Fortunately, at its meeting of Wednesday 20th April 2016, Chairman of the Forum Abdulaziz Yari Abubakar led its members to unanimously agree to a Fiscal Restructuring Plan (FRP) to help ameliorate the effect of the fiscal crisis and stabilize government budget operations. An Aide Memoire (attached) was consequently prepared and sent to Mr. President. The FRP became necessary because previous interventions were only palliative and could not completely resolve the growing financial liabilities of States due to the large and cumbersome nature of inherited financial obligations.

The Fiscal Restructuring Plan detailed short, medium- and long-term measures which eventually kickstarted the national strategy to address fiscal sustainability issues in the country, including the release of bailout packages, the development of the fiscal sustainability plan and the budget support facility. Among measures recommended

were the reimbursement of Paris Club deductions to State and local governments that were not indebted to the Paris Club; moratorium and low interest rate on concessionary loans; full refund on federal government roads constructed/rehabilitated by State governments; restructuring of the Revenue Mobilization Allocation and Fiscal Commission; proposed direct intervention/restructuring grant for each State that falls below a sustainable threshold required to keep the government functional; as well as an immediate forensic audit of NNPC, including outstanding payments to the federation account among others.

The Forum had earlier moved for a resolution for a moratorium of two (2) years on all restructured debts of States, given the exposure of States to high Irrevocable Standing Payment Orders (ISPOs) at its meeting of Wednesday, 18th November 2015. A Committee was consequently instituted at the National Executive Council (NEC) meeting of January 23, 2016 to engage with the Governor of the Central Bank of Nigeria (CBN).

On the 2nd of September 2016 the Forum also intervened by requesting a one-year moratorium to States on liabilities for the excess crude loan facility, the FG salary bailout and restructured bank loans. All of these got the Forum busy and positioned it for the

confidence that the President eventually reposed on its members.

Zamfara state economy and its people might have bled for missing their governor, but the then Chairman of the NGF Governor Abdulaziz Yari Abubakar and his brother governors as they call each other, ran around, cajoling or bullying public officials whichever necessary to take back what belonged to states, that was denied them in the past. And a lot was achieved. Nearly N3tr was disbursed to the 36 states depending on their share or the enormity of their responsibility or liability at each stage. Apart from

President Muhammadu Buhari who magnanimously approved all the releases, the only other entity that deserves any mention in facilitating this huge endeavor is the Forum Secretariat. This contribution has impacted immensely on the economy of states and their peoples.

anyone if such is not connected to the bigger Kwara dream.

From his inaugural speech to his first official functions, he embarked on fence-mending and confidence-building among critical stakeholders in Kwara State. He started with his party men just hours after he was inaugurated. And shortly after holding his maiden security briefing, met with the State's Council of Chiefs during which he took their advice and sought support for the new government

### Ahamadu Umaru Fintiri - Adamawa State Terminates Bindow's last-minute appointments

Governor Ahmadu Umaru Fintiri, in his first line of action after assuming office,

dissolved all appointments made on or after March 28, 2019 by his predecessor.

In his maiden broadcast in Yola, Governor Fintiri announced the dissolution of all political appointments made by his predecessor, including 50 state development area councils, and boards of tertiary institutions.

He also suspended for review, all appointments made into the state's Judicial Service Commission, Planning Commission, Civil Service Commission, boards of Adamawa Health Insurance Scheme and the Jimeta Ultra-Modern Market.

His words were: "All appointments made into the state's Judicial Service Commission, Civil Service Commission, Planning Commission, and boards of the Adamawa State Health Insurance Scheme, chairmen and members of the Jimeta Ultra-Modern Market Board are hereby suspended.

Fintiri

"Equally, all appointments made on or after 28 March 2019 are hereby suspended on grounds of public interest. Also, all last-minute recruitments done on or after 28 March 2019 through mere waiver without observing the laid-down procedure, such as Federal Character, are hereby suspended."

The governor further announced the dissolution of all the chairmen and members of boards, and commissions, and asked the outgoing chairmen and members to hand over their organisations and public property to the most senior civil servants in their establishments.

Governor Fintiri said a committee would be set up to review all "hasty recruitments", stressing that there was a need to conduct "proper" exercises that will be open to all eligible citizens, including those affected by the suspensions and dissolutions.

# Declares free health care in Imo

New Imo State Governor, Emeka Ihedioha announced the beginning of free healthcare for children and elderly people in the state.

"On food security, I will ensure the return of our displaced people to their farmlands to ensure national food security.






Ugwuanyi, who commended youths in the state for supporting his administration, directed all the elected chairmen and councillors to relocate to their various

Besides, he declared that his administration would establish 19 more technical colleges to make it one for each local government area and a fully func-


tional vocational centre in each of the 25 local government areas of the state.

future and prosperity."

He stressed that: "This event also opens a new chapter in our march towards peace, unity and progress as it also signals another series of activities, developments and events which require all hands to be on deck in realising our collective aspirations in the task of leaving lasting legacies for the benefit of the present and future generations.

"We will continue on the economic trajectory of fiscal discipline, prudence, prioritisation of capital projects over recurrent and giving value for money spent in the delivery of services."

Wike also promised to partner relevant national and international agencies and expertise to initiate and implement a 25-year Marshall Plan for economic transformation and development of the state.

the State Governments taking the lead in implementation while the Federal Government facilitates and supports.

- 13. We look forward to an NGF that would contribute to ensuring no state is left behind on the development curve. An NGF that would encourage economic cooperation between states, especially within the regions, and engage development partners and other enablers as a bloc towards attracting more resources and technical assistance to achieve our developmental objectives.
- 14. We would strengthen the capacity of our secretariat to continue to support our states with technical assistance in the areas of Economic Advisory, Policy Advisory, Knowledge Management, and Public Financial Management, as well as build on our existing peer review mechanisms, while stimulating robust partnerships and productive rivalry between states.
- 15. Our secretariat would also continue to drive the activities of existing committees, such as the Constitutional Review Committee; Revenue Allocation Committee; and Security committees to make them more functional and productive, even as we explore creating more committees in keeping with the exigencies of the times.
- 16. We would also strengthen our capacity to be proactive and effective in Conflict Resolution and Mediation in matters of conflict between member states, and between our states and other interested parties. We shall also not fold our arms, but would put in all efforts within the limits of our mandate to promote peace and harmony in the country.
- 17. We are encouraged by the reach and influence that the NGF has earned over the years as a critical stakeholder in nation building, but are also constrained by our limitations, which inhibit our potential to do more for the country. We would therefore be examining ways in which the NGF can be formally recognised and achieve status as a bonafide actor in the body polity.
- 18. While we have our goals and objectives before set before us, and our mandate remains crystal clear, we shall remain flexible and adaptable to the times and seasons, and the peculiar challenges that would be thrown up within the course of our tenure. Our hope and faith remains in God to guide us and strengthen us to do right by our people, and use the mandate He has given us through the people, to restore our great country Nigeria to her pride of place, as the bulwark of peace and progress in Africa and beyond.
